The specialized services provided by Dr. Jorrisch are critical to the MORE Center to address the current opioid addiction crisis in Louisville.


Dr. Mark Jorrisch has been the Medical Director for LMPHW's MORE Center Methadone Clinic for 20 years. The LMPHW MORE Center Methadone Clinic provides evidence-based treatment for opioid addiction to drugs like heroin. MORE Center services include psychosocial counseling & medication assisted treatment. The MORE Center, with Dr. Jorrisch's leadership as Medical Director, is absolutely necessary for LMG and the community to address our current opioid crisis.

Dr. Jorrisch has a doctorate degree in medicine, is licensed in KY, and has practiced as an addictionologist with an addiction population for over 20 years at the MORE Center. Dr. Jorrisch has been instrumental in pioneering the MORE Center's medication assisted treatment program based upon an evidenced-based treatment approach for opioid addiction. Dr. Jorrisch has become the president elect of Kentucky's American Society of Addiction Medicine (ASAM), is ASAM certified, and is an addiction expert, providing guidance and training to other physicians, psychiatrists, medical interns and residents regarding opioid addiction and medication assisted treatment.

No other physician in the city of Louisville is more qualified than Dr. Jorrisch because of his decades of experience providing leadership and expertise at the More Center, making him unique to continue serving in this role.
