This Amendment made and entered into by and between the Kentucky Transportation Cabinet (KYTC) and the Louisville/Jefferson Metro Government (RECIPIENT) acting as an amendment to that Agreement entered into between the parties dated December 6, 2011.

WHEREAS, on December 6, 2011, the parties hereto entered into an agreement for the North Louisville Loop Multi-Use Path; and

WHEREAS, the parties desire to amend said agreement;

NOW THEREFORE, in consideration of the following promises and covenants contained herein the parties hereby agree as follows:

1. The Terms and Conditions of Agreement numbered PO2-628-1100002903 made and entered into by and between the Kentucky Transportation Cabinet (KYTC) and the Recipient, are modified to reflect a funding increase of \$300,000.00 from \$750,000.00 to \$1,050,000.00 and to extend the project end date to June 30, 2019;
2. All other terms and conditions of PO2-628-1100002903 shall remain in effect.
