It's, he's actually here, I'm not going to go into a lot about him because he is on participating on the call. So I will let him introduce himself and tell a little bit about why he would like to be on this board.

Mr. Hobbs if you wanna introduce yourself with the record, you have the 4, sir.

"David Hobbs"

Yes, sir, thank you. Sorry I apologize for that. Not used to these zoom calls and yet as if they had mentioned, my name is David. Hobbs, I am the president of diversity bank. I've served in that current capacity since 2006. I've been with our organization for over 36 years.

Uh, our corporate office is in the downtown. is in the downtown Development district, um, you know, we are strongly supportive our community constantly giving back. I see this as a further effort to give back to the community in regards to the spot.

Uh, you know, we currently have several projects that are being financed in the district itself, and a couple of the outside parameters. So we are very conscientious about the environment and the downtown area as far as the safety, the cleanliness and so forth. Uh, we recently committed to over 2Million dollars. dollars Improvement to our facility so we are committed to the downtown area and I just see, as I mentioned, I just see this is further way to give back.

Good evening my name is Bill Fisher. I'm the managing member of, um.  
I go to real estate. I have an extensive background in development in  
southern Indiana and Jefferson County, olden county.  
I have some bullet county too. Um, I am honored to have been asked to  
join this committee and, um.  
I think I could bring a wealth of experience and knowledge to the board  
and help represent the community.  
With some of the issues, they have

fantastic any questions or concerns regarding this appointment.  
Yeah, Piagentini.

"Vice Chair Piagentini"

more advocacy than anything else, you're, you're eminently qualified  
Thank you for agreeing to serve and appreciate glad to vote for you. What  
I would advocate for is, um, you know, there's been, uh, concerns.  
Amongst the public that, um, and and I saw in a few cases recently where.  
It felt like the commission was.  
Going through the motions a little bit, right. Um, so I would advocate  
for when you're on the, when you're on the commission. I, this is going  
to be this is 1 of the toughest boards.  
To serve on and I, thank you for being your willingness to do. So, uh,  
but it it is incredibly important to.  
Of the citizens of this community that we look at things from all angles.  
Right? And that we keep open minded to the public's.  
Fact, based must be fact based not just thoughts or motions right but  
fact, based feedback related to some of these developments and how to  
improve them and what impacts they could have. And whether or not those  
developments are, in fact, following the law.

So, I would just ask you to keep a very open minded, both sides of it. And, uh, but I appreciate your willingness to serve on this commission. It's incredibly important to my district, given the amount of growth, but to many districts across the community. So, thank you for serving.

Very well noted and, uh, I must say that I have the utmost respect for the people that come and. Speak their emotional, you know, contact to, uh, the land or to the community. I have I, I do respect that.

"Vice Chair Piagentini"

Well, said, sir, and I will say, you know, they. Generally speaking, even if the vote doesn't go their way, which many times it does it. Right? Um. As long as their voice has been heard has been properly digested and it was part of the process. And was it just, um, you know, sloughed off as as noise? I think then they at least respect the process and that their voice was heard. So, I know you'll do that and I appreciate you saying how much you respect their, their attendance and their voice in the process.

They'd like to add 1 more point. I've often said that I wouldn't want to develop in a neighborhood that doesn't have people that want to show up. And speak for man,

For her appointment to this to this board she again, she is with rebound ink. She has worked with urban seniors job program. She's done a number of jobs within metro area, but we are asking for her appointment.

You don't have any questions or concerns for brenda's appointment, or need to hold it up.

Is that anyone? Nope. Okay. This is important. That requires a voice. What all is in favor say aye aye aye in opposition.

"Chair Ackerson"

13, so they do stagger.  
About a 3rd of the board. Perfect.

"Althea Jackson"

That's the way it was originally set up. It was staggered and then they have there are 3 turns, but then they can only serve 2 consecutive terms. Most boards at 3 there's this too.

"Chair Ackerson"

Gotcha I appreciate that. I appreciate the fact that staggered also. So we don't get bogged down in 1 direction without considerations or the other. All right. Danny has a question or concern?

"Vice Chair Piagentini"

Yeah, just in general concern.  
About and again, I'm looking at the document that I have here MS Jackson. So if I'm what I'm about to say is wrong. I apologize but I'm just using what's what's filed.  
Under district, I see 1 person. Um, and that's 3 point. We just did JD Carey. There's a district 17 when I look at the rest of the districts 4 or 5, 9, 4, 8.  
6,3 lot of single digits.  
In a 26 district County, and we've got app there's actually an incredible amount of applicants for this board. At least in the document I'm looking at districts. 2518.  
1016 and 1715 2002.

"Althea Jackson"

So, to answer that, even though they may have applied, and they may meet the demographics and turnout terms of East or West, but do they represent they have to be their prescribed seats. So they have to represent. So, I'll say, represent the homeless individuals, they have to be represent the apartment Association. So are all of the. These are all of the seats on the affordable housing trust fund prescribed. Are there any better there?

"Vice Chair Piagentini"

They're 1. there's 1 member at large.  
Seems a little ridiculous. Okay.

"Althea Jackson"

And then there's a metro cancel. Rep. right.

"Vice Chair Piagentini"

Yeah. And I think that's councilman. Arthur correct?

"Althea Jackson"

Shanklin

"Vice Chair Piagentini"

oh, Shanklin. Okay. Excuse me I was thinking something else. I was thinking of another, I think the downtown development board I was just looking at

"Althea Jackson"

there's like a representing from the banking community from a neighborhood association.

"Vice Chair Piagentini"

You know, yeah, I, I'm just wondering, you know. Nothing that we're going to figure out today, but it. Considering, how much demand there is to participate in this 1. If they're all prescribed minus, maybe 1, you know, having more at large positions, just, you know, again, positions that give you and the administration and us more latitude to say, okay, we have these prescribed positions filled, but we want to make sure the community is represented. Right again, maybe racially political affiliation, geographic we see more affordable housing going more throughout the community, so we want to make sure the whole community is involved.

"Althea Jackson"

If that happens, that will take an ordinance change. Right?

"Vice Chair Piagentini"

Right. So yeah, and that's what I'm saying, we're not going to solve it today and that's on us to do something about. So, uh, but thank you for clarifying.

"Althea Jackson"

Yeah.

"Chair Ackerson"

You know, the questions or concerns regarding this appointment hearing none this is an appointment that requires a voice vote all in favor say, aye.

Any in opposition.

No physician's passage. Naturally she'll be sent to consent calendar. The next time I'm going to be, I remember 92622k the redeployment of Kimberly Sickles to the 40,000 trust on board. Determine the expires December 31st 2025 is their motion.

There, uh, has been some confusion about which agency the contract will be run through. So, at this point, um, we're, we're not sure how to finish. The contract is drafted, but it may need to be changed before we can share it with everybody.

I got your Paul and then because of that, I mean, essentially, we don't have a contract and my position is chair is I'm not going to approve a contract. That's.

That we don't have, does anyone have a problem with that?

No okay. Good. So, item number 11 will remain held also, which is going to leave us for our final item for the evening item. Number 10.

And item number 10 is R dash 170.

resolution asking for the internal auditor to look into record retention and compliance with record retention laws of the little metro police department

for over a 5 year period from 2018 to January. eighteen to january 2020.

To the data passage. Sorry, thank you. And I ask for your approval.

"Chair Ackerson"

All right, anyone have any questions or concerns regarding this resolution.

I know that we have some folks here from the 490 project. We liked a couple minutes to give us your thoughts on this.

"Nancy Cavalcante"

The 490 project's been active as far as a watchdog and transparency other issues.

But just a couple of minutes, if that's okay.

"Chair Ackerson"

I believe that you're going to be.

Talk about the expansion of this potentially.

"Nancy Cavalcante"

I promise I get nervous enough. I won't be long.

"Chair Ackerson"

Great.

"Nancy Cavalcante"

Thank you for letting us speak here. Today. We did put in a request for this audit to.

"Chair Ackerson"

You got to see your name.

"Nancy Cavalcante"

Excuse me, I'm Nancy. I'm a constituent of district 26, and a member of the 490 project.

And do you know who we are?

"Chair Ackerson"

Yes.

"Nancy Cavalcante"

Okay.

I think most people do so in our work to create a safer community and to monitor what's going on with the policing and, uh, collective bargaining agreements.

We discovered that the city government, and the police department were not with an alignment of the law and the, um.

Metro councils ordinance regarding record retention.

And so we ask for an audit of this. I, we are very happy that you have agreed to audit the. But I think it's a very narrow focus. And it needs to be broader than that.

Because we discovered that there are lots of places and things that are not being addressed that are a part of the ordinance and the state law.

So that's why we wanted to speak tonight to just say that.

Maybe this is the beginning, but I think it is time to really look into and I know we have a new administration. So that's a good time to do that.

And if we need to come back and ask for that to go broader, we will, but we would like to see that expanded if possible in this ordinance

"Chair Ackerson"

1 of the primary sponsors. I will tell you that we've viewed this as a beginning. We'll leave it to my colleagues if they want to expand to other at the moment.

But, uh, it's, it's it's a starting point and, uh, not an ending point. So.

Appreciate you being here night okay,

"Nancy Cavalcante"

thank you. Very much.

"Chair Ackerson"

Anyone else have any questions or concerns.
