The following was discussed:

- Health or safety concerns to the home owners and their families
- Property concerns on how the "product looks"
- Public can submit feed back online
- Public notice requirements are extended to neighborhood associations
- Public meeting virtually or in person are made mandatory upon request of a person who receives notice of installation or application in their area
- New small cells must conform to the existing street scrape and infrastructure including within historic districts
- If utilities are located within an alley, then small cells generally must be restricted to an alley also
- The frontage of historic buildings are protected
- The Division of Community Forestry assumes oversight of trees and vegetation within the right-of-way
- Question about expanding information beyond the notice for people impacted by underground work
- Ground based equipment and pole placement are in the right-of-way
- Contact information will be available and on notifications
- Ability to regulate installations is limited by Federal law
- Public comment period is over September 15, 2020 and new policy goes into effect and will be sent out by October 1, 2020
- Mechanism for public report damages would be Metro Call
