

ORDINANCE NO. 039, SERIES 2022

AN ORDINANCE APPROPRIATING ~~\$23,250~~ \$26,250 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$3,000 FROM DISTRICT 6; \$2,250 FROM DISTRICT 9; \$1,875 FROM DISTRICT 15; \$1,500 EACH FROM DISTRICTS 2, 4, 7, 8, 10, 12, 14, 17, 19, 23, AND 26; \$750 EACH FROM DISTRICTS 20 AND 22; AND \$375 EACH FROM DISTRICTS 13, 21, AND 25; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO KENTUCKY SHAKESPEARE, INC FOR THE SHAKESPEARE IN THE PARKS *JULIUS CAESAR* 2022 TOUR (AS AMENDED).


BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE "COUNCIL") AS FOLLOWS:

SECTION I: The sum of ~~\$23,250~~ \$26,250 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,000 from District 6; \$2,250 from District 9; \$1,875 from District 15; \$1,500 each from Districts 2, 4, 7, 8, 10, 12, 14, 17, 19, 23, and 26; \$750 each from Districts 20 and 22; and \$375 each from Districts 13, 21, and 25; through the Office of Management and Budget, to Kentucky Shakespeare, Inc. for the Shakespeare in the Parks *Julius Caesar* 2022 tour.


SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.


SECTION IV: This Ordinance shall take effect upon its passage and approval or otherwise becoming law.
