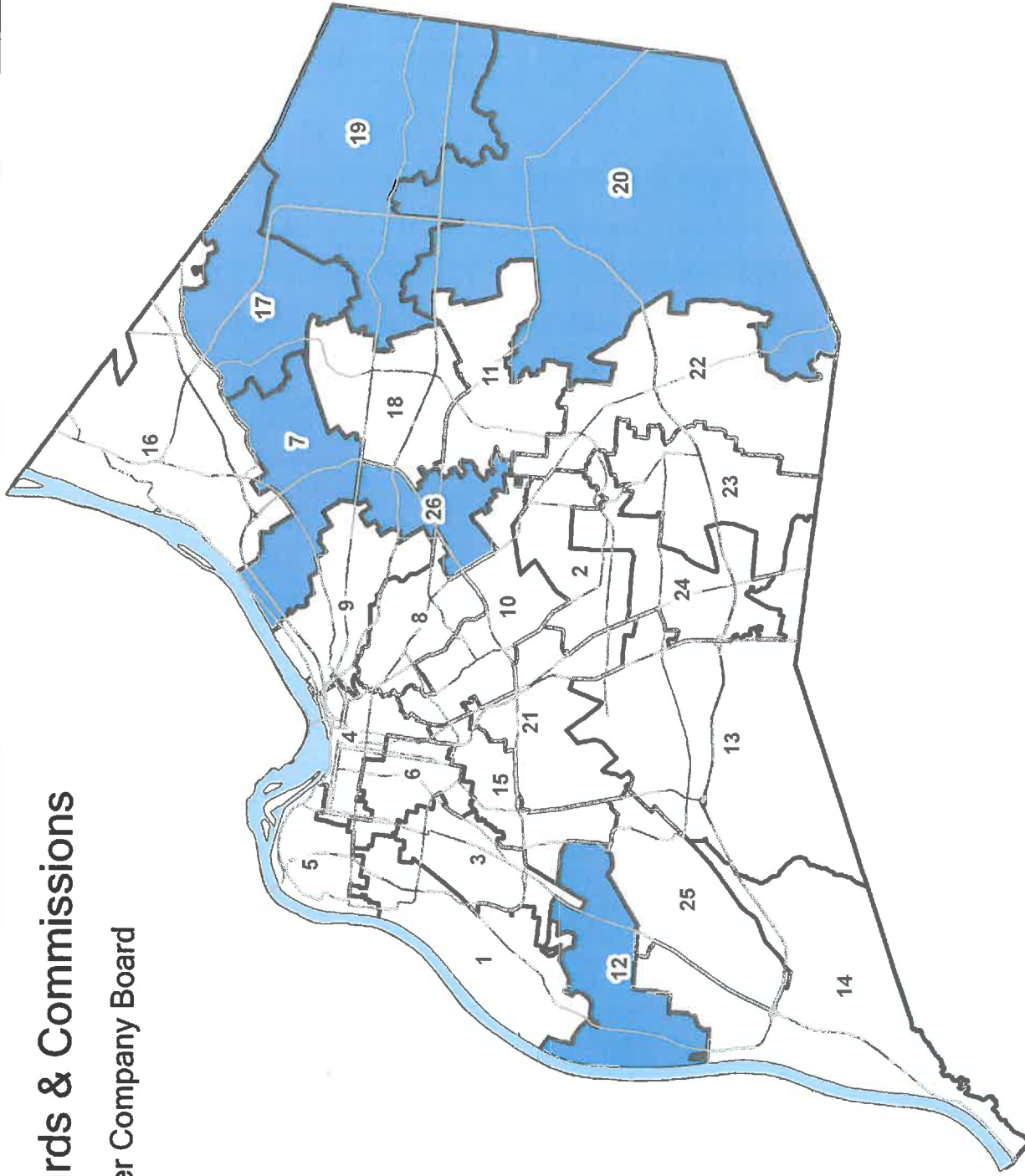

HOW APPOINTED	By Mayor with approval of Council
EX OFFICIO MEMBERS	Mayor
QUALIFICATION OF MEMBERS	County residents; no more than 3 of same political party; owners of real estate in County. All must be at least 30 years of age. No officers or employees of the City can be appointed to board. Must own real estate in Jefferson County.
COUNCIL APPROVAL OF APPOINTMENT	Yes
COMPENSATION	Reasonable compensation for attending board meetings.
TERM OF APPOINTMENT	4 year terms and until a successor has been appointed and qualified. Appointees are eligible to succeed themselves.
VACANCY APPOINTMENT	All vacancies shall be filled for the unexpired terms by appointment in the same manner.
AUTOMATIC REAPPOINTMENT UNDER KRS 65.008(2)?	No
REMOVAL	N/A
POWERS	Vested with all the authority and privileges, exercise all the franchises, and have possession, control and management of all properties of the corporation of which the Metro Government owns all stock; make contracts; sue and be sued; fix and collect reasonable rates for the use of water furnished; may be authorized to fix reasonable conditions upon which board of waterworks may cut into the public ways; may borrow money; may issue bonds; may establish and enforce reasonable rules and regulations.
BONDING AUTHORITY	Yes – KRS 96.300
RECORDS/ REPORTS	Make a quarterly financial statement, showing its liabilities, receipts and expenditures, and deliver a copy to the Council.
PURPOSE	Supplying water to inhabitants by controlling, managing and operating a water plant.

If President is elected from without the Board, his or her election shall constitute him or her as an additional nonvoting member. Must have at least 5 years experience in public utility operations or administration. Chair is elected from within membership of the Board. Vice Chair elected from within membership of the Board. Secretary and Treasurer may be elected by Board, or combined into one person.
OFFICERS TERM OF OFFICE	President, treasurer, secretary and chief engineer serve for one year term or until their successors have been elected and qualified.
