

Landscape Bed by Beechmont Clock

Remove existing plantings, dig and save as many bulbs as possible, re-shape bed, spade edge all the way around new bed, add topsoil where needed, install new plant material and re-locate trash can. Apply weed fabric and staples, fertilize new plantings and mulch. Haul away material removed, leaving the bulbs for someone to pick up.

- 3 Dogwood, 1-3/4" cal.
- 18 St. John's Wort
- 1 White Fringe Tree, Clump
- 7 Sweetspire (Itea)
- 3 Hummingbird Summersweet
- 5 Grasses
- 3 Ruby Slippers Hydrangea
- 5 Grey Owl Juniper
- 4 Boulders
- Topsoil
- Weed Cloth and Staples
- Hardwood Mulch and Slow Release Fertilizer
