Angela, I sent you the wrong version of the CIF request. The CIF request at the top of page 1 should only be for \$42,826.08 (and that is the amount listed on page 3 under D20, but there is a different amount on the signature line on page 1 - \$67,358.98) not \$110,185.06 . The amount on the signature line should be changed as well.

The description should say there is \$80,522.53 coming from the ordinance being heard in Budget Committee, not \$13,814.94. The total being added to the \$180K in the FY21 budget is \$123,348.61, including the \$42,826.08 from CIF. I switched gears on what was in the ordinance versus the CIF request and sent you the wrong one. Please change on the CIF request before sending it on. I am SOOO sorry!! Too many moving parts on this one!
