Dear Mr. Dock,

I am writing this letter of support for the Progress Airstream Park development to be rezoned as C-2. I am still a relatively new resident of Louisville, but have had the opportunity to visit the park on a few occasions, including the fundraiser for the local Parkinson support group which rose over \$20,000 last year to start a new program for those impacted by Parkinson disease in our community.

I would like to share a few personal observations of how the development has been improved and the benefits it will provide our community if the city allows the property to be further expanded.

- The 12 acre property was purchased approximately 2 years ago by Mike Pifer and Nick McDowell, both lifelong residents of Louisville in the Buechel/Hikes Point area.
- When the property was purchased it had two houses that were in poor repair, old car parts in the woods, the pond dam leaked, the entire property was overgrown and hazardous.
- Mike, who has a renovation business in town, and Nick, who owns a landscaping business, combined their skills and personal labor to make a number of amazing improvements.
- One home on the property has been completely renovated, and the other should be completed by summer.
- The pond is now repaired, safe to swim in, includes a sand beach, and has recently been restocked with fish.
- The grounds have been cleared, include walking paths, and a children's play area.
- The area is no longer a safety hazard in the neighborhood. It now has a retreat atmosphere that, with city approval, will be shared with area residents and visitors to our great town.
- The owners have been able to purchase and renovate two airstream campers. These airstreams taught me a new word, Glamping. They are beautiful. Its like staying in a high end hotel in a park setting.
- The potential benefits to the community are endless: new city tax revenue, new state tax revenue, a new location for group retreats, a venue for local fundraisers, family reunions, weddings and so much more.
