

ORDINANCE NO. 136, SERIES 2015

AN ORDINANCE APPROPRIATING ~~\$14,000~~ ~~\$14,750~~ \$17,250 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$2,500 FROM DISTRICT 23; \$2,000 FROM DISTRICT 25; \$1,000 EACH FROM DISTRICTS 5, 2, 21, 4, 14, 6, 22, 20, 16, 24; \$500 FROM DISTRICTS 13, 12, 3, 9, 17; \$250 FROM DISTRICT 10; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE WAR AGAINST VIOLENCE CORPORATION FOR COSTS ASSOCIATED WITH THE "YOUTH ALERT!" VIOLENCE PREVENTION/HEALTH COMMUNITY OUTREACH PROGRAM (As Amended).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$14,000~~ ~~\$14,750~~ \$17,250 is hereby appropriated from the Neighborhood Development Funds in the following manner: \$2,500 from District 23; \$2,000 from District 25; \$1,000 each from Districts 5, 2, 21, 4, 14, 6, 22, 20, 16, 24; \$500 from Districts 13, 12, 3, 9, 17; \$250 from District 10; through the Office of Management and Budget, to the War Against Violence Corporation for costs associated with the "YouthAlert!" Violence Prevention/Health Community Outreach Program.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
