AN ORDINANCE APPROPRIATING \$9,500 \$14,000 \$18,500 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$2,000 FROM DISTRICT 4; \$1,500 EACH FROM DISTRICTS 3, 7, AND 25; \$1,000 EACH FROM DISTRICTS 1, 2, 6, 7, 9, 10, 15, 20, and 24 25; 1000 EACH FROM DISTRICTS 5, 13, 14, 19, 21, 1000 AND 23, 1000 AND 26; 1000 AND 26; 1000 AND BUDGET, TO THE WATERFRONT DEVELOPMENT CORPORATION FOR THE SECOND ANNUAL JUNETEENTH JUBILEE IN WATERFRONT PARK (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The amount of \$9,500 \$14,000 \$18,500 is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,000 from District 4; \$1,500 each from Districts 3, 7, and 25; \$1,000 each from Districts 1, 2, 6, 7, 9, 10, 15, 20, and 24 25; and \$500 each from Districts 5, 13, 14, 19, 21, and 23, and 26; and \$250 each from Districts 17 and 22; through the Office of Management and Budget, to the Waterfront Development Corporation for The Second Annual Juneteenth Jubilee in Waterfront Park.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
