WE'RE GIVING ABORTION PROVIDERS THEIR FLOWERS WHILE THEY'RE HERE.

NEXT WEEK ABORTION PROVIDERS AROUND THE U.S. ARE BEING
CELEBRATED FOR THEIR STRENGTH AND RESILIENCE AND COMPASSIONATE
COMMITMENT TO CARE.

SEVERAL CITIES, EVEN CITY COUNCILS EVEN PASSED PROCLAMATIONS
THIS WEEK AND RECOGNIZING THE DAY OFFICIALLY.
