This policy will be written specifically for metro council and provides guidance for the proper use of social media accounts.

To ensure that Metro council social media accounts are compliant with state laws on data retention and our ethics code the policy also addresses the reality that many metro council accounts

are forms for the public and for the public's use to engage with us and others and provides 1st Amendment protections for both metro council users and members of the public we ask for your support.

I've been speaking with the administration this evening, and we have some misalignment 3 of the 4 items that are being changed are okay to move forward, but 1 of those descriptions does not match the intentions.

So our motion to strike section 2, making section 3, the new section, 2, and striking L. A. T. dash 0061. so we can work with the mayor on what we're actually spending that on. spending that on

It probably moved in 2nd, any discussion on the proposed amendment.

Kinds of like all this clarification. So it doesn't.

I'm not sure if I understand what counsel authors.

What the amendment was? Yeah. W. W. yeah, I know that.

He's asking to remove it, but it doesn't I don't know what he means by. It doesn't.

If the intentions of America would you like to clarify.

Absolutely, so when the director of the level accelerator team can celebrate, came to the budget committee last week he shared it with us and it's written in the ordinance that it does 4 things.

1, it extends the services for the safe outdoor space beyond that 1 year.

2, we take some money and we move it around to make sure that we purchase that community care space for more shelters.

3 we extend the time for to spend their reform money and 4, it helps make sure that our public safety bonuses.

Our legal with all of the guidelines.

But earlier today, the mayor announce some new investments in those investments, included a wellness center.

The new headquarters, public safety bonuses, and something about narcotics tip line as well.

Those investments were said to be in the press release, and I confirm with the mayor to be paid for, with American rescue plan money the project description.

Does not mention those investments they mentioned, making sure that we pay for reforms from the hill report.

And recommendation from the Department of justice, the Department of justice has not given us recommendations yet. And the hillier Heintz report does not outline what he announced today.

In fact, has a dashboard for their reforms and that dashboard does not have what he announced today.

So that's an issue and I want to make sure if we're going to spend the money on that we actually put it in the ordinance. We talk with the

administration to have an understanding of what we're putting the money into because right now, if we pass this.

We're saying we're going to spend it on reforms, but we're not saying what those reforms aren't necessarily. And I would argue the reforms that were announced today are not reforms whatsoever. Those are capital projects that are not in any recommendation that we received.

Thank you Michael. Did I answer your question? Didn't need constant. Did you have a comment? Yes, I do. Thank you. Mr. President. I, I'm supporting this motion. Not because I don't support some of the things that the mayor announced today.

For example, he announced.

A completed PD headquarters I think that's critical.

Uh, I, but I also agree with councilman Arthur that we need to be super clear.

About how this is being done and I will say, I'm not, I want to be super clear, not accusing this mayor with this, but we have had a problem with prior administrations,

making announcements or statements on spending dollars, without having really transparently come through a committee allowed us to digest it, debate it and and properly pass it.

And, um, I understand that's not what he's attempting to do.

And I'm not saying that's what he's trying to do, but my understanding is, there's nothing that's going to be hurt. We're passing the rest of the material that's in here.

It's just this 1 line, and frankly they can have a new filing in, you know, I think it's 10 days from today. 1st, reading in 2 weeks later it'll be approved. And if it's all in the up and up, I think it'll fly through.

And and again, I, I don't necessarily object with some of the mayor's priorities enough to fix. Some of them are terrific, but we should be totally transparent and the budget.

Ordinances should align to that. So I think it's a reasonable thing just to take the 1 out. Have the administration work with the budget chair a chair black? Well, the vice chair, uh, Kramer and and the rest of counsel to make sure that's done properly. So that that's why I'm supporting this amendment.

Thank you.

Any further discussion okay. For some right there we go. Okay. Sorry. Counsel them with training.



Thank you misunderstanding. May I ask councilman Arthur a question?

From Arthur, you can direct the question. Yes.

Councilman Arthur in your conversations today with the mayor's office, did they indicate that there is enough money to later come back for funding to get those items funded? Or did they suggested.

There would be another pathway for payment of those things he announced.

Well, that's kind of the issue, you know, we put aside 17.5Million for those reforms and then announcement today talked about 14Million dollars.

For this renovation, so 14Million dollars for the renovation a 1Million some change for the wellness center.

That leaves us with very little for the reforms and we have no idea what the Department of justice is going to say to us as far as how much this thing will cost. We put that money aside.

For that, just to save it for when that report and that, you know, decree comes down. So if we want to take some of this money and use it for what he announced today, that's fine. But that's not what the ordinance currently says.

And, like council and said it's important that we're clear, and we're transparent with the public about what we spend their money on.

Thank you, that's why I asked the question, because we can't assume that next week, if they put in a request that that should.

Automatically be approved, although we all agree that what he would like to do is so so important, but we have to be mindful of where we said those dollars should go. So, I'm in agreement with that. Thank you.

And counseling BLACKWELL has had a question since Arthur has been in discussions with the mayor's office over this 1. so it seems to me from my perspective, it seems to me, it would.

Make more sense, and be more efficient just to send the whole thing back. Because if you, if you move forward 3 out of the 4, and they send the other 1 back, and they have to create another ordinance, and then we have to have a reading for that, and then we have to.

So, you know, we're stretching that timeline out. It seems to be, unless there's a reason not to, it seems to me to be more efficient, just to send it back but.

Councilman Arthur, so, in my conversation, uh, of course, they want to move everything forward. He made that announcement earlier today.

But the safe outdoor space, the shelter space.

The public safety bonuses, I would think we would want to move those forward as soon as possible. And those are things that we are already aware of, that we've okayed in the committee.

That the administration is supportive of it's really just this piece that I'm trying to take out that we need to have more discussion about because the announcement today does not line up with the ordinance.

And furthermore, the ordinance that we did approve, it does not line up with what we assume the attentions to be based on those reports. I even talk with the former budget chairman.

Uh, Bill calendar, just to see if I missed something when we approved that money and we passed that money and to his understanding.

The announcement that came out today was never a part of the intentions of that 17.5Million if we change our minds. Okay. But let's at least talk about it and give the public some time to understand what we're spending their money on.

But the other 3 pieces we've already okay, those are outlined. Pretty clearly. This last piece is just what's missing from the ordinance.

Okay, with me, I don't feel strong any other any other comments on the amendment.

So, ordinarily we oh.

Oh, I'm sorry president Winkler. Um, I, I, I'm in support of the amendment as well. I think we need to get everything aligned, um, before we pass it all through.

I was actually in attendance today, uh, at the at the mayor's announcement, and I appreciate what he's doing and I'm supportive of what he's doing,

but I think it is important for for metro hall and city hall to be to make sure we're on the same page of how how we're spending.

In support of the amendment as well.

Now, seeing no 1 else queued in, ordinarily, this would be a voice vote. We do have a potential extension so I'm going to call for a roll call vote on the amendment.

So, we were voting on the amendment only Amanda click, please call those online counsel member. Arthur.

Yes, council member Fowler? Yes.

And counsel member ackrason yes.

Counseling Baker would you like to explain your extension? Please?

Thank you chair my parents church is in close proximity to the project and me not knowing what it's going to affect with their property values and.

And whatever return of investment, I think it's just best for me to abstain. So I will not be participating in voting neither discussion. Thank you.

Thank you the amended ordinance is now before us any discussion I'm sorry. Mr. you have 24 years and 1 extension member passes. The amended ordinance is before us any discussion on the amended ordinance.

I'm just going seeing none, please open the voting.

Council member Arthur.

A member yes.

Council member ackrason yes. President you have to. Can we get counterfeit? I know. You just did it but can you please.

Uh, describe your extension uh, again, um.

My parents church, my father is the pastor of the church that's in close proximity to this project. Not knowing what it will do to property values.

And other return of investments I think is best for me to abstain from any vote or discussion on this project.

Mr. president you have 24? Yes. Folks in 1 extension. The ordinance passes. Nonclinical reading item 29.

The requested amount is 10,000 dollars and we're at 5,250 right now the primary sponsor was council woman Shanklin. She may want to speak to it. may want to speak to it

Council and Franklin, thank you dot Greenway. Let me. Oh, what's his name? Greenway Thank you. Mr.

uh, this was left over from Cassie.

Council casting Armstrong, and I think they found it in December and nobody was there to work with it. So they gave it to my office and they were asking for 2000 dollars from district districts.

They have libraries and it was 2. two

And so they were asking for 2000 dollars for all of those 25 and 15.

and so, in any 1, that's close to the zip code or 4 to 20 or to 18 for 223 4222and4 2 or 3 they're asking if you want to give funding towards this mental health program.

But the ones that I mentioned, they are wants to have libraries. the ones that i mentioned they are wants to have libraries

In their district, and they're asking for 2000 dollars from each 1 of those districts. And so far we got 2000 from 2 and 4 and I think 19 gave 1000.

And, uh, 14 gave 250.

So, if you have a library and you want to give 2002 towards this mental health program in your district are close to your district.

They are asking for funding, uh, councilman Arthur.

Piece I know in the budget committee, we were asking about the specific library locations. Did we ever find that out? Because we have Western in Maine.

But they only asked for funding for 2.

For 1825 and 8, I think.

I've got it written down on a piece of tissue so it's hard to see understood. I was just wondering if we knew which branch they were going to take the program to and district for.

They are going to do 7 districts. He said.

Sovereign libraries to downtown.

So, this was not my ordinance. This was.

Someone else's that was just given to me. Okay. Well, shout out to the love of free public library. The best in the world. I strongly encourage folks to support this. We could never have enough mental health resources. Thank you.
