There is well more than the 48 inch clearance needed for installation thus no pads need to be poured. You OK'd the weekly trash pickup already. (See below) I know you mentioned SWMS may not be able to install with the crew shortage so we are appropriating \$8,000.00 for the 7 can, installation by the company and freight charges. (\$1,100 shown below per can and estimated freight charges.)






Thanks for your email following SACC's general neighborhood meeting. It was great to meet you and Kevin. Hope you all have had and continue to have a wonderful holiday season.

We would love to move forward with ordering seven green trash cans. In this Google Drive folder, you will find a map of the proposed locations for the trash cans, as well as photos of each location. There is ample room on each of the

identified corners for the trash receptacles to be installed. We had discussed using an NDF for half of the cost (\$3,850) and having SACC assume the cost for the other half (\$3,850). We are happy to provide a check for this amount at any time. Please let us know how we can get the ball rolling on the NDF. I've attended the NDF training and have written many.

The black or green slotted ones range around \$1,100 which includes liner, bolting down to ground and freight charge. However, the location has to have an area for bolting down. If it's a sidewalk there must be 48 inches clearance for handicap after installing the can. (Wheel chair, walker, etc...) If not a concrete pad will have to be poured to accommodate the trash can. When you get me the locations I will be glad to inspect the area. I have had many installed.
