AN ORDINANCE APPROPRIATING ~~\$11,200~~15,700~~18,200~~ NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$3,500 FROM DISTRICT 15; \$2,000 FROM DISTRICT 21; \$1,500 EACH FROM DISTRICTS 5, 7, 10, 12, 13, 14, AND 25; \$1,300 FROM DISTRICT 1; \$250 EACH FROM DISTRICTS 2 AND 9; AND \$200 EACH FROM DISTRICTS 4 AND 6; TO METRO PARKS DEPARTMENT TO FUND THE 2017 LOUISVILLE JACK O'LANTERN SPECTACULAR HELD AT IROQUOIS PARK AND PROVIDE VOUCHERS FOR REDUCED ADMISSION (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$11,200~~15,700~~18,200~~ is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,500 from District 15; \$2,000 from District 21; \$1,500 each from Districts 5, 7, 10, 12, 13, 14, and 25; \$1,300 from District 1; \$250 each from Districts 2 and 9; and \$200 each from Districts 4 and 6; to Metro Parks Department to fund the 2017 Louisville Jack O'Lantern Spectacular held at Iroquois Park and provide vouchers for reduced admission.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
