PRESIDENT YATES: Colleagues, it is my distinct honor and privilege to once again accept your vote for the Metro Council president. Thank you. Thank you for your trust and your confidence. I look forward to a very important year in 2017.

And before we get started, I must first look out to the crowd and thank my family. I see my grandfather. And Wanda served in the house

of representatives for 22 years, not just the intent, but what it really meant to be a public servant. At a time when I wasn't even sure about running for office, she was the one that told me you need to do it. You need to do it for your community, for our family, and you need to do it for those little girls. I thank you.

My uncle Jim. My father Charlie. My two beautiful daughters, who are my everything, Ava and Grace, who are here. I'm missing one person, my mother, who passed away, and all y'all were there for me. It is her birthday tomorrow. And I will tell you everything I do I do to try to honor her, and I think that life is often defined before and after defining moments. Now that she is gone, I think it is very important to create a life and do the things that I think are necessary for myself, for my family, for our city too. And I know each of you do that.

Just in this last year as president I have learned a lot. I have learned how to better lead, but I have also learned how to listen, when to step back and try to bridge gaps and bring people together. I have got to know each of you better. I was joking in our caucus that I have butted heads with every one of our members at least once, and I can say that about at least everybody in here, good and bad. But I can tell you I know for certain that we have so so much more that unites us and brings us together than what sets us apart.

One of that is our family and the desire and need to serve. That is what we do. We sacrifice. I look at those two little girls and they sacrifice so much of their father's time so that we can better serve our community. But we do that so we can have a better future for them. I also want to take a second to thank my law office, who has stepped up for me to

be president and work long hours so that I can do this job. And everybody in here knows how great my legislative assistant Brian Bowles is. He took on a lot of extra hours and time. I appreciate your help. I didn't know what I was getting with Lisa. We are working a lot to make things better, though. We are going to have another financial analyst position coming up so that the whole council can be better informed.

If you look back and you reflect on what we have done just over the last year, think about it. One year, we have done so much. We have talked about before I was elected president, we were so concerned about how we were going to strive to do economic development, and we are booming. We have cranes in the sky. This city is booming like it has never boomed before. We decided we wanted to be responsible, and there were several members that brought up our deferred maintenance issues, the road debt. Instead of kicking the can to future generations, to my little girls, your grandchildren, we decided to be responsible. It isn't glamorous. We didn't get to cut a lot of ribbons for paving roads, but we put it in the plans. \$22 million in the next decade is what we committed to so we can be responsible government. We do the meat and potatoes, the things we are supposed to do in government.

What is the other something the infrastructure needs? The other thing is public safety. What city are we if we are not safe? Public safety in all aspects, not just our police officers, which are very necessary, but all of our first responders. We make sure they are equipped and they have the talent, equipment and funding they need. We will have to do that again. I love the way this council came together this past year when we saw a need with the unprecedented amount of murders and violent crime.

We are all elected to represent our prospective districts. We didn't scramble over the funding of where the money will come from. We had too many people dying, and we came together and gave all the tools that we can. And when I say all the tools, not just boots on the ground, which we will continue to do, but resources too. We have people and programs to help children make better choices. We have responsible policing, community policing. And I will tell you whether I'm wearing this hat or another, I believe very strongly in holding our law enforcement officials accountable, but I also believe in supporting them so they can do their job. I think that is what this body needs to do this next year. I think that is what we have done. We will support them by making sure we have all the tools and resources they need. 62% of our budget last year was for public safety. And I'm proud of that, because it is what is needed. We need to balance that, and we will move forward on basic principles.

We also came together and we looked at the LG&E franchise fee. It was a big one. It was nothing more than a regressive tax on some of the poorest residents in the city. We stepped up and fought it and challenged it and came together as a body to put together a work group to ensure that the fee wouldn't just be passed on to those who would be most harmfully affected, and I'm so proud of the individuals who worked on that long hours that didn't even affect their district for the good of our city.

We denied an MSD rate increase of 20%. It still worries me because the public safety aspect of MSD is making sure we comply with not only the EPA but flooding. Each year we will have to be responsible and work with them. But we also knew that we had to protect our constituents from overburdensome taxes of 20%, something that a lot of them couldn't

do. That was dead on arrival here. We came together. Bipartisan for our constituents.

And Google Fiber. I think everybody in this room knows -- some constituents don't have it yet -- Google Fiber is a game-changer for our city. We will be among the fastest Internet in the world. We did that by working together. We reduced regulations. Cut all the that I think so people say are problematic with government, we streamlined that. There are other cities looking to see what Louisville did. That's good government. And I have to thank the administration and the members of this body for doing so.

2017 can bring us a lot of opportunities too. Not only with the cranes in the sky because the development, more development than we have ever seen in this city. We have got numerous hotels, buildings, the Omni, convention center, the Dixie Highway do-over, the redo, so much economic development. But West Louisville has not had that big win yet, and that is very important because all ships have to rise with the tide. You can't win the race with a flat tire, and we need a win for West Louisville. We will be meeting with the chamber of commerce to make sure it is needed. It goes hand in hand. It goes with our public safety. Because when individuals live in very, very low income or are homeless, it is very hard to go to school to get an education. You lose hope. And a lot of times you turn to crime. We have to make sure that we reduce our food deserts. We have to make sure that we have prosperity throughout the entire city.

The HUD grant, \$29 million to revitalize the Russell neighborhood, tear down Beecher Terrace and build new housing is huge. But we have to build momentum. I'll ask all of us to do what is best for the

community and make sure that we have the economic development everywhere. Crime continues to rise. If murder rates continue high, economic development will blunt. It will hurt the city. So we have a compassionate responsibility. We also have an economic responsibility to make sure that there is prosperity throughout the community. We are tearing down Beecher Terrace and the vacant houses. We made sure we know that we need additional workforce and affordable housing throughout the community. People don't have places to stay. We are getting ready to tear down projects. We have to make sure that we are working within each of our communities to make sure that has met the need of our constituent base.

Then we are going to have this budget due diligence, and I think the leadership here, we will have two full months for the mayor's proposed budget. It is already a lot of work, as I have learned the past year. If we all set aside our individual wants and needs -- don't get me wrong, I want you each to represent your own district as you were elected to do, but we have to look at the greater good, because all boats will rise with the tide. We come together and we make sure we have huge changes, and we are responsive. We know at the state level there will be changes in the tax code that might affect us. We need to make sure that we have communication and that we lead here. Regardless of our party affiliation, our age, race, creed, anything else, we are all elected to represent the city of Louisville, and I believe each one of you will vote your conscience but then work hard to make sure that Louisville will continue to prosper and win. But in order to do so, we have got to address our public safety. They will be coming to us here in a couple months to look

at some of the changes we have made, and we maybe have to adjust and hold those accountable.

I think that we have each learned a lot. I think this next year will be a big win. I intend to build on my experience and improve from where I fell short. I know some of you have not been — have been reluctant to tell me where we need to improve. — I appreciate that. I will continue to have an open-door policy. Stop by my house or the office. As long as we are working together and communicating together, Louisville will win. With that, sincerely appreciate your confidence. Thank you for electing me president of the Metro Council.

[APPLAUSE]

Council Members Bill Hollander and Robin Engel, would you please announce to Mayor Fischer at the conclusion of the meeting that our 2017 Metro Council has been organized and is in session?

Next, election of the clerk for members of council. The next order of business is election of clerk. Nominations can be made from the floor and no seconds are needed. The nominee needs 14 votes to be elected. Nominations are now in order for council clerk.

COUNCILMAN KRAMER: Mr. President.

PRESIDENT YATES: Councilman Kevin Kramer.

COUNCILMAN KRAMER: Thank you, Mr. President.

It is my great pleasure to nominate for another tremendous year of service Stephen Ott as clerk. He has served us incredibly well, and we are very proud of the work that he has done, and I'm hopeful that my colleagues would agree that we can elect him unanimously.

PRESIDENT YATES: Thank you, Councilman Kramer.

Are there any further nominations?

Hearing none, the nominations are closed. If there are no other nominations, then you have -- you know what, Mr. Clerk, let's bring open a roll call vote. If there are no other nominations, please open the voting. I guess we could have done a voice vote.

Mr. Clerk, I was just wanting to make sure that you were going to get unanimous. There you go. The voting is open. Without objection, the voting is closing. The voting is closed.

MR. CLERK: Councilman Benson, I also feel kind of strange reading the tally for my own vote.

24 yes votes and 2 not voting. Thank you very much.

PRESIDENT YATES: Congratulations.

She would have been down here tonight to watch the swearing in, but we don't like to have her take the chance of falling when the weather is inclement. I want to thank my mother. She watches us faithfully every time that we have a meeting, and my husband, who has stepped out of the room for a minute, Don Flood, for 18 glorious years of marriage.

Those of you who are new on the council will truly find out very soon how much of a sacrifice that your family will make to allow you to do these positions. And I wanted today thank my son and daughter-in-law,

Brandon and Stacey, and my two wonderful grandsons Oliver and Christian. Christian who is certainly at eight years old sees a future in politics. Very opinionated at eight years old, but I wanted to publicly thank those people who allow me to do this and the constituents of District 24 for allowing me for four more years. Thank you.

AN ORDINANCE CHANGING THE ZONING FOR 147 PROPERTIES FROM VARIOUS ZONING DESIGNATIONS, INCLUDING R-4 SINGLE-FAMILY RESIDENTIAL, R-5 SINGLE-FAMILY RESIDENTIAL, R-5 MULTI-FAMILY RESIDENTIAL, R-6 MULTI-FAMILY RESIDENTIAL, R-7 MULTI-FAMILY RESIDENTIAL, OR-1 OFFICE RESIDENTIAL, OR-3 OFFICE RESIDENTIAL, C-N COMMERCIAL NEIGHBORHOOD, C-1 COMMERCIAL, C-2 COMMERCIAL, C-M COMMERCIAL MANUFACTURING, AND M-2 INDUSTRIAL TO PD PLANNED DEVELOPMENT DISTRICT; AND CHANGING THE FORM DISTRICT FROM NEIGHBORHOOD TO TOWN CENTER FOR 93 PROPERTIES AND FROM TOWN CENTER TO NEIGHBORHOOD FOR 3 PROPERTIES; AND ADOPTING THE PD PLAN AND GUIDELINES FOR PROPERTIES FRONTING ALONG BOTH SIDES OF FEGENBUSH LANE BETWEEN FEGENBUSH LANE'S INTERSECTIONS WITH VAUGHN MILL ROAD AND BEULAH CHURCH RD AND ADDITIONAL

PROPERTIES LOCATED WITHIN AN AREA GENERALLY BOUNDED BY BEULAH CHURCH RD, DELIGHTFUL WAY, HAPPINESS WAY, OUTER LOOP, APPLE VALLEY DR, VAUGHN MILL RD, BRISCOE LN, GLASER LN AND WATTERSON TRAIL, CONTAINING APPROXIMATELY 236.26 ACRES AS MORE PARTICULARLY DESCRIBED IN THE HIGHVIEW PD PLAN, AND BEING IN LOUISVILLE METRO (16AREA1004).

Read in full.
