VISION STATEMENT:

UNA-USA KY Division's strategic planning makes one of the 17 UN Sustainable Development Goals, SDG #5, our top priority; to empower women and to work for gender equity. Therefore, our works on the Convention on the Elimination of all forms of Discrimination Against Women go onward with focus on Article 6: we take measures to bring awareness, education and to advocate (including legislation), to suppress all forms of trafficking in women and exploitation of prostitution of women. We see a Louisville Metro, Kentucky and beyond where trafficking is being addressed by law enforcement - also agencies have the ability to provide shelters for women, children, men, boys and marginalized community members as well as education, counseling, mental health care and other forms of help for trafficked victims to become survivors.

Technological advances (Thorn's 'Spotlight' and now 'Solace' uses computers to become digital defenders of children) by law enforcement will eventually disable slavery whereas, initially and now, criminal uses of computers reign to destroy lives and futures since the tables will turn. We will also have more and better laws at the local, state and federal levels and see laws that are similar if not the same in these 3 levels of government as governments work together. There will be more STINGS by law enforcement over the U.S. to not only incarcerate traffickers but to send a message to not get involved in such criminal enterprises as well as nix those who are not knowledgeable that what they are doing is criminal as well as morally wrong. Brilliant persons will step forward whether through philanthropy or corporations to help eradicate the scourge of human trafficking that also involves many diseases and increases healthcare costs.

F. Briefly describe any existing collaborative relationships the organization has with other community organizations. Describe what those partners are bringing to the relationship in general and to this program/project specifically.

Co-sponsors to date: UNA-USA Frankfort Chapter will provide some funding and email to members to attend and volunteer; UNA-USA Louisville Chapter will provide funding and email to members and volunteer; UNA-USA Bluegrass/ Lexington Chapter will provide some funding and email to members; UNA at U of L campus chapter can email to members and acquaintances as well as stake yard signs on campus for the event; UNA WOMEN at U of L will also email to members and others as well as stake yard signs and volunteer; UNA-USA KY Division will provide some funds and email to members and others, post yard signs, get more co-sponsors, arrange committee meetings and line up volunteers for the event. We anticipate working again with U of L Women's Center for some funds and notice to others on campus and beyond. We anticipate working again with AAUW Louisville Branch for some funds and notice to members. We will again reach out to the Mayor's Office for Women for help and perhaps a brochure on ACE's (Adverse Childhood Experiences) and how this factors in with Human Trafficking, etc. NGO's can furnish volunteers and disseminate information by emails, facebook, newsletters, websites and word of mouth. Information can go to their national organizations and government sponsors can potentially provide information at committee meetings and to their staff. More awareness means more detection of victims and perpetrators and the ability to get help right away or to call 911 if immediate danger. The NGO funds help us to pay for items we cannot pay for with this grant such as travel, lodging, food, small gifts/awards. We will reach out to past NGO's who helped: Alpha Kappa Alpha Eta Omega Chapter (lots of teachers eager to get this information and helped with funding and attendance); KY Foundation for Women for funding and art work display if possible – one speaker has benefited by their help; U of L Kent School of Social Work funding and students attending; Zonta Club of Louisville for funding and attendance as well as individual donors from the past who have helped with funding.

- A -Teena Halbig was re-elected to serve another term on UNA National Leadership Council. Teena and Bill Miller will attend the Leadership Conference in Washington, D.C. from June 10-12. Halbig will also attend The UNA-USA National Council Meeting on June 9th -a day earlier to address UNA-USA Divisional Agenda including development of a Template for Divisional By Laws. Chapter By-Laws have been completed.
- B. Halbig reported on a successful Human Trafficking Conference held on Dec 6, 2017. She also reported the close out letter of Metro Council Funding.
- C. Jeanette Westbrook indicated that S. 1693 - SESTA=Stop Enabling Sex Traffickers had passed the US Senate. Formal letters were sent to Senator Mitch McConnell in support of S.1693, and McConnell voted YES for passage. The KY Legislature also voted 83-0 in a resolution in support of SESTA/FOSTA.
- D. Teena Halbig attended the National "Global Engagement Summit" held February 22- 24, 2018 in New York at the UN.
- E. At Commission on the Status of Women (CSW) 62 at the UN, UNA-USA board members Teena Halbig, Jeanette Westbrook, were on the Panel:: "Human Trafficking & CEDAW: Meeting Challenges and Utilizing Opportunities" on March 14, 2018, and Robin Frederick and Jeanette Westbrook were on "Intersecting Grassroots Radio and New Technologies to Reach Rural and Refugee Women." Also, Jeanette Westbrook presented on a panel at The John Jay University of Criminal Justice on Tuesday, March 13, along with Canadians Jeanne Sarson and Linda McDonald on NON State Torture

KDUNA Teena Report Global Engagement Summit Annual Meeting 2-23-18

Highlights of UNA-USA national Global Engagement Summit 2-23-18 Report by Teena Halbig on 2-17-18:
Overall recommendations:

Importance to attend national events for a plethora of information and to meet other UNA-USA members, staff, and officials. Important emphasis on gender equality and climate change and SDGs this year. How businesses can help with SDGs is a good way to involve NGOs. Wonderful speakers include His Excellency Miroslav Lajcak and meeting the great granddaughter of Eleanor and Theodore Roosevelt (and photo together). Use of the term, "migration" that is a better "buzz" word. The increasing global refugee crisis and need for more storytelling. Good to continue the Stand Up 4 Human Rights.

We were in the United Nations General Assembly Hall where many Presidents, several Secretary-Generals and many notables have been and spoken from the podium. I was in it before and this massive room holds 1,900 people and UNA-USA registrations were upwards of this number with maximum number of attendees that could be accommodated with a waiting list.

Some of the sponsors spoke as well as the U.S. Youth Observer to the UN, Munira Khalif. Next was Her Excellency Amina J. Mohammad, Deputy-Secretary-General since the Sec.- Gen. Antonio Guterres was unable to be with us. Her focus was on preventing war, humanitarian need for treaties and SDGs. Climate threats and widening inequalities and economic and technological challenges to achieve the SDGs.

I always enjoy Peter Yeo, who is in charge of Better World Campaign who noted, "This is the largest gathering of supporters in the UN in history!" and called us 'change-makers'. He introduced Ambassador Kelley Eckels Currie who is Ambassador to the EOSOC and she lives in NY. She pointed out the voices of the 193 countries where each is treated equally whether 1.4 Billion population in China or in the small islands of a population of only 20,000. She told how the present day work to get the 15 members of the UN Security Council to get Syria to agree to a 30 day pause in the war so medical, food and evacuations of injured could occur.

From this point, there were sessions in Conference Room 4 or in the UN Gen. Assembly Hall.

I chose to attend Climate Change:

Of all the speakers, I thoroughly enjoyed all the comments of the youthful Lia Cairone, Sr. Policy Advisor of NY City Mayor's Office of Sustainability. The challenges are immense but the actions are so positive and strikingly monumental to meet SDG 13 that include laws for future building codes by 2020 as well as legislation to mandate over 15,000 larger buildings to reduce fossil fuel. And plans to lower traffic, deaths and to have some electric vehicles. I am contacting our AG regarding a potential avenue to get BILLIONS for Kentucky in a separate letter. Jamil Ahmad, Deputy Director and Head of Inter-governmental Affairs, UN Environment: spoke to say, "The health of our planet depends on climate change." There will be a July 2018 meeting. There is more political awareness. Megan Boone pointed out there is never a valuation on air or topsoil and this is an oversight. Lia Cairone: Cities are responding

to the Paris Agreement and the C40 Group is working to have cities reduce greenhouse gases in 3-4 years. Where NY is expected to have 80% decrease from 2015. NY is leading the Global Protocol for Greenhouse Gases for Cities. THE U.S. WITHDREW FROM THE PARIS CLIMATE AGREEMENT but work goes on nonetheless. NY wants to PROTECT the city with an electric grid for hospitals for example. It is a struggle to find the resources for these problems and need to raise funds – including innovative crowd-sourcing, youths, private sector, etc. The U.S. conference of Mayors knows that by 2050 most will live in cities. It is imperative to work with preservation agencies, agencies with housing, and the broader community, etc. Need for making housing affordable and better health and air quality, reducing energy bills, etc.

UNA-USA Chair Teta Banks introduced His Excellency Miroslav Lajcak who is the current President of the UN General Assembly. He stated the UN Charter's first purpose is to save the next generation from the scourge of war and how any country can join when they agree to the UN Charter points. Gen Assembly is crucial but not legally binding decisions but does have a level playing field where all members are equal and each has a voice/vote. He said we are "Stronger together than alone". He outlined the UN Agenda: 1. Migration that is a global phenomena but there is no document addressing migration but there is a 2016 Practicum about a "global contract ____ and migration" with a set of principles. This will be about migration in July in the UN and by Dec., 2018, he hopes it will be adopted because there are 258,000 people on the move. **The U. S. pulled out of the process.**

Sustainable Development (SDGs) to make this planet a better place by 2050: tap into private funding to find the money to link to SDGs. Water concerns since 2.1 BILLION do not have access to clean water and 1 in 3 no basic toilet. There will be a MARCH for WATER for Sustainable Development.

Peace & Prevention – professional Diplomat. Need UN mediation. 2016 Resolution "Sustainable Peace" April 24 & 25th for Sustainable Peace.

Human Rights – from Eleanor Roosevelt – we need to stand up for HR; speak up; violation is the first indicator something is going wrong. UN Security Council does not represent the 21st Century but is more visible and prominent now. There will be public hearings for the President of the UN this next year.

Peace & Security & Management to address "Global Challenges to

CLIMATE, MIGRATION & SUSTAINABILITY. There has been no respect for the RULE OF LAW.

Questions: Global Migration can't be addressed by government alone. Partners , NGOs, local government need to have an open dialogue to write policies.

Prevention & Peace: Ukraine is on the agenda and several Resolutions have been adopted regarding violations. The UN is paying attention.

Lacjack: said the UN is guidance and not dictated; the 17 SDGs are not binding; member states take what they want into national legislation. The UN Global Contract is to be a document to inspire government to change.

There are obstacles in this General Assembly Room since the 193 countries have different interests. Any RESOLUTION carries very powerful and political messages.

Question about Bangladesh Women Rohingya, Myanmar – over a year now and what steps?

One youth wondered why WATER over WOMEN but he explained SDG6 Water this year with events in Brazil and March 22nd is International Day of Water.

LUNCH

Rachel Pittman: Refugee Crisis – worst since World War I! with 65 MILLION forcibly displaced from Iraq, Somali, etc. with 51% less than 15 years old. Need to fund UNHCR and work on Adopt-A-Future since the demand for education is strong. Myanmar is accepting 680,000. The number of refugees is constantly increasing and stories need to be told. No one can do it alone, not just the UN, no one for this massive scale of displacement. Grainne O'Hara explained that only 1-2% ever resettles back to their far away countries – they don't go back. A wonderful program "Sesame Street programs for children in their language with funding from a Foundation. While 1000 organizations applied, the grant was given for this for \$100 MILLION.

It was said that "unless you are a NATIVE AMERICAN, you are an immigrant!"

I was being instructed by another UNA member on using Instagram but Jeffrey Sachs was giving a good talk.

He was followed by the great-granddaughter of Franklin and Eleanor Roosevelt who spoke about women's equality and taking citizen action. The need to stand up 4 human rights: if not us – who", if not now – when?

It was reported that 1,300 messages were sent to Congress by us! UNA to 52886.

Then I went on to 6pm to 9pm meeting with National Council on 2-23-18 and again on 2-24-18 8am to 4:15pm National Council Meeting.

Background

Classified advertising websites are making it **as easy as ordering a pizza to order human beings for sex** from the privacy of one's home, office, hotel room, or cell phone. **Many of those bought and sold on such websites are sexually trafficked children and adults.** One such website, Backpage.com, facilitates this activity by editing ads to conceal the illegality of underlying criminal activity.

Despite investigations by the U.S. Congress and several court cases, websites like Backpage.com are getting away with their role in facilitating sex trafficking. Why? Because of an outdated law that is shielding them from justice. That law is the Communications Decency Act (CDA). Most of the CDA was struck down by the Supreme Court years ago, but Section 230 remains and unfortunately, it is being interpreted by the courts to give Backpage immunity for facilitating online sex trafficking. For this reason the National Center on Sexual Exploitation (NCOSE), along with survivors, anti-trafficking advocates, law enforcement officials, and concerned citizens are calling on the U.S. Congress to amend the CDA.

Legislative Update

On February 27, 2018, the U.S. House of Representatives passed historic legislation to amend the CDA by a vote of 386 to 25. This package included H.R. 1865, the Allow States and Victims to Fight Online Sex Trafficking Act (FOSTA), sponsored by Rep. Ann Wagner, *and* an amendment offered by Rep. Mimi Walters which added in the language of S. 1693, the Stop Enabling Sex Traffickers Act (SESTA). SESTA, sponsored by Senators Portman, Blumenthal, and McCaskill, makes the vital CDA changes we've been asking for. Without the Walters amendment, the long sought-after changes to the CDA would not have been included since these provisions had been previously gutted from FOSTA by the House Judiciary Committee. With this legislation combo, key alterations to the CDA are made: the right to pursue civil rights of action is restored to sex trafficking victims and state Attorneys General are empowered to bring prosecutions against bad actors.

Now that FOSTA, with the Walters' SESTA amendment, has been passed by the House, the push to amend the CDA moves to the Senate. Please sign up for NCOSE emails and check this webpage for updates on this process.

This is the most important anti-trafficking legislation in a generation. If you care about stopping sex trafficking there is no single legal reform that is more vital than amending the Communications Decency Act now! Please join us in calling on the Senate to #ListenToSurvivors, and not protect the kingpins of sex trafficking!

GREAT NEWS!

President Trump signed FOSTA/SESTA into U. S. law Monday, April 9, 2018.

Now websites that are found engaging in criminal activity will be held accountable.

It is not okay to purchase someone for sex - this is **abnormal and criminal** so don't think it is normal.

Derbytime is one of the times of the year when sex trafficking spikes. Make other folks aware this is a crime - encourage them to not to make that cold call because sometimes the person on the other end of the number is not a 14 year old girl but a cyber crimes law enforcement person. A person's life will be forever changed when involved in crime.

Changes are being made and fast action taken by Craigslist, CityVibe, Reddit, Erotic Review, etc. so they won't be **arrested like the SEVEN backpage.com executives were on April 6, 2018.**

Backpage.com has a history of online sex trafficking so when these executives were arrested, the **website was also seized by the FBI on 93 indictments.**

WOW! Changes have come about due to the outcry of many from various walks of life that have included lawsuits when youths have been victimized.

Thank you for your concerns over trafficking and this is indeed, a great victory after many years.

It is fine to thank your Congressperson since it took Congress to fix this problem with legislation of FOSTA and. SESTA . We can be proud of those in Congress who acted to make this happen.

Louisville, KY: Teena Halbig was chosen as the **National UNA-USA Delegate to the UN for the CSW62** (Commission on the Status of Women, 62nd year) in NYC. Additionally, her proposal of **“Human Trafficking & CEDAW (Convention on the Elimination of Discrimination Against Women): Challenges Encountered & Utilizing Opportunities”** was chosen by the national UNA-USA to send to the CSW62 Committee who also selected her proposal to be given on March 14 in New York. Teena selected additional panelists (see the attachment) and was Moderator. The room held 200 for the 90 minute presentation. And the national office was represented the day of the panel with the presence of Rachel Pittman. A debriefing will soon occur this week with the national office.

ABOUT CSW: The UN Commission on the Status of Women (CSW) is the principal global intergovernmental body exclusively dedicated to the promotion of gender equality and the empowerment of women. Established in 1946, the CSW is instrumental in promoting women's rights, documenting the reality of women's lives throughout the world, and shaping global standards on gender equality and the empowerment of women.

Teena is also on the UNA-USA National Council and serving her second year. She is now the Immediate Past President of UNA-USA Kentucky Division after serving as state President for 6 years.

The accomplishments of getting the FIRST STATE CEDAW Legislation (“States for CEDAW” passed in the United States was part of her presentation as well as earlier work as a coalition member with the local Louisville “Cities for CEDAW” resolution that was the second to pass in the U.S.

She attended the CSW60 two years ago when 8,000 attended but this year of CSW62 had the greatest record attendance of more than **10,000** registered individuals (men, women, students, elected officials, etc.) from around the world. **This was the largest gathering in the history of holding the CSW at the United Nations Headquarters in New York City.**

Another Debriefing of CSW62 will be held locally in Louisville off Bardstown Road at the Historic 1796 Bashford Manor Inn, 2227 Bashford Manor Lane (just off Bardstown Road at the red light with entrance marked with two horse heads) on **April 21 from 1-5pm**. Several will speak to share their experiences and insights gained on problems facing women worldwide and how to advance the women’s agenda which also helps men, boys, girls and children. UNA-USA KY focus was on Sustainable Development **Goal #5** for Gender equity and to Empower women and girls and CEDAW’s Article 6 to

take all appropriate measures, including legislation, to suppress all forms of trafficking in women and exploitation of prostitution of women.. Another presentation will be on the Status of Women in Louisville and also on Radio Communications being effective in rural communities in the world. Also, legislators and elected officials will be recognized and have a few minutes to address folks.

We are currently in a celebratory mood since **FOSTA/SESTA = Fight Online Sex Trafficking Act and Stop Enabling Sex Trafficker's Act passed the full U.S. Senate on March 21, 2018. Now, 3rd parties can and will be held accountable for criminal involvement with online ads. Senator McConnell gave his support on the U.S. Senate floor in his speech last week.**

Already, "[Reddit changed their policy](#) and reacted to say there will be no more: "*Paid services involving physical sexual contact*," and [Craigslist has officially removed the Personals page](#) from its website. Erotic Review, a discussion board for buyers, has shut down its US page and CityVibe, a site promoting prostitution advertisements, has also shut down". No doubt Backpage will be watched closely for sex traffickers" per Equality Now online report today (3-24-18). This proves a swift response by third parties to the passage of this important federal regulation.

In addition to this federal legislation, Teena worked to get several bills in the 2018 KY General Assembly – two are on Human Trafficking, one on FGM = Female Genital Mutilation and 3 on gender equity. Some have companion bills. Additionally, she is working on a local ordinance which will soon begin to be put forward. Teena has been working with the national AAUW (American Association of University Women) Public Policy Mgr. who is also an attorney (Kate Nielson) and bill sponsor. Teena serves as Public Policy Chair for both AAUW Louisville Branch and the state AAUW Kentucky.

She will tell how State Representative Jim Wayne (who is retiring this year from the KY House of Representatives after 28 years) sponsored House Resolution 6 in 2016 (and with the help of Co-sponsors, including State Representative Mary Lou Marzian) was able to gain passage to make Kentucky the FIRST State to have STATE legislation on CEDAW. Since creating "States for CEDAW", other states that passed "Cities for CEDAW" have followed this initiative. She came to value even more our democratic system of government, even with its faults. Her goal in sharing her experiences is to help wake Americans up to the reality that our Constitution, our rights, our freedoms, and the facts and truth are being sacrificed for the personal financial gain and power of the top leaders in our country. At no other time in her 62 years has Katherine felt the extreme desire and need to speak up and out. As a woman of the world, she hopes that her story will inspire others to come out, speak up, and vote. This is one of the most critical times in our history to encourage everyone to register to vote and to go to the polls on November 6th. If not, we are sleepwalking to the precipice!

Are We Sleepwalking to the Precipice?

Katherine has been a business innovator and entrepreneur for 36 years. For two decades, she has served on boards with several Kentucky civic organizations and is a Past President of Louisville NAWBO and Louisville United Nations Association USA. She is a Parkinson's disease expert and Board Certified Patient Advocate in her company, Parkinson Partners, LLC., advocating for and educating people with Parkinson's and their families, helping them through the difficult journey.

In 1973 after graduating from T.C. Williams High School in Alexandria, Virginia, Katherine traveled on an exchange program for comparative political studies to The Soviet Union, Helsinki, East Berlin, Warsaw, and other countries. The six-week trip changed Katherine's life. Three weeks in Leningrad (now St. Petersburg), Kalinin, Moscow, and East Berlin brought sadness and concern to Katherine. Hear her story to get a unique perspective on what we are experiencing today.

Katherine Johnson Autin is from Alexandria, Virginia. With a B.A. in international studies and cross-cultural training from the School for International Training in Brattleboro, Vermont, she moved to Washington, D.C. where she met and married John David Autin (David). In 1985 they moved with their son, Michael to Metairie, Louisiana. In 1991 David's job with the U.S. Department of Commerce moved them to Louisville, Kentucky where he became the Director of International Trade Operations for Kentucky. In college, David and Katherine lived in France and both speak French. Katherine also speaks Italian.

Katherine's father, Haynes Bonner Johnson was a Pulitzer Prize winner in 1966 for his coverage for the Washington Evening Star of the civil rights movement in Selma, Alabama (Mr. Johnson walked with Martin Luther King in Selma). He later worked for the Washington Post, was often on *Meet the Press*, *Washington Week in Review*, and *the McNeil/Lehrer Report*, and authored 17 books. Katherine's grandfather, Malcolm Johnson won his Pulitzer Prize in 1949 for his local reporting for his 24-part series "Crime on the Waterfront" on which the movie, *On the Waterfront* was later based. They are the only father and son Pulitzer Prize winners.

KDUNA H.R. 6568 Police Sex 9-6-18

7 attended Meeting with Senator McConnell's field rep., Andrew Condia

Teena gave the below info:

Rep. Jackie Speier (D-CA 14), **H.R. 6568** Police Sex. Introduced July 2018; co-sponsor Rep. Barbara Comstock (R-VA 10). It awaits a potential vote in the House Judiciary Committee.

Closing the Law Enforcement Consent Loophole Act would jail cops who have sex with someone in their custody and prohibit a claim of consensual sex as a defense (only federal law eliminating the consent defense is for federal corrections employees). If guilty, sentence to 15 years in prison – even if all said it was consensual.

Federal law enforcement officers include anybody with Immigrations and Customs Enforcement (ICE), the FBI, Department of Homeland Security, and other similar organizations.

It would incentivize 31 states to change their laws and encourage annual reports to Congress for such complaints and provides additional funding to states that do so through the Violence Against Women Act.

About 1 in 6 law enforcement officers charged with sexual assault from 2006 to 2016 were either acquitted or charges were dropped by claiming consensual. Research shows sexual misconduct is the 2nd most frequently reported form of police abuse but unknown statistics.

National attention when an 18 year old alleged 2 Brooklyn police detectives raped her while in their police van. The detectives resigned.

H.R. 6069 FIND Act = Fight Illicit Networks and Detect Trafficking Act introduced June 12, 2018 by Reps. Juan Vargas (D-CA) and Keith Rothfus (R-PA) and referred to the Committee on Financial Services which ordered the bill reported, as amended, by vote of 53 - 0, June 13, 2018, then June 25, 2018, House considered under suspension of the rules.

Bill would require GAO to do a study on how virtual currencies and online market places are used to buy, sell or facilitate the financing of goods or services associated with sex trafficking or drug trafficking. Also to examine how virtual currencies can be used to detect and deter these illicit activities.

Please wear navy BLUE on January 11 in honor of Human Trafficking Day.

Now, more than ever in our history has slavery been more pronounced; globally but also in all 50 of the United States of America! Nationally, Human Trafficking (HT) is second only to DRUGS since 2016 when Guns moved from second to third. Annually, HT is \$150 Billion criminal industry that also can involve drugs and/or alcohol.

While United Nations Association of the USA Kentucky Division has worked on HT for the past 9 years, we have definitely seen HT mushroom as a full blown movement over the past 4 years. UNA-USA KY has involved other NGO's, Louisville Metro Government officials (we were proud that 22 of 26 Metro Council Members supported our HT works), State Government officials, students, professionals and the public bring about awareness, education and advocacy by holding events and conferences.

Again, Dec. 6, 2017, we held a conference (UNA-USA KY's UN Human Rights Program: Human Trafficking and Intersections Exploitations) .with a packed house and had plenty of materials to put in the hands of attendees to continue the wide distribution of the National Human Trafficking Hotline # 1-888-3737-888 and Text 233733 or 'BeFree' (www.polarisproject.org). Each participant received a Universal Declaration of Human Rights Booklet and the new CEDAW = Convention on the Elimination of all forms of Discrimination Against Women booklet, a HT bookmark, a SDG = Sustainable Development Goals bookmark, HT post-it note pad, HT Hotline bumper sticker, #StandUp4HumanRights bumper sticker, green HT pen, orange human rights pen, 3 specially created brochures (1. Human Trafficking in Jefferson County, Kentucky: It's Happening in Our Communities; Labor Trafficking: It Happens in Our Communities; Female Genital Mutilation (FGM), Program outline and flyer plus bio of keynote, data Dec. 2007 to June 2017 for KY's HT Statistics from Polaris since KY ranks 31st out of 100 cities where the national HT hotline # proved to be HT cases; Protected Innocence Challenge for KY's Report Card of 2015 tells classification and fines for HT and other offences; a Selected Reading List procured from our HT Planning Committee members; bio of special guest of honor (Councilwoman Mary C. Woolridge who received the Human Rights Award) and a Questionnaire/Evaluation form.

Instead of going through the array of presentations, attached is the Program Booklet/Pamphlet with each presenter and panelists plus their credentials, topics and a short topic summary.

I'd rather let you know about the important accomplishment post our last year's conference where Marian Hatcher, Chicago Cook County Sheriff's office and coordinator of the ongoing "National John's Suppression Initiative" held a 2016 sting covering 17 states (but KY was not one of these states!) where 1,020 sex buyers were arrested. The good news is that KY has been added and will forever be one of the participating states!

Because we continue to work for changes and action, this year, we will continue to have legislation in the 2018 KY General Assembly. Our keynote this year was attorney Jeanne Smoot with the Tahirih Justice Center who works on child marriage. She helped Virginia in 2016 and Texas in July, 2017 passed a bill that is similar to what has been introduced this January, 2018 KY General Assembly with a provision for emancipation. Yes, this occurs in AMERICA! Yes, it occurs in other countries but most are shocked to hear about "child brides"/child forced marriages in the U.S.A. Children as young as 10 or so are married off to men decades older (sometimes HT can be involved).

We have a House sponsor to carry FGM legislation in KY since 28 states now have laws in place. Due to our conference, another bill is for Trafficking to be a VIOLENT CRIME and traffickers would have to serve 85 % of their sentence. On all of the legislation, we will be doing education to promote awareness and inform the public so they can voice their sentiments.

As AAUW Louisville Branch and KY Public Policy Chair, I am working with AAUW national office and state Senator on a Senate bill to be introduced on pay equity. Additionally, we will be introducing ordinances in support of parity in cities of branches soon. We are working with a State Representative for another equal pay bill.

Right now, the U.S. federal legislation, S.1693 needs your help. This is SESTA = Stop Enabling Sex Traffickers Act. While backpage.com owner, Carl Ferrer, was handcuffed by two state attorney generals and taken to trial, the Judge said that Congress needed to fix the problem. So S1693 is the 'fix' so that 3rd parties engaged in criminal activities can be held accountable under the Communications Decency Act. Please act today to call Washington (1-202-224-3121) to leave a message for Senate Majority Leader Mitch McConnell to push to get S.1693 on the Senate floor for a vote or email or mail to him.
