- **Street Name Change**

CASE SUMMARY/BACKGROUND

The applicant is proposing to rename the recently recorded right-of-way Fisk Court to Fisk Street. The subject right-of-way is within the Beecher Terrace development at the western edge of Downtown Louisville. The right-of-way was recorded 2-19-19 at Plat Book 58, Page 53 and has not yet been constructed.

STAFF FINDING

The request is in order. Per Land Development Code section 6.3.2.D.3, the Planning Commission may waive the public hearing for a street name change if all governmental jurisdictions having authority agree, and no one formally requests that a hearing be held.

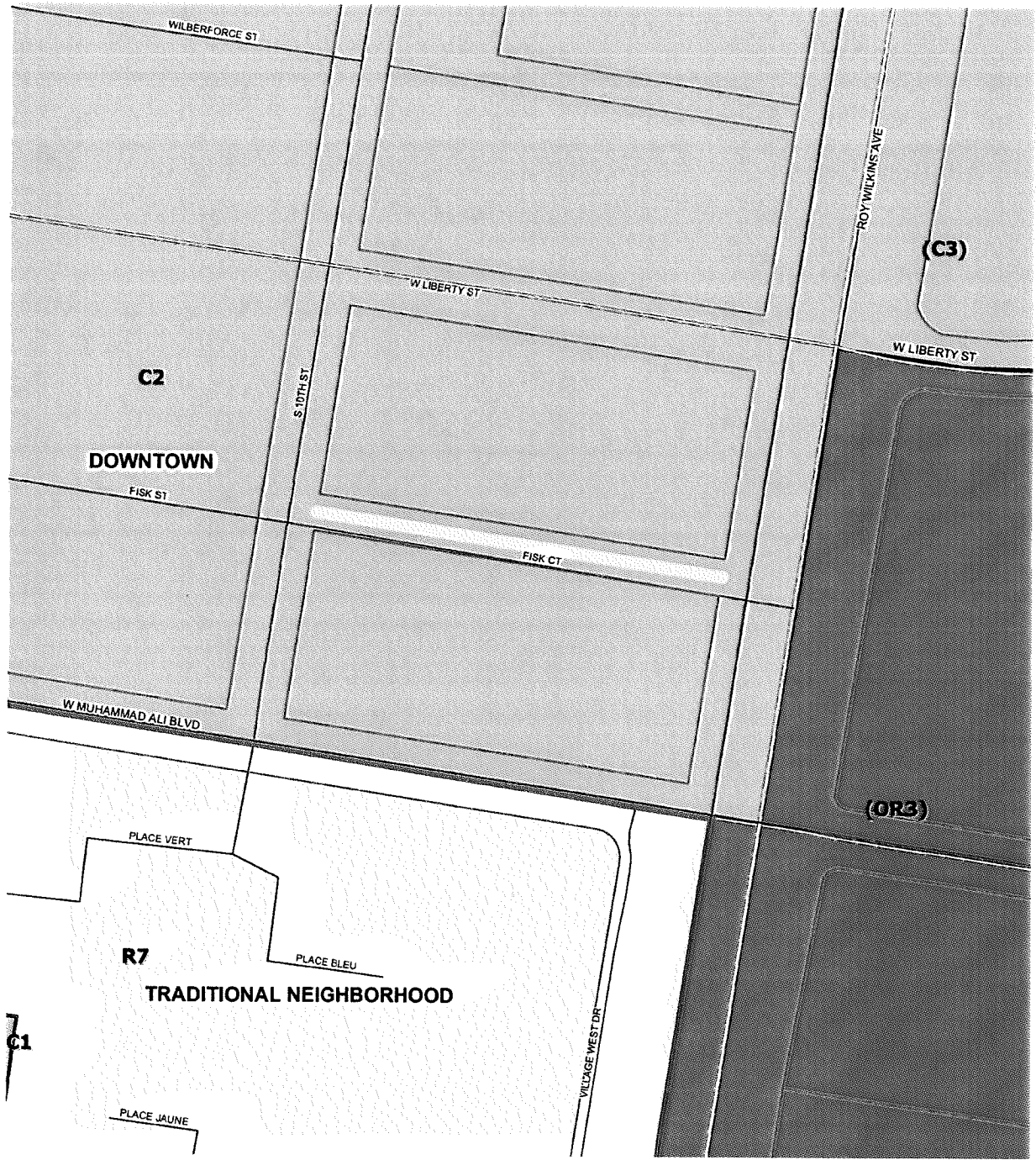
