There is a mural in the 3300 block of Preston Hwy across the street from Audubon Park. Recently, a large graffiti mural several feet high and wide was painted on the decorative mural. We have contacted Rueff Sign Company who did the original mural. They estimate it will take about \$1,500 to remove the graffiti and restore the mural. If Councilman Magre funds this work, will Public Works accept the funds to pay Rueff Sign Company? I anticipate they will need to have an ITPS as they are not a current Metro vendor.
