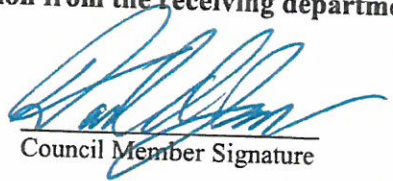

Hi Wanda,

Beth and I looked at these locations today and I have just a few notes.

- ✓ 1. 2527 Garland Ave estimate is below.
2. When we went to Midway and inspected the sidewalk between Maple and the alley we only found a very small section of sidewalk near the alley. Attached is a picture of Midway starting at Maple and you can see that there is no sidewalk here currently and it doesn't look like anyone is walking in the grass here either. If you want an estimate for a new sidewalk, contact Mike Hudson and he'll provide the quote.
- ✓ 3. We couldn't find 2933 S 16<sup>th</sup> St. I believe the road stops at 2033 S 16<sup>th</sup> St, but we did go by 2029 S 16<sup>th</sup> St and saw several sidewalks that need repair. An estimate for those repairs is below.
- ✓ 4. 310 W Kentucky St is the address for a building next to a long parking lot. we took some measurements for the sidewalks that were damaged near the building. If you wanted to repair all of the sidewalk along the parking lot let me know and I'll provide a larger estimate.
5. 7<sup>th</sup> Street between Garland and Brecken ridge, is for a business development. Some concrete repairs have been done here recently. This repair estimate is below.
- ✓ 6. 6<sup>th</sup> St between Hill St and Gaulbert is a long section of sidewalk repairs and almost all of them involve trees. This estimate is below.
