### ENACTING RESOLUTION

**STATUTORY AUTHORITY** KRS 173.105

**ORDINANCE AUTHORITY<sup>1</sup>** LMCO 32.370(D)

**POWERS**

Authority to adopt bylaws. Sole authority to determine the library materials to be purchased and kept by the library; sole authority for the determination of the expenditures from gifts and grants donated to the library; may make recommendations on other activities of the library at the request of the Mayor; contract and be contracted with; sue and be sued; acquire and hold real and personal property; mortgage property; may issue bonds for the purpose of making improvements, repairs, or paying off any indebtedness it may owe.

**REMOVAL**

Serve at pleasure of Mayor per KRS 173.105(2). Shall be immediately removed if member misses three consecutive regular meetings of the Commission, without sufficient excuse accepted by the whole Commission.  
 NOTE: LMCO 32.370(G) A member of the Commission may be removed by the Mayor for cause, after a hearing by the Mayor, and after at least ten days' notice in writing has been given to the member of the Commission, which notice shall embrace the charges preferred against the person. State law supersedes local ordinance.

<b>EX OFFICIO MEMBERS</b>	Vacancies shall be filled by the appointing authority for the unexpired portion of the term.
<b>COMPENSATION</b>	No compensation but shall be reimbursed for necessary expenses incurred in the performance of their duties.

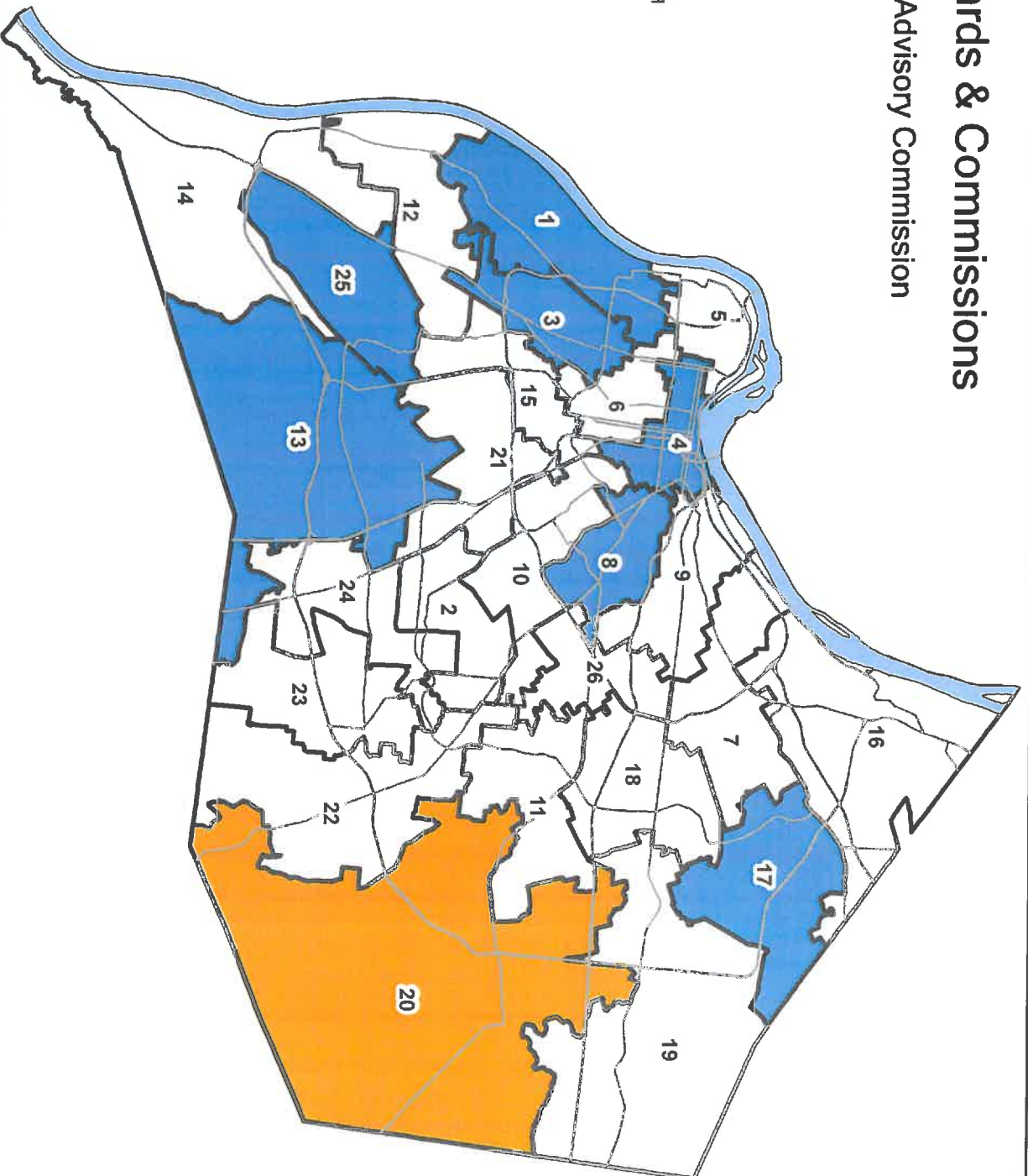
