PRESIDENT KING: Thank you. Please cause the record to reflect that Council Member Woolridge has an excused absence. I believe along with Councilman Johnson has requested one. And Council Member Tandy has an excused tardy.

MR. CLERK: So noted.

PRESIDENT KING: And Council Member Downard has, I think, kind of a little tan going on, so we are not sure where he has been.

Mr. Clerk, are there any addresses to Council?

MR. CLERK: Yes, sir, there are.

PRESIDENT KING: Please bring them forward. Let me remind those addressing the Council to please refrain from using profanity or from making derogatory statements to council members.

PRESIDENT KING: Mark Baridon. Apologize if I didn't get your name right. Come forward, please.

MARK BARIDON: I'm privileged to not only live in the sixth district but serve as pastor of a church in the sixth district. And I am speaking in favor of increasing the minimum wage in the city of Louisville.

Many religious leaders over the years of all kinds, many in the faith community, have spoken on this issue in favor of it. Many of us serve churches and neighborhoods where there are people who just -- the working poor, people who work hard, to have to work all day and then stand in a line to wait for food assistance or other assistance who can't afford decent housing for themselves and their children. I will quote a colleague of mine in the Baptist tradition, Reverend James Perkins, President of the National Baptist Convention, who describes raising the minimum wage as a moral issue. He says people who are opposed to raising the minimum wage are more interested in their economic ideology than providing struggling people with the dignity of work.

Many people in the faith community want to raise the issue. These are the neighbors. Most of us have something is in the religious background that reminds us to love our neighborhood as ourself, and we believe this is one way to do just that. Just days after there were minimum wage victories several years ago in many states, the nation celebrated the groundbreaking for the Martin Luther King Jr. Memorial. The historic occasion reminded us a key demand of the 1963 march on Washington, the "I Have a Dream" address, was a national minimum wage act that will give all Americans a decent standard of living.

It is long past time to fulfill that dream, and I am hoping that the Louisville council will take the brave stand in leading Kentucky and hopefully the country to allow all of our citizens to the dignity to provide for their family. If this is passed, this is another thing we can be proud of in leading the nation for caring for our neighbors.

MR. CLERK: Jeanine Triplett.

JEANINE TRIPLETT: Good evening. At this time I would like to thank Metro Council and President King for giving me the opportunity to speak on behalf of the Center for Women and Families this evening. I'm

here to give you an update on what's been going on with us for the past year.

As you know, we have had a little building issue that we have been challenged with for the past year. Our building's about eight years old, and starting in the fall of 2003 we continued to struggle with what we thought was a few leaks in the roof. We quickly realized that that became a comprehensive issue, that the entire roof was compromised.

As a result of that, we ended up having to close shelter rooms. The goal was to phase out and hopefully stay a part of the building and adapt accordingly. Last March we moved out of it completely because the water damage became so bad there wasn't a part of the center that we didn't have buckets and our large garbage cans collecting water. At that time what was also going on was that water was coming through the walls and compromised our electrical system. We did replace the roof. It is a 70,000 square foot building. We had to remove the HVAC off that and replace it. So that has been our challenge the past year. We have replaced the roof as of last week. We are very excited about that. Demolition has started on the interior.

We are using this opportunity to look at the building, because we do have to replace the walls, carpet, repaint and adapt and take care of the mold issues as a result of that. But we have called this the "lemonade campaign," because we are making lemonade out of lemons. We will be stronger. We are using this opportunity to take the center to the next level. Right now we can't accommodate men. With the changes we will have a center to accommodate domestic assault and violence for women, but also for men. We will also increase the security.

It has been a challenging year, but a lot of good things have come out of it. I am here to thank all of you for the support of Center for Women and Families. The city of Louisville has supported us financially and then individually through your discretionary funds. Several of you all have made gifts to us. We thank you for that. We know that you have a lot of causes that are very important to the city of Louisville, not just the center. So we hope that you will consider a discretionary fund gift one time, if you haven't already. So thank you

again for all you have done to support us. We can't do it without you. Thank you.

MR. CLERK: Jay Dennis.

My name is Jay Dennis. I am a business agent and political organizer for Teamsters Local 89. I come here on behalf of our president, Fred Zuckerman, and the 15,000 members of our union. As an organization, we have a clear mission, to raise the standards for all workers and workers' families within the community. This mission is not simply one of a legal mandate, but a moral imperative. No economic injustice, whether at the hands of unethical employers or out of touch lawmakers, can be tolerated by the union. We will mobilize against any attempt to repress or deny the wages necessary to support a family and sustain some semblance of financial stability. This is why Teamsters Local 89 proudly stands with the workers of this community in demanding an increase in the minimum wage, one more suited to today's economic conditions.

The notion that minimum wage jobs are only occupied by teenagers earning cash, this is simply not the economic reality. Gone are the days in which we had a robust manufacturing base in the country. It has been replaced by low paying service sector jobs which are being occupied by adults, adults with families. Unless you act, most of these families will never see true economic prosperity or the American dream as it has been purposefully placed beyond their reach.

One of the opponents of a fair wage sitting in this chamber cited family, hard work, and education as the key to uplifting oneself out of poverty. The comment is insulting in its naivety. Workers put in hard work. To say they are not working shows blatant disrespect to the workers in our economy. And if we deny the workers the opportunity to support a family, you have no right to put yourself on a pedestal. And education, many of the families are forced to work multiple jobs to feed their families. Education is not an option when you have to choose between feeding your children and paying the rent.

While other government bodies have turned away from those affected by the economic realities, you, Metro Council, have the power to

correct the wrongs. You have an opportunity to impact Louisville Metro families. This is where you show your constituents where your loyalties truly lie. Will you work to uplift the families of the community or will you be beholden to the narrow interests of a few? The Teamsters will stand with the workers. This is not empty rhetoric. This is our promise and our mission. Thank you for your time.

MR. CLERK: Paul Neumann.

PAUL NEUMANN: Good evening. My name is Paul Neumann, and I am the CEO of a company that employs 140 people in Louisville. I have an undergraduate in economics from Queens University, masters of science in Carnegie Mellon. And I will warn you I am about to make an economic argument for the minimum wage, so your eyes can glaze over.

First, the decision has nothing to do with fairness. The economy and life are not fair. Your decision should be based, as my Council Person Kenneth Fleming has said, on the financial impact on our community. An increase over three years in the minimum wage is neither fair nor compassionate. It is a smart economic choice for the city of Louisville.

Second, the critics of this measure are correct. A number of low wage jobs in Louisville will be eliminated if you pass this ordinance. They refer to it as "creative destruction." It is how the economic works as costs change. However, what is also true is that the equivalent or greater number of jobs will be created due to increased economic activity. We all know low income people spend more of their wages, and they spend more of them locally. The multiplier effect of that spending creates more jobs. That is also how the economy works.

Starting in the 1990s multiple studies have shown a neutral or slightly positive effect of localized increases in the minimum wages, despite all the claims you hear to the contrary. A number of those are attached to the back of what I handed out. There are many more. From a business perspective, better wages leads to better workforce and better jobs. As a business, we invest in our employees in a number of ways via training and education. Wages are part of that investment. When our company made the decision in 2006 to increase our wages from 7 to \$8, it

had a tremendous impact on the quality of employees we attracted and an employee's ability to stay employed. We now start at 13.25 an hour. I think Nortons, and U of L, who have made strategic choices at the low end of their wages have had similar experience.

The choice will also send a signal, just like bike lanes or funding the arts, that Louisville is a good choice for young people. We need to compete for mind share with Portland and Nashville and San Francisco. This will help us do that.

Finally, if the financial emphatic statement being prepared properly takes into account the relevant research, it will show clearly this result in a higher wage base for Louisville. It raises revenue without raising taxes, a winning formula for a winning community and a choice every one of you should support. I trust you'll vote with enthusiasm for this ordinance and our extraordinary mayor will then approve it. Thanks for listening.

MR. CLERK: Mr. President, that concludes the addresses to Council.

PRESIDENT KING: Yes.

>> Could we have his remarks?

PRESIDENT KING: I'm sorry. Would you like a copy of the remarks?

>> I thought he said he left them.

PAUL NEUMANN: I left them with the clerk when I came in.

PRESIDENT KING: We will track them down.

PAUL NEUMANN: Thank you.

PRESIDENT KING: Mr. Neumann, will you check with reception before you leave to make sure that at least one copy remained with her? All right. I think that has been handled as well as it can so far.

Next we have a special presentation to each of our departing members. And maybe it would be best if the four departing members, if they are still here in chambers, could possibly come forward. Would you all mind doing that? And I want you to stand Democrat, Republican, Democrat, Republican. Yeah, start on the left. You are on the right. Go

down here a little bit further. Go down here a little further, if you would, so everybody can see you. Here you go. And we have a presentation.

Jess, do you have a presentation that you want to give them? You don't want to do it? I should take them down there? You'll take them. Okay. Then you go right ahead. Keep them straight. See if you can help her. That would be great.

For those that can't see, we are giving out Louisville Sluggers, but we are giving them out as they leave, if you notice, not as they joined us.

>> If you are going to give them bats, should you really have lined them up Democrat, Republican, Democrat, Republican?

PRESIDENT KING: And what I want to say, and then I would like to ask our council members here if they have any comments. And then certainly I would encourage the four of them to maybe take the mic out there if they have any comments as they depart. We would love to hear them.

It has been an honor working with each of you, and we are thankful to know each of you. And as I said earlier, I know you are going on to bigger and better things. The service you have done for the community, city, and country can't be repeated. It takes a lot of time to do what you do. I know you did it with sincerity, you did it with principle, and a lot of time away from family and friends. On my behalf and on behalf of the council, thank you very much for doing that.

[Applause.]

Can you all come up here and take a picture? We would love that, for the four of you to come up. Don't look at my desk. There's a lot of stuff going on here.

[Applause.]

I think Steve Hague led the way on getting the bats for us, so I want to thank him for getting that. And any council member that would like to floor to make any comments, certainly feel free as to. And departing council members, also feel free.

Council Member Hamilton.

COUNCILMEMBER HAMILTON: Thank you, Mr. President.

I was walking over to our reception with Councilwoman Ward-Pugh, and I told her that in my estimation -- and I think I can put it for all four who are departing -- they have been the conscience of their communities and who they represent, the conscience of the constituents, of the council, and our caucus today. Tina reminded us again what a loss we are going to feel by her departure. I feel the same. Each one of you have stood up for principle. And I think you have made the council a better place to work, and you have made this community a better place to live, and I thank you for your service.

PRESIDENT KING: Absolutely. Well, can I tell you that when I first got on the council, I sat right there next to Councilwoman Ward-Pugh. And she looked at my knuckles one time, and I said, "What are you doing?" And she said, "I really think your knuckles drag the ground." And I had so much to learn from her that she finally told me it doesn't appear to be so bloody anymore on the end, so I'm making some progress.

COUNCILWOMAN WARD-PUGH: Walking upright.

PRESIDENT KING: Walking upright. And I thank you for what you have taught me. Honestly, I do. I value that. And we really got a great friendship. Really do. Anyone else? Very good. Thanks to all of you.

We do have some guests tonight. Let's start with Council Members Kramer, Aubrey Welch, Fowler, Butler, and Johnson. I believe you have Metro Technology. You have the floor. Oh, certainly. Metro Technology, please come down.

>> Mr. President, colleagues, to the viewing public, it is our honor to be here tonight to share with you an award that Louisville has received. This is not the first time that we have been before you.

A couple years ago the Digital Cities Survey recognized Louisville for the web design that they had done. And this past year we sent in another example of the great work that is taking place here in Louisville, and this year we were awarded third place in the Digital Cities Survey. And it was for overall technology work that we are doing in the city, not anything specific. They were looking at website design. And we completely redesigned the website since the last award.

And they looked at the way it allows citizens to interface with government through technology. Things that most of us don't really think

about. Some of us don't use parking meters anymore, but all the parking meters in town are set up so you can use your cell phone when you park at the parking meter. And these are the kinds of things the digital folks are doing all the time. We don't realize or recognize what is going on, but folks around the country are paying attention, and they realize that Louisville has got some really impressive things going on with technology. And this year we received, as I said, third place overall, and we beat out cities like Los Angeles. We came in third behind Los Angeles. So we are gunning for them. We are not finished. I think we are right on their heels.

But I just wanted to say how much we really appreciate the work these guys do. It is given out every year in conjunction with the National League of Cities. When I travel to the National League and the ladies next to me were in Austin and we hear from other cities about what is going on in technology in Louisville, we just smile and nod like we know what we are talking about. We come back with the award and the IT people say, man, everybody is talking about us. We must be doing something right.

Council members Welch and Fowler were able to go to Austin and I wasn't able to be there, but I asked them to bring the award back. Here is how it went.

>> We were excited to accept this award on your behalf. It was a stormy, wet night, so it was quite a challenge to get to where we needed to go, but we did it. But to hear the names of the cities we beat out were just phenomenal. We are very proud of you all. Here is your Digital City Survey winner 2014. Third place of 250,000 or more categories. That is a lot of cities. Congratulations.

[Applause.]

And then we decided to take it upon ourselves to make a proclamation from us.

So, Louisville Metro Council, to all whom these letters shall come, greetings. Know ye that the Louisville Metro Council hereby honors and recognizes Metro Technology Services in recognition of receiving the distinction of being a Digital Survey City. And hereby honored and

recognized for outstanding work in earning top ten honors in this year's Digital Cities contest.

Metro Technology services continues to strive to bring about impressive change across all aspects of Metro Louisville by leveraging information technology and technology investments to expand open government, citizen participation, and share services.

And whereas the Center for Digital Government's Digital Cities Survey is conducted annually in the summer, July through August. All United States cities, towns, villages and consolidated city-county governments are invited to participate in the survey. The awards are presented concurrently with the National League of Cities Conference that is held each November.

We hereby confer this honor with all the rights, privileges, and responsibilities thereunto appertaining. In testimony whereof we have caused these letters to be made and the seal of the Louisville Metro Government to be hereunto affixed.

And the four of us, plus Councilman Johnson who couldn't be here tonight, we put our names there as the ones who got it for you. Congratulations.

METRO TECHNOLOGY STAFF: On behalf of Metro Technology, thank you for your support. Thank you all for representing us and representing us well at the ceremony and the dinner and in bringing back the trophies. It is a testament to all the folks we have here in the technology department and all their hard work, and I'm really happy for them they get the recognition they deserve for all of their blood, sweat, and tears they put in to making our city as best it can be from a technology standpoint. It is a real honor to be a part of that team. Just appreciate your support of that and look forward to a first place win next year.

>> There you go.

PRESIDENT KING: Thank you all.

Councilwoman Flood, do you want the floor?

COUNCILWOMAN FLOOD: I do.

PRESIDENT KING: You've got it, since you took it.

COUNCILWOMAN FLOOD: Isn't that just like me?

PRESIDENT KING: It is. No problem.

COUNCILWOMAN FLOOD: Colleagues, tonight I have the distinguished honor and pleasure to present proclamations to one of the finest women I have ever known. She has been the executive vice president of the Louisville Apartment Association for 37 years, but at the end of this year she finally bids farewell to the position. I have known and worked with Gale for the past 36 years, whether it be through property management or legislative process. She has worked tirelessly with local and state officials to make multifamily residential property here what it is today. If you are a member of the association, whether you are an owner, a leasing agent, manager, or a maintenance man, Gale Lively has put on numerous seminars to make sure that people are educated on what their responsibility is to this community as a leasing agent or maintenance man Those are things you don't normally see attached to Gale's name. And when there is legislation that comes up, she has a cool mind when she comes down to discuss how it will affect fair and accessible housing for all, not just in the city of Louisville, but within the state of Kentucky.

Though we have not always been on the same side, I have never, ever, asked for an appointment or asked to speak with a council member that you didn't sit

and listen and vote your conscience. And for that, I am so grateful to each and every one of you. I hope that my job will continue, and the person who replaces me I know will get to know each and every one of you as I have gotten to know you. Thank you for helping make housing in this city more affordable and accessible. Thank you so much.

Colleagues, I do have friends in high places. You are looking at a fine gentleman, a constituent of mine, Micki Bridwell, who played Santa Claus at Light Up Okolona, but what you don't know about Micki is this, and I would like to read the proclamation.

COUNCILWOMAN AUBREY WELCH: Yes. It is 75,000.

PRESIDENT KING: Okay. Very good.

Councilwoman Butler.

COUNCILWOMAN BUTLER: Yes. Thank you, Mr. President.

This is something that I put forward. The food literacy program partners with many schools throughout the community. They are working with Hazelwood School in my area. They got a grant to expand to more schools throughout the area. They go in and teach the children how to garden. They do a garden at school. And they show them they can use raised beds or flower pots to grow food. They don't have to have a big plot of land. They teach them how to grow and cook and eat the vegetables they do grow. It is a wonderful program and it teaches the kids how to be sustainable and do that. So if you are so moved, it would be great if you could add on and help them as they expand their programming to other schools in the community. Thank you.

This is, again, just some more of the changes to our overall Land Development Code. This particular section is a continuation of what we voted on last time, just miscellaneous changes on rules and procedures. And again, for total clarity or transparency, there was an amendment in regards to one section which is on -- I guess the best way to put it is on outside amenities of development such as connecting sidewalks, walking paths, plazas and so on, we have expanded the requirement for those to include industrial complexes, and we have lowered the threshold where those apply from 100,000 square feet aggregate construction to 60,000 square feet aggregate. So they should now be constructed on more developments more often. So that's just the only major or significant change that is above and beyond what the planning commission sent to us. And that would be it, Mr. President.

PRESIDENT KING: Very good. Any further discussion? Hearing none, this is an ordinance requiring a roll call vote.

Mr. Clerk, please open the voting. Without objection, the voting is closing. The voting is closed.

MR. CLERK: There are 23 yes votes and three not voting.

PRESIDENT KING: The ordinance as amended passes.

Mr. Clerk, a reading of Item 44, please.

MR. CLERK: A RESOLUTION PURSUANT TO THE CAPITAL AND OPERATING BUDGET ORDINANCES, APPROVING THE APPROPRIATION TO FUND THE FOLLOWING

PRESIDENT KING: Thank you. The resolution is now before us. Councilman Miller, did this come out of your committee?

COUNCILMAN MILLER: Yes, Mr. President, it did.

It came out unanimously, but we sent it to Old Business in case someone wished to abstain from it due to their employment.

PRESIDENT KING: And were we thinking they would? COUNCILMAN MILLER: Yes.

PRESIDENT KING: Yes. Okay.

COUNCILWOMAN SCOTT: Thank you, Councilman Miller, for that.

Although I would not receive any financial benefit from this contract, I do teach at Jefferson Community and Technical College, so I will be abstaining from this vote.

PRESIDENT KING: Is there any further discussion on this item? Hearing none, this is a resolution allowing a voice vote, but in order to record Councilwoman Scott's abstention, we will use our system for a roll call.

Without objection, the voting is closing. The voting is closed.

MR. CLERK: There are 21 yes votes, one abstention, and four not voting. The one abstention is Councilwoman Scott.

PRESIDENT KING: Thank you. The resolution passes with the one abstention.

Mr. Clerk, a reading of Item 45, please.

MR. CLERK: A RESOLUTION PURSUANT TO THE CAPITAL AND OPERATING BUDGET ORDINANCES APPROVING THE APPROPRIATION TO FUND THE FOLLOWING NONCOMPETITIVELY NEGOTIATED RENEWAL PROFESSIONAL SERVICE CONTRACT - (UNIVERSITY OF LOUISVILLE RESEARCH FOUNDATION, INC., \$125,000.00). Read in full.

PRESIDENT KING: May I have a motion and second for approval, please?

>> So moved.

PRESIDENT KING: Get the second. Thank you.

Councilman Miller, I believe this also came from your committee.

COUNCILMAN MILLER: Yes, Mr. President. This item along with Item 45, 46, 47, 48 all came out unanimously, but since they involve the University of Louisville and since we have two council people who are employees there, we close to put it to Old Business in the belief that one or both may wish to abstain.

PRESIDENT KING: Very good.

COUNCILMAN OWEN: Mr. President.

PRESIDENT KING: Yes.

COUNCILMAN OWEN: In the name of deliberative efficiency, Items 45 through 48 I will be abstaining. My daily employment is with the University of Louisville, and while I will not benefit from any of these contracts directly, for fear of some misperception of conflict, I will be abstaining.

PRESIDENT KING: Very good.

Councilman James, would you like to offer a similar explanation?

COUNCILMAN JAMES: I would like to offer a similar explanation.

I too am employed at the University of Louisville -- go Cards -- and I will do the same and not have an appearance of improprieties or ethical violations, and I will abstaining.

PRESIDENT KING: And that pertains to the next four items?

COUNCILMAN JAMES: Four items. That's correct.

PRESIDENT KING: Very good. So I will not be coming back to you for further explanation on those. We will put it on the record on here and just roll on through them.

COUNCILMAN JAMES: Thank you, Mr. President.

PRESIDENT KING: All right. Have we read 45 into the record yet?

MR. CLERK: Yes.

PRESIDENT KING: And I have a motion and second already on the board for that? Okay.

So is there any further discussion on this item, 45?

Hearing none, this normally would allow a voice vote but we will go ahead and take system votes to allow the abstention to be recorded.

Open the voting.

Councilwoman Parker, did you want to have a recorded vote? COUNCILWOMAN PARKER: Yeah, I did.

PRESIDENT KING: Let's just do that.

COUNCILWOMAN PARKER: It is not recording. Just record me as a "yes."

PRESIDENT KING: Okay. Well, we will record you as a "yes." COUNCILWOMAN PARKER: Yes.

PRESIDENT KING: Okay. Very good. And without objection, the voting is closing. The voting is closed.

Mr. Clerk.

MR. CLERK: There are 20 yes votes, 2 abstentions and 5 not voting. The two abstentions are Council Members James and Owen.

PRESIDENT KING: Is there 4 not voting maybe? 20 and 2.

MR. CLERK: That would be correct, sir. I apologize. 22 and 4.

PRESIDENT KING: 22 and 4. Okay. The resolution passes with the two abstentions.

Mr. Clerk, a reading of Item 46.

PRESIDENT KING: I do have a motion and second for those.

Is there any discussion other than the abstention? Hearing none, we will take this as a system vote to record the abstentions if our system is working. Good. Well, we are going to have to do this by show of hands. Let's just do it by show of hands.

Mr. Clerk, you will just record it by show of hands.

All those in favor of this resolution raise your hand. We will get the gentlemen from 25 and 26 to help us there. Should come out to 20. And we have two abstentions.

MR. CLERK: 20 yes votes.

PRESIDENT KING: You want to look at the two abstentions before you report the vote? To your left, one there and one here.

MR. CLERK: Got it. So we have 20 yes votes, two abstentions, and four not voting. The two abstentions are Council Members James and Owen.

PRESIDENT KING: Very good. The resolution passes with the two abstentions.

MR. CLERK: So noted.

MR. CLERK: I have 20 yes votes, two abstentions and four not voting. The two abstentions are Council Members James and Owen.

MR. CLERK: So noted. 20 yes votes, two abstentions, four not voting. The two abstentions are Council Members James and Owen.

PRESIDENT KING: Thank you.

I believe that brings us to the end of the agenda. Item 49 was moved to Consent earlier.

Is that right?

MR. CLERK: Yes.

PRESIDENT KING: Okay. So thank you for your patience.

Councilman Blackwell, were you seeking recognition? Thank you. Our meeting is adjourned. That does conclude our meeting. And I want to thank our clerks for the good work tonight.
