From 1975 until retiring in 2001, Ms. Berry worked for the Transit Authority of River City (TARC), the public transportation provider for Metro Louisville and surrounding counties. During her diverse career, Glenda last served as Special Assistant to the Executive Director, Affirmative Action Officer (EEO), DBE Liaison Officer, Internal Ombudsman, and acted as a registered lobbyist for the transit system. While working for TARC, she also served the agency as Assistant Director of Planning/Construction Manager, Purchasing Manager, and Assistant Purchasing Agent.
