AN ORDINANCE APPROPRIATING ~~\$29,500~~ ~~\$35,500~~ ~~\$51,000~~ FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$10,500 FROM DISTRICT 12; ~~\$7,000~~ ~~\$7,500~~ FROM DISTRICT 23; \$6,000 FROM DISTRICTS 5, 12, 2; \$4,500 EACH FROM DISTRICTS 4, 12, 11, 3; \$3,000 EACH FROM DISTRICTS 11, 21, 17; \$1,500 FROM DISTRICT 10; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO WALDEN THEATRE CORPORATION, FOR PROGRAMMING EXPENSES ASSOCIATED WITH PERFORMANCES BY THE BLUE APPLE PLAYERS IN LOCAL SCHOOLS (As Amended).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The sum of ~~\$29,500~~ ~~\$35,500~~ ~~\$51,000~~ from Neighborhood Development Funds in the following manner: \$10,500 from District 12; ~~\$7,000~~ ~~\$7,500~~ from District 23; \$6,000 from Districts 5, 12, 2; \$4,500 each from Districts 4, 12, 11, 3; \$3,000 each from Districts 11, 21, 17; \$1,500 from District 10; through the Office of Management and Budget, to Walden Theatre Corporation, for programming expenses associated with performances by the Blue Apple Players in local schools.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
