CASE SUMMARY/BACKGROUND/SITE CONTEXT

The applicant proposes to create three lots from two at the intersection of Whispering Hills Boulevard and Woodrow Way. The plat further amends the Woodrow Manor subdivision (PB 20, PG 36), previously amended by minor subdivision docket 271-04 (12/3/05) which created the existing lot configuration.

TECHNICAL REVIEW

Per section 7.1.91 of the LDC, the Planning Commission shall have the power to amend any recorded plat, if reasonable notice and an opportunity to express objections or concerns have been given to all persons affected by the record plat amendment.

The minor subdivision plat is in order and has received preliminary approvals from Transportation Planning, the Metropolitan Sewer District, and the Highview Fire Department.

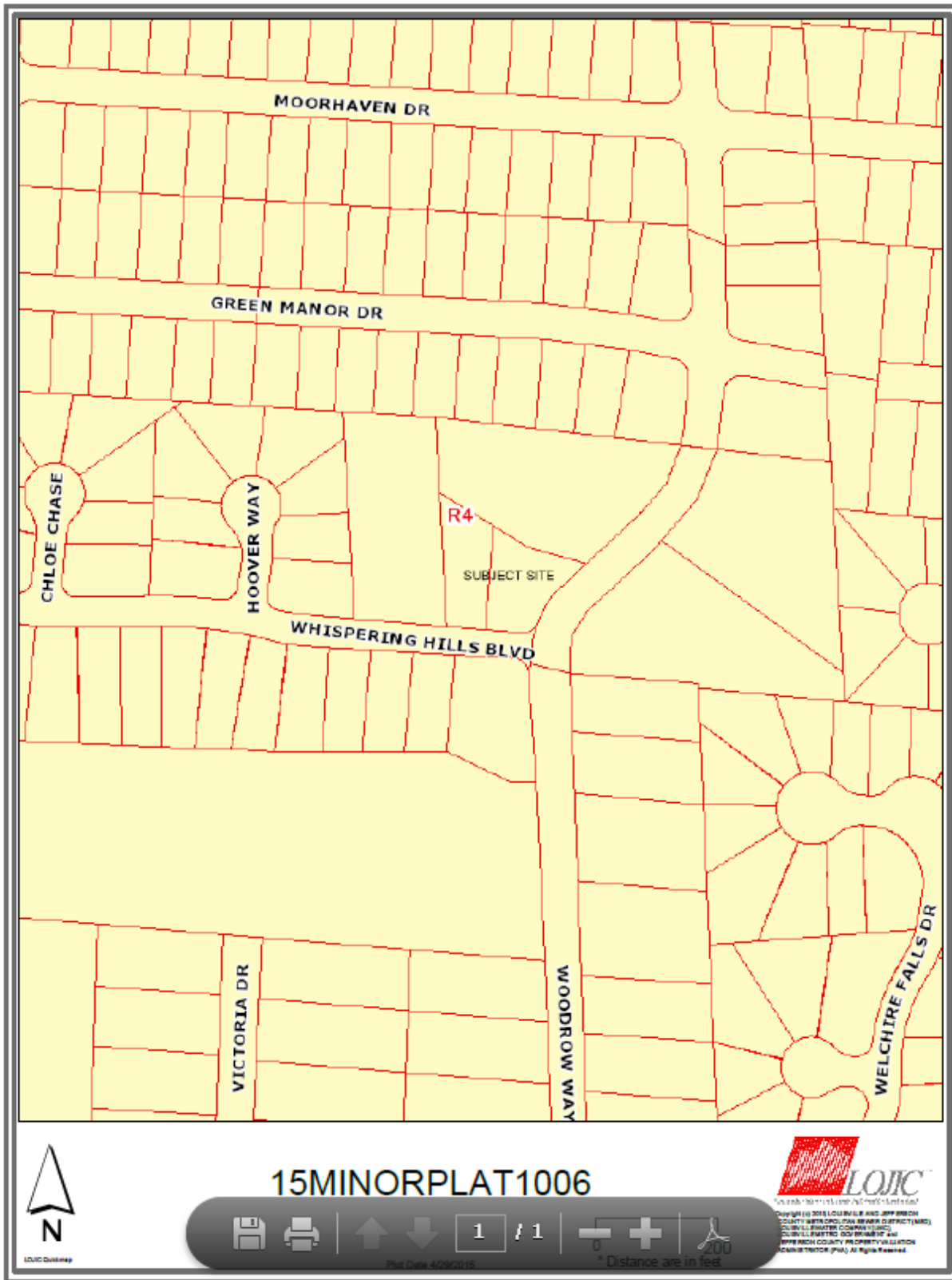
