SUMMARY OF EXPERIENCE:

Primary responsibilities consist of preparation of proposals, completion of investigations; and preparation of reports. Duties include supervision of field and laboratory crews; responsibility for the processing and curation of archives and archaeological materials; complying with NAGPRA. These collections are the second largest in Kentucky.

In 1977, supervised preliminary excavations of an earthen fortress in Meitlica, Poland, under a research grant from the Smithsonian Institute and the Polish government. Directed Cultural Resource Management (CRM) studies involving the survey, testing and mitigation of archaeological sites endangered by State and Federal development. In the early 1980s served as the Project Director for a Research Planning and Protection Process (RP3) of prehistoric sites in the Floyd's Fork drainage and urban historic archaeological sites in Louisville, Kentucky. In 1984, served as Principal Investigator in a RP3 study of regional paleontological and archaeological resources of caves. Since the early 1980s has been extensively involved in archaeological investigations of the caves throughout the southeast US. Since the late 1980s has been involved in numerous archaeological investigations of criminal activities involving cemeteries. Has qualified as an expert witness in Georgia and Kentucky concerning cemetery archaeology.

Has taught several archaeological field schools for the University of Louisville and a Cave Archaeology field school for the Cave and Karst Research Institute of Western Kentucky University. Teaches internships in laboratory methods in archaeology as well as independent studies in skeletal forensics at the University of Louisville. Assists in investigations conducted by the Kentucky State Medical Examiner and the Kentucky Attorney General.

Author or co-author of 80 technical reports, papers and articles resulting from CRM, cemetery, and cave studies in the southeast US. Founding President of the Kentucky Organization of Professional Archaeologists, later served as director. Co-editor and Treasurer of the Proceedings of the Symposium on Ohio Valley Urban and Historic Archaeology, from 1983 to 1988. Active in community and statewide education. In 1997-1998 served as President of the Cave Research Foundation.
