AFFIDAVIT OF WAYNE GALLAVIN

Comes the Affiant, Wayne Gallavin, and after first being duly sworn for his Affidavit, states as follows:

- 1. My name is Wayne Gallavin, and my permanent residence is 2509 Top Hill Road.
- 2. The 2509 Top Hill Road is owned by "2509 TH Land Trust". I filed my primary residence registration as Trustee of the 2509 TH Land Trust.
- 3. The 2509 TH Land Trust is a separate entity and does not own any other property except 2509 Top Hill Road. It has never had another primary residence, nor have I in my capacity as Trustee of the Trust had another primary residence.
- 4. There have been some questions of inconsistencies of primary residence filings which I would like to address. First, 1274 Everett Avenue is owned by All Black Land Trust *204, a separate entity from 2509 TH Land Trust. In 1274 Everett Avenue's primary residence registration, filed on August 18, 2022 and accepted as filed, Leslie Frye was listed as the "Short Term Rental Host". I signed the registration application in my capacity as Trustee of the All Black Land Trust *204. Since I have signed both applications as Trustee for separate Trusts, I do not see an inconsistency with the primary residence registrations. Further, I listed Leslie Frye as the host for 1274 Everett Avenue.
- 5. There have been some questions regarding when I moved into 2509 Top Hill Road. I moved into the property the week of April 10, 2023. I had not completed my move as of the sate of my registration. I changed my voter registration to the Top Hill address as soon as I decided Top Hill would be my primary residence. One of the reasons I did so prior to completing the move was to change my voter registration as soon as possible in case there was an upcoming vote.

6. There are some questions whether I intend to live at the 2509 Top Hill Road for an extended period of time. One of the reasons 2509 Top Hill Road will be my primary residence is my sister and my niece are traveling from New Zealand to live with me. They are moving to the United States in order to assist in my caregiving of my girlfriend, Leslie Frye. Ms. Frye is suffering from a severely debilitating illness, and I cannot, on my own, take care of her. While my sister and my niece live in the United States, they will be living at 2509 Top Hill Road. Also, in order for me to take advantage of the Federal Tax Code, I have to live at 2509 Top Hill Road for a certain period of time.
