01:26:14 Father Bill Bowling spoke in opposition of the petition. Father Bowling briefly reviewed the history of the parish. Father Bowling stated with the decline of finances, the ability to take care of buildings becomes far more challenging. Father Bowling introduced Bruce Hines, Business Manager, to speak in regard to the history of finances and the state of the buildings (see recording for detailed presentation).

01:36:23 Bruce Hines spoke in opposition of the petition. Mr. Hines spoke in regard to Holy Name's finances. Mr. Hines stated in late 2016 he had a meeting with Collin Underhill with Underhill and Associates. Mr. Hines stated he provided Mr. Underhill with a copy of an appraisal that had been obtained by Father David Sanchez who was the prior pastor, in an attempt to try to market the buildings. Mr. Hines stated Mr. Underhill evaluated the properties and indicated that there was absolutely no interest on the part of the investors in Underhill and Associates in assuming any responsibility for either the gym or the school because of their condition and because of the high rates of crime, poverty and drug addiction in the neighborhood. Mr. Hines stated there was some point being made about demolition through neglect, and that is not purposeful. Mr. Hines stated from the period of July, 2015 through August, 2019, Holy Name has spent 218,000 plus dollars in capital improvements. Mr. Hines stated over the last four years, Holy Name has been operating at a \$40,000 deficit, so any neglect in terms of trying to maintain buildings that are no longer serving a useful purpose for Holy Name is certainly not be design, it is out of necessity (see recording for detailed presentation).

01:43:08 Father Bowling spoke. Father Bowling showed a map which indicated where people come from in Louisville Metro. Father Bowling stated in looking to their history of building and tearing down and building again to have structures that fit the ministries that they want to do, they stand in support of the efforts of the Archdiocese to renew their campus to suit the purpose of ministry on the property that they own for the present and for the future (see recording for detailed presentation).

01:50:00 Jon Baker stated what they are looking to accomplish on the campus is removing non-income-producing religious structures and replacing them with another non-income religious structure. Mr. Baker stated the priority on the grounds is the church building, but the church building also needs resources to keep up, so it becomes an effort to allocate resources around the complex so as to maintain buildings, so they completely disagree with the allegations that have been put forth that this is demolition by neglect. stated there is a need for parking on the campus as they move forward (see recording for detailed presentation).

01:52:09 Lisa DeJaco Crutcher, CEO of Catholic Charities, spoke in opposition of the petition. Ms. Crutcher spoke in regard to the mission and ministries of Catholic Charities. Ms. Crutcher stated these buildings are not functional for the work they're trying to do. Ms. Crutcher stated the Holy Name location, however, is excellent for the work they're doing. Ms. Crutcher stated this is a neighborhood with a long history of Roman Catholic presence, and it's important to the church and Catholic Charities Ministry to maintain a presence there. Ms. Crutcher spoke in regard to disrepair of the buildings and the expense of upkeep. Ms. Crutcher spoke in regard to the need for parking (see recording for detailed presentation).

02:10:44 Jon Baker noted objection that they are being deprived of due process if they are not allowed to continue their case in objection to this designation. Mr. Baker introduced Mark Trier (see recording for detailed presentation).

02:12:01 Mark Trier with JRA Architects stated JRA was hired by Catholic Charities to evaluate these buildings in terms of their program and also in terms of renovation costs. Mr. Trier showed a Powerpoint presentation and discussed evaluation criteria. Mr. Trier stated they cannot recommend rehabilitation of these buildings (see recording for detailed presentation).

02:26:32 Jon Baker reviewed legal objections to landmark designation, and introduced Bill Weyland (see recording for detailed presentation).

02:29:34 Bill Weyland spoke in opposition of the petition. Mr. Weyland stated he is an individual who greatly respects the work of preservation. Mr. Weyland stated in his professional capacity he has saved over forty buildings throughout this region that are historic in nature. Mr. Weyland stated he still believes that demolition in some instances is required to really have impactful redevelopment because of the real cost of saving buildings. Mr. Weyland reviewed examples of repurposed buildings. Mr. Weyland stated the Preservation Task Force was very specific that this is exactly the type of situation that we try to avoid; we try to avoid last minute landmarking of buildings that had already been through the other systems of government like zoning (see recording for detailed presentation).
