STATUTORY AUTHORITY

KRS 91 750 - 91 762

ORDINANCE AUTHORITY1

LMCO 160.01 - 160.98

POWERS

The District shall constitute a body oxiderate, with the power to contract and be contracted with:

- (A) The Hourd of Directors of the District shall have the right to backast business on behalf of the District immediately after the appointment of its manufacts.
- (B) The Board of Directors shall have full powers to name its organization and remake bylaws and rules for the regulation and management of the affairs of the District not indonsistent with the provisions of this chapter.
- (C) The Board of Directors shall have all powers necessary and proper to conduct the affairs of the Distinct nonneoresistent with the provisions of this chapter sociating but not limited to.
- (1) Preparing annually an Economic Improvement Plan and budget.
- (2) Implementing the Economic Improvenient Plant
- (3) Making policy for operation of the District.
- (4) Managing the (iscal affairs of the Dismot.
- (5) Incurring in the aggregatic short term and long-term deticin amount not to exceed \$500,000, and
- (6) Such other powers as provided in KRS 91 750 through 91,782.
- (b) The Board of Directors may contract with any person or corporation determined to have the needed expertise to manage and nonlinicity line day-today operations of the affairs of the District.
- (b) The Board of Directors may undertake the following exancing improvements within the District.
- The planning administration and management of development or improvement activities.
- (2) Landscaping, mainlenance; and diraning, of public ways and spaces.
- (3) The promotion of commercial activity or public events:
- (4) The conduct of activities in support of business requirement and development
- (5) The provisions of security to public areas:
- (6) The construction and maintenance of capital improvements to public ways and spaces, and
- (7) Any other according improvement activity that specially benefits property

REMOVAL

Any member of the Board of Directors appointed by the Mayor may be removed by the Mayor for source.


