Conceptually we have no further comment at this time. When David and I last spoke about this project, I apparently misunderstood that the curb & gutter along the south side would be eliminated and the sidewalk moved further away from the road. The sidewalk was indeed moved, but I see that the C&G also remains. I have asked our Central Office folks to verify whether or not Item 10 of the permit application regarding frontage rights would apply in this situation. At this time, I am awaiting response.

As a reminder: when it comes time to develop the roadway construction plans, the work must be done by a prequalified Design firm. At this time, Mindel Scott is not on the list of prequalified roadway design firms. As well, the construction will require a prequalified contractor and third party inspection will have to be done by prequalified engineering firm. The lists for these can be found at these links:
