AN ORDINANCE APPROPRIATING ~~\$5,300~~ ~~\$8,300~~ \$8,850 FROM NEIGHBORHOOD DEVELOPMENT FUNDS (NDF) IN THE FOLLOWING MANNER: \$2,000 FROM DISTRICT 9; \$1,200 FROM DISTRICT 8; \$800 FROM DISTRICT 10; \$750 FROM DISTRICT 14; \$500 EACH FROM DISTRICTS 7, 14, 21, AND 25; \$300 EACH FROM DISTRICTS 2, 5, 12, 13, AND 15, AND 17; AND \$250 EACH FROM DISTRICTS 4 AND 6; \$200 FROM DISTRICT 3; AND \$100 FROM DISTRICT 1; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO THE LOUISVILLE INDEPENDENT BUSINESS ALLIANCE, INC. FOR OPERATING EXPENSES ASSOCIATED WITH THE NINTH (9<sup>TH</sup>) ANNUAL BUY LOCAL FAIR. (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

**SECTION I:** The total of ~~5,300~~ ~~\$8,300~~ \$8,850 is hereby appropriated from Neighborhood Development Funds (NDF) in the following manner: \$2,000 from District 9; \$1,200 from District 8; \$800 from District 10; \$750 from District 14; \$500 each from Districts 7, 14, 21, and 25; \$300 each from Districts 2, 5, 12, 13, and 15, and 17; and \$250 each from Districts 4 and 6; \$200 from District 3; and \$100 from District 1; through the Office of Management and Budget, to the Louisville Independent Business Alliance, Inc. for programming expenses associated with the Ninth (9<sup>th</sup>) Annual Buy Local Fair to be held at the Louisville Water Tower Park.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
