My name is Connie Marshall. My website is www.justiceforallcitizens.com. My email address is conniecmarshall@gmail.com My topic is "2nd Division, Police and Corruption."

Recently Major Harper of the 2nd division in which I do live was given your support regarding corruption he exposed within the Louisville Metro Police. I am requesting the same support, as I have been begging you for assistance for the past five years and beyond.

The following is a brief synopsis of crimes committed against me by the Louisville Metro Police Dept and the videos and audios of some of the crimes in progress are posted on my website and You Tube.

I have received thirty Hate/Sexual Degradation/Death Threats calling me the N word, telling me orders have come down to kill me, stating my grandson Dazia would be put on a list or shot up with drugs. The name Dazia is an odd name yet they mentioned him by name in the email.

I photograped 114 pieces of mail sent to my address over the past five years in the name of Elizabeth Fields a corrupt prosecutor in the case in which I was set up by the Louisville Metro Police. All of the mail is in the name of Elizabeth Fields and some include LMPD, Commonwealth, Jefferson County Attorneys Office and Jefferson County.

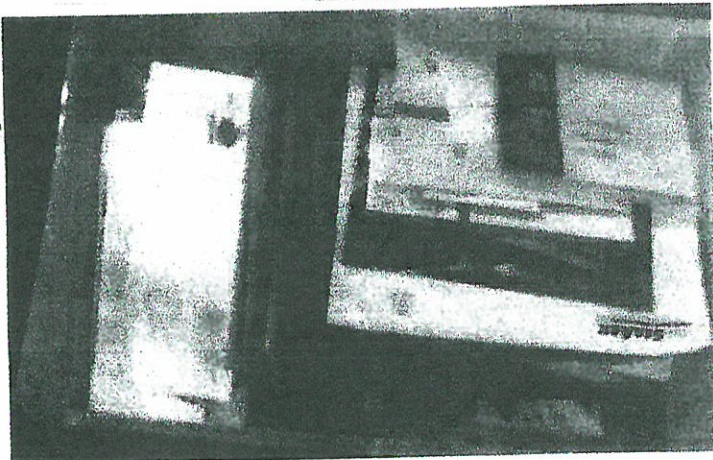
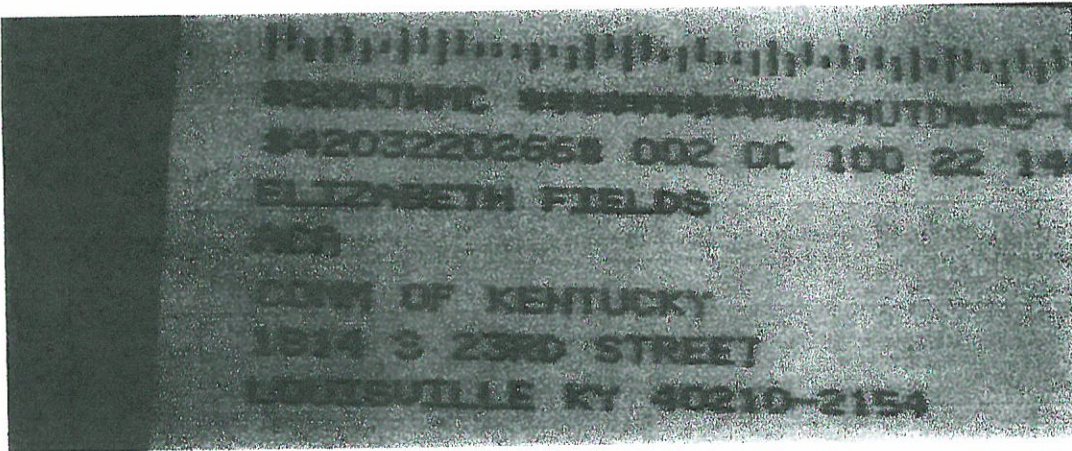
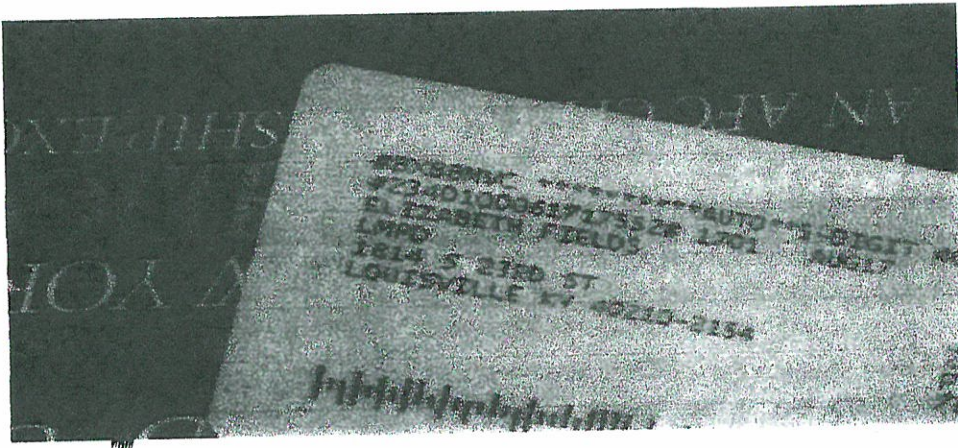
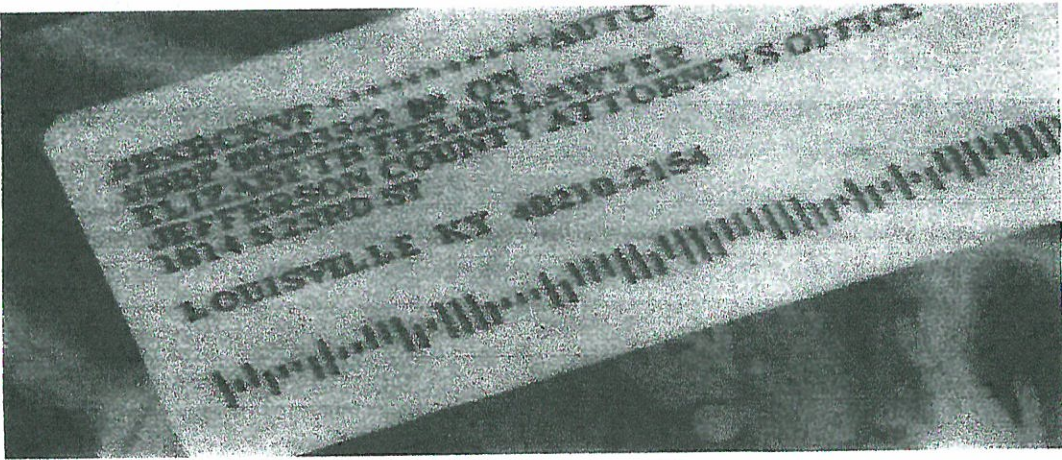
Mail, Emails and calls are intercepted. Seven fabricated/forged pleadings have been filed in the courts with my signature. One in the US Court of Judge Hale and five in the Ky Supreme Court of Judge Minton. In these pleadings they have accused Judge Minton of performing oral sex on a 12 year old girl, accused Judge Hale of taking bribes and accused Judge Hughes of being a hardened lesbian infatuated with me. Another document was filed in the District court of Judge Sean Delahanty,

I am stalked and the police admitted in an email that they sent the white man that tried to break into my home while I was in the bath tub.

July 9, 2016 a Fabricated/forged email was sent to Tim Melton – Manager at LG&E threatening to kill him. Tim Melton and David Milay of Louisville Gas & Electric colluded with the Police to produce this document. A false report was filed by Detective Jeremy Livers whom I have never met and the police came to my home ready to drag me out based on this forged email. I made some calls and this criminal act by the police was thwarted.

On the morning of **June 20, 2016** I put Malone Staffing on the docket for lying to unemployment which I did eventually get. That same night the Police were banging on my door accusing me of sending an email to Malone Staffing. I requested a copy but a Lieutenant stated they do not have a copy. Question: How can they accuse me of sending something they don't have.

Detective Boerste was assigned in **May 2018 to investigate** Report #80-17-096771 regarding David Milay and Tim Melton of LG&E & Torey Malone and her father of Malone Staffing and they should have been cited for filing False reports, however Detective Boerste has refused to investigate.
