**AN ORDINANCE APPROPRIATING ~~\$9,750~~ \$13,750 FROM DISTRICT NEIGHBORHOOD DEVELOPMENT FUNDS AS FOLLOWS: \$3,000 FROM DISTRICT 25; \$2,500 FROM DISTRICT 14; \$1,000 EACH FROM DISTRICTS 4, 12, 13, 15, 21 AND 24; \$500 EACH FROM DISTRICTS 2, 7, 22 AND 26; \$250 FROM DISTRICT 10, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO SHIRLEY'S WAY, INC. FOR EXPENSES ASSOCIATED WITH THE SHIRLEY'S WAY FINANCIAL ASSISTANCE PROGRAM (AS AMENDED)**

**BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:**

**SECTION I:** The sum of ~~\$9,750~~ \$13,750 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,000 from District 25; \$2,500 from District 14; \$1,000 each from Districts 4, 12, 13, 15, 21 and 24; \$500 each from Districts 2, 7, 22 and 26, \$250 from District 10, through the Office of Management and Budget, to Shirley's Way, Inc. for expenses associated with the Shirley's Way Financial Assistance program.


**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

**SECTION IV:** This Ordinance shall take effect upon its passage and approval.
