AN ORDINANCE AMENDING ORDINANCE NO. 087, SERIES 2021 RELATING TO THE FISCAL YEAR 2021-22 OPERATING BUDGET, FOR THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT BY APPROPRIATING \$388,000 FROM THE AMERICAN RESCUE PLAN ("ARP") LOCAL FISCAL RECOVERY FUNDING TO THE DEPARTMENT OF CODES AND REGULATIONS FOR ADDITIONAL STAFF TO HELP ENSURE COMPLIANCE WITH LIQUOR LICENSE REQUIREMENTS AND PROVIDE CAPACITY TO INVESTIGATE ALLEGATIONS OF LICENSE VIOLATIONS.

**WHEREAS**, there are currently 1,371 active liquor licenses in Jefferson County;

WHEREAS, there are currently eight Alcoholic Beverage Control officers working for Louisville Metro government;

WHEREAS, the lack of staffing makes it difficult for ABC to enforce licensing requirements, investigate allegations of license violations, and provide proactive training to establishments; and

**WHEREAS**, additional ABC staff would help ensure compliance with liquor license requirements and provide capacity to investigate allegations of license violations.

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT ("COUNCIL") AS FOLLOWS:
