AN ORDINANCE APPROPRIATING ~~\$5,500~~ ~~\$6,500~~ \$16,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$3,000 FROM DISTRICT 12; \$1,500 EACH FROM DISTRICTS 14, 15, 17, AND 25; ~~AND \$500 EACH FROM DISTRICTS 1, 2, 3, 7, 9, 10, 13, 14, AND 17, 19, 20, AND 21, 22, AND 24~~; AND \$250 EACH FROM DISTRICTS 5, 6, 8, AND 23; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO HARBOR HOUSE OF LOUISVILLE, INC. TO HELP PAY FOR THE 17TH ANNUAL KENDUCKY DERBY FUNDRAISER (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$5,500~~ ~~\$6,500~~ \$16,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$3,000 from District 12; \$1,500 each from Districts 14, 15, 17, and 25; ~~and \$500 each from Districts 1, 2, 3, 7, 9, 10, 13, 14, and 17, 19, 20, and 21, 22, and 24~~; and \$250 each from Districts 5, 6, 8, and 23; through the Office of Management and Budget, to Harbor House of Louisville, Inc. to help pay for the 17th Annual KenDucky Derby fundraiser.

SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

SECTION IV: This Ordinance shall take effect upon its passage and approval.
