

STORMWATER POLLUTION PREVENTION PLAN NOTE:

1. THE APPROVED STORMWATER POLLUTION PREVENTION PLAN (SWPPP) SHALL BE ADHERED TO PRIOR TO ANY LAND-DISTURBING ACTIVITY ON THE CONSTRUCTION SITE. ANY MODIFICATION TO THE SWPPP MUST BE REVIEWED AND APPROVED BY THE METRO PUBLIC WORKS DEPARTMENT PRIOR TO IMPLEMENTATION.
2. DETENTION BASINS, IF APPLICABLE, SHALL BE CONSTRUCTED FIRST AND SHALL PERFORM AS SEDIMENT BASINS DURING CONSTRUCTION UNTIL THE CONTRIBUTING DRAINAGE AREAS ARE SEEDS AND STABILIZED.
3. ACTIONS MUST BE TAKEN TO MINIMIZE THE TRACKING OF MUD AND SOIL FROM CONSTRUCTION AREAS ONTO PUBLIC ROADWAYS. SOIL TRACKED ONTO THE ROADWAY SHALL BE REMOVED IMMEDIATELY.
4. SOIL STOCKPILES SHALL BE LOCATED AWAY FROM STREAMS, PONDS, SWALES, AND CATCH BASINS. STOCKPILES SHALL BE SEEDS, MULCHED, AND ADEQUATELY CONTAINED THROUGH THE USE OF SILT FENCE.
5. ALL STREAM CROSSINGS MUST UTILIZE LOW-WATER CROSSING STRUCTURES PER MSD STANDARD DRAWING 61-02-00.
6. SEEDING-LANDS GRASS COVERED ENCOUNTERED DURING TRENCHING, BORING OR OTHER EROSION CONTROL ACTIVITIES SHALL BE RESEEDS WITH SEEDS TRAPPING DEVICES PRIOR TO BEING DISCHARGED INTO A STREAM, POND, SWALE OR CATCH BASIN.
7. WHERE CONSTRUCTION OR LAND DISTURBING ACTIVITY WILL BE TEMPORARILY CEASED ON ANY PORTION OF A SITE, TEMPORARY SITE STABILIZATION MEASURES SHALL BE REQUIRED AS SOON AS PRACTICABLE, BUT NO LATER THAN 14 DAYS AFTER THE ACTIVITY HAS CEASED.
8. PUBLIC WORKS AND KTC NOTES:
9. NO LANDSCAPING OR CONSTRUCTION SIGNS SHALL BE PERMITTED IN STATE AND METRO WORKS RIGHT-OF-WAY.
10. RIGHT-OF-WAY EROSION BY SEED OR MINOR PLANT MUST BE REQUIRED PRIOR TO SITE CONSTRUCTION APPROVED BY PUBLIC WORKS OR WITH ASSOCIATED RECORD PLAT AS REQUIRED BY METRO PUBLIC WORKS.
11. ALL STREET EROSIONS AND EROSION INTERSECTIONS SHALL MEET THE REQUIREMENTS FOR LANDING AREAS AS REQUIRED BY METRO PUBLIC WORKS.
12. COMPATIBLE UTILITY LINES (ELECTRIC, PHONE, CABLE) SHALL BE PLACED IN A COMMON TRENCH UNLESS OTHERWISE REQUIRED BY APPROVED AGENCIES.
13. STREET TREES SHALL BE PLANTED IN A MANNER THAT DOES NOT AFFECT PUBLIC SAFETY AND MAINTAIN PROPER SITE DISTANCE. FINAL LOCATION WILL BE DETERMINED DURING CONSTRUCTION APPROVAL PROCESS.
14. AN ENVIRONMENTAL PERMIT AND BOND MAY BE REQUIRED BY METRO PUBLIC WORKS FOR ROADWAY REPAIRS ON ALL SURROUNDING ACCESS ROADS TO THE SITE DUE TO DAMAGES CAUSED BY CONSTRUCTION TRAFFIC ACTIVITIES.
15. ALL STREET TRAFFIC SIGNS AND PAVEMENT MARKINGS SHALL CONFORM TO THE MANUAL ON UNIFORM TRAFFIC CONTROL DEVICES (MUTCD) REQUIREMENTS AND BE INSTALLED PRIOR TO CONSTRUCTION OF THE PROJECT.
16. THE MINIMUM GRADE OF ALL STREETS SHALL BE ONE (1%) PERCENT AND A MAXIMUM GRADE OF TEN (10%) PERCENT UNLESS APPROVED BY DIRECTOR OF PUBLIC WORKS.
17. THE OWNER IS RESPONSIBLE FOR ANY UTILITY LOCATIONS ON THE PROPERTY.
18. ALL CUL-DE-SACS AND ROADWAY PAVEMENT WORKS, EXCEPT SIDEWALK LOCATIONS AND OFFSETS SHALL BE IN ACCORDANCE WITH METRO PUBLIC WORKS STANDARDS AND APPROVED AT THE TIME OF CONSTRUCTION.
19. CURBS AND GUTTERS SHALL BE PROVIDED ALONG ALL STREETS REQUIRED BY 5.8 OF THE LAND DEVELOPMENT CODE.
20. TREES AND SHROUBS SHALL BE TRIMMED OR REMOVED TO PROVIDE SITE DISTANCE.
21. ALL SIDEWALKS SHALL CONFORM TO A.D.A. STANDARD SPECIFICATION FOR THE SPECIAL NOTE FOR DETECTABLE WARNING FOR SIDEWALK RAMP PER KTC STANDARD DRAWING FOR SIDEWALKS AND PER KTC STANDARD SPECIFICATIONS FOR ROAD AND BRIDGE CONSTRUCTION, LATEST EDITION.
22. ACCESS FROM STREET TO LOT/AL STREET OR ON 409-106-02 PLAN TO BROAD RUN PARKWAY SHALL REMAIN A LATED EMERGENCY ACCESS ONLY UNLESS OTHERWISE APPROVED BY METRO COUNCIL AFTER A PUBLIC HEARING AT PLANNING.
23. THE APPLICANT SHALL INSTALL SIGNS APPROVED BY THE METRO PUBLIC WORKS DEPT. 4. DRAINAGE/STORMWATER DETENTION:
5. DEVELOPER SHALL USE A COMBINATION OF LOW IMPACT DEVELOPMENT PRACTICES, BIO-ENGINEERING FEATURES, STRUCTURAL DEVICES AND PRACTICES TO REDUCE ENVIRONMENTAL IMPACTS. ANY SETBACK VOLUMES WITH THESE DEVICES SHALL BE APPLIED TOWARDS MSD'S STORMWATER DETENTION REQUIREMENT VOLUME TO OFFSET REGIONAL FACILITY FEES. THESE FEATURES AND DEVICES MAY BE MODIFIED AS EACH SECTION IS DEVELOPED AND APPROVED BY MSD TO MAKE THE BEST USE OF IMPROVED TECHNOLOGIES.
6. EROSION AND SILT CONTROL:
7. A SOL AND SEDIMENTATION CONTROL PLAN SHALL BE DEVELOPED AND IMPLEMENTED IN ACCORDANCE WITH MSD AND THE USDA NATURAL RESOURCES CONSERVATION SERVICE RECOMMENDATIONS.
8. A PORTION OF THE SUBJECT PROPERTY LIES WITHIN A FLOOD HAZARD AREA PER FEMA'S FIRM MAPPING (211101032E, 211101032E, 211101032E, 211101032E).
9. THE FINAL DESIGN OF THIS PROJECT MUST MEET ALL MSW WATER QUALITY DESIGN PHASE DUE TO PROPER ZONING OF GREEN BEST MANAGEMENT PRACTICES.
10. A GEOTECHNICAL EVALUATION SHALL BE PERFORMED BY A GEOTECHNICAL ENGINEER PRIOR TO ANY MITIGATION OF EXISTING SHIMHOLES AND THE APPROPRIATE DETAILS FOR RECONSTRUCTION SHALL BE NOTED ON THE CONSTRUCTION PLANS.
11. AREAS ALONG OLD MARIAN ROAD ARE IDENTIFIED AS POTENTIAL WATER QUALITY AND DETENTION COMPENSATION AREAS.
12. ALL NECESSARY RIGHTS FOR UTILITY PURPOSES SHALL BE RESERVED ON OPEN SPACE LOTS.
13. A PERMIT FOR MINOR RECONSTRUCTION SHALL BE REQUIRED PRIOR TO ANY CONSTRUCTION.
14. IF SITE HAS THRU DRAINAGE AN EASEMENT PLAT SHALL BE REQUIRED PRIOR TO ANY CONSTRUCTION.
15. IF REQUESTED AT THE TIME OF CONSTRUCTION AND SANITARY DRAINAGE ARE BEING PERMITTED, LANDLORDS SANITARY PIPES MAY BE REQUIRED IN AREAS FROM TO HIGH WATER TABLES TO PREVENT I & L.
