CM Blackwell supports the paving plan that Public Works has identified for District 12 for the next three fiscal years, with one caveat. He wants Upper Hunters Trace needs to be incorporated – we know that the current paving ratings only have a few sections under the 65 rating threshold, however, it is the street that we get the most calls regarding its condition. Increased traffic in recent years, potholes, and crushed curbs have left the roadway bumpy to drive in many places. CM Blackwell requests that this roadway be re-examined and incorporated into the 3 year plan. We would rather see Upper Hunters Trace in the plan that Winstead Drive.
