SPECIAL DISCUSSION:

WINTER GOLF MAINTENANCE GOALS

DEFERRED MAINTENANCE PRIORITIES – DANA KASLER

Chair Person Fowler introduced Margaret Brosko and Dana Kasler, Metro Parks.

The following was discussed:

- There were several questions were asked regarding the chain of responsibility for winter golf maintenance.
- Margaret Brosko is the Assistant Director of Metro Parks; Nathan Maywald, Golf Administrator, and Mike Ginder, Turf Supervisor, report to Margaret Brosko.
- Each golf course has a respective Superintendent that oversees the daily operations.
- There were several questions regarding the process for coordinating the winter maintenance operations with the golf course pros and Metro Parks golf staff.
- Margaret Brosko stated that her staff has bi-annual goal setting strategy meetings to discuss maintenance, operations, and deadlines for particular divisions and each respective team.
- Each team meets with the golf pros bi-monthly to discuss desired goals, improvements and set deadlines for achievement.
- There were several questions regarding the current status of goals for each golf course.
- An update was given on the current progress and areas for improvement for golf courses overall such as overall equipment maintenance, repainting areas where needed, cutting brush/limbs and maintaining turf/greens.
- There was a discussion regarding the overall updates currently underway in the winter months throughout all the golf courses and particularly Shawnee golf course.
- There was a discussion on deferred maintenance in the golf courses specifically safety items and major system projects.
- There were several questions regarding whether all the golf courses are on track for winter maintenance, and the golf courses are on track with their goals at this time.
- There were several questions regarding course fees and Metro Parks general fund dollars.
