

I got 2 numbers from our paving contractor to remedy the situation. Putting a bandaide on the problem, which is just patching with hot mix asphalt is about \$6k. To do it right, which involves removing the bad asphalt down to the subgrade in the worst spots is about \$15.5k. The larger number would take care of almost 500 feet of the Park road. I will try to call you in the morning to talk about this in more detail.
