>> PRESIDENT JAMES: ALSO, COUNCIL MEMBER COAN, SHANKLIN, REED, PURVIS HAVE EXCUSED ABSENCES.

>> PRESIDENT JAMES: AND COUNCILMAN BLACKWELL WILL BE HERE SHORTLY.

>> CLERK: SO NOTED.

>> PRESIDENT JAMES: COUNCILMAN MULVIHILL, WILL YOU PLEASE COME TAKE THE CHAIR? ALL RIGHT, COLLEAGUES, I DON'T THINK ANYONE HERE STANDING WITH ME IS A STRANGER TO ANY OF YOU ALL. THIS IS GLI THAT IS HERE WITH ME AND KENT OYLER AS THE CEO. TODAY IS A SPECIAL RECOGNITION FOR GLI. AS YOU KNOW, EARLIER THIS SUMMER, RIGHT, THIS SUMMER, GLI WAS NAMED THE BEST CHAMBER OF COMMERCE IN OUR COUNTRY, SO WE WANT TO TAKE THE TIME TO RECOGNIZE GLI, WITH YOUR LEADERSHIP FOR ALL THE WORK THAT YOU DO IN THE COMMUNITY, AND WE HAVE A SPECIAL PROCLAMATION FOR YOU. FIRST, I'LL GIVE IT TO YOU, THEN I'LL READ IT, SO ANYBODY KNOWS WHAT IT SAYS. TO WHOM THESE LETTERS SHALL COME GREETINGS, KNOW THE LOUISVILLE METRO COUNCIL RECOGNIZES GREATER LOUISVILLE INC., GLI, WHERE AS GLI WAS VOTED CHAMBER OF THE YEAR IN 2007 HONORING ITS WORK AS LEADING BOTH IN BUSINESS AND COMMUNITY SERVICE. AND WHEREAS IN MAY OF 2018, GLI WAS NAMED ONE OF THE TOP THREE METRO CHAMBERS IN THE NATION BY THE ASSOCIATION OF CHAMBER OF COMMERCE EXECUTIVES, AND WHEREAS IN JULY 2019, GLI WAS AWARDED THE CHAMBER OF THE YEAR FOR LARGE CHAMBERS OF COMMERCE BY THE

>> YEAH, THANK YOU. [APPLAUSE]

>> PRESIDENT JAMES: WITH THAT SAID, TURN IT OVER TO YOU TO SAY A FEW WORDS.

>> I'LL KEEP IT BRIEF. THANK YOU, PRESIDENT JAMES AND COUNCIL FOR THIS RECOGNITION. WE'RE HONORED TO BE HERE TODAY. WE'RE OVER HERE OFTEN, AND I KNOW OUR STAFF MEETS WITH YOU ON A VARIETY OF ISSUES, AND WE REALLY APPRECIATE THE PARTNERSHIP WE HAVE WITH THE COUNCIL. CARLA IS OUR CFO, SARAH IS OUR COO AND CHIEF OF STAFF, AND DEANNA IS OUR CHIEF OF ECONOMIC DEVELOPMENT. PART OF OUR LEADERSHIP TEAM, WE HAVE 35 PROFESSIONALS WORKING ON

A FULL-TIME BASIS OVER AT 614 MAIN TO HELP ADVANCE THE ECONOMIC GROWTH OF OUR CITY. SO I KNOW OUR CITY LOVES NATIONAL CHAMPIONSHIPS. WE HAVE BUILT OVER THE LAST FIVE YEARS A WINNING TEAM. IF YOU DO RECALL WHEN WE GO BACK TO KIND OF THE DARKER DAYS OF 2014, WE WERE A CHAMBER IN DISTRESS, THOUGHT ABOUT SUNSETTING THE CHAMBER AND RESTARTING IT, BECAUSE WE WERE IN THAT SITUATION, LOSING MONEY, LOSING MEMBERSHIP. THIS TEAM HAS HELPED REBUILD THE CHAMBER TO THE POINT LAST YEAR WE WERE A RUNNER-UP FOR THE NATIONAL CHAMPIONSHIP AS FAR AS CHAMBERS GO, AND THIS YEAR WE WERE, AS PRESIDENT JAMES SAID, NATIONAL CHAMPIONS FOR THAT. AND I WANT TO PRESENT YOU, THE REAL TROPHY IS BIGGER, BUT THIS IS A REPLICA OF THE TROPHY THAT THEY GAVE US WHEN WE WERE OUT IN LONG BEACH FOR THE NATIONAL CONVENTION FOR THE AWARD. SO THANK YOU VERY MUCH FOR THE SPONSORSHIP. WE REALLY APPRECIATE IT. THIS IS A, TRULY, A TEAM EFFORT AND THIS GROUP HAS COME A VERY LONG WAY. WE'RE HONORED ALSO TO HAVE PRESIDENT JAMES ON OUR BOARD AS EX OFFICIO ON OUR BOARD AS PRESIDENT OF THE CHAMBER, SO APPRECIATE THAT AND YOUR ENGAGEMENT AND INVOLVEMENT HERE. LIKE I SAID, HOPE THAT HAT DOES NOT MESS UP YOUR HAIR. THANK YOU VERY MUCH. [APPLAUSE]

>> PRESIDENT JAMES: I THINK YOU HAVE SOME SPECIAL GUESTS.

>> IT IS MY PLEASURE TO WELCOME THE LOUISVILLE MEMBERS OF THE JACK AND JILL OF AMERICA, INCORPORATED. JACK AND JILL OF AMERICA WAS FOUNDED FOR MOTHERS COMMITTED TO PROVIDE SOCIAL,

CULTURAL, AND EDUCATIONAL OPPORTUNITIES TO NURTURE FUTURE AFRICAN-AMERICAN LEADERS BY STRENGTHENING CHILDREN THROUGH LEADERSHIP DEVELOPMENT, VOLUNTEER SERVICE, PHILANTHROPIC GIVING, AND CIVIC DUTY. TODAY, THERE ARE MORE THAN 245 CHAPTERS REPRESENTING MORE THAN 40,000 FAMILIES. ANNUAL PROGRAMS, THROUGH ANNUAL PROGRAMMING AND SERVICE PROJECTS, AND SO THESE YOUNG PEOPLE WHO ARE STANDING RIGHT NEXT TO ME, THEY ARE IN THE MIDST OF LEARNING ABOUT CIVIC ENGAGEMENT. THEY ARE SOME OF THE MOST INQUISITIVE AND BRIGHT YOUNG PEOPLE THAT I HAVE EVER MET. THEY HAVE WONDERFUL QUESTIONS, THEY WERE VERY ENGAGED, THEY WERE INTERESTED IN THE MICROPHONES, SO WE'RE NOT AFRAID OF ASKING QUESTIONS AND BEING INVOLVED. I GREW UP IN JACK AND JILL OF AMERICA WITH MY MOM, SO IT DOES BRING FOND MEMORIES BACK TO SEE THESE KIDS AS THEY ARE ON THE CIVIC ENGAGEMENT QUEST AND LEARNING AS PER THE CHARTER OF THE ORGANIZATION, SO, AGAIN, I WOULD LIKE TO FORMALLY WELCOME AND RECOGNIZE THEM FOR BEING HERE WITH THEIR MOMS, WHO ARE A PART OF THIS PROCESS AND BIGGEST SUPPORTERS, SO I DO HAVE A PROCLAMATION. LOUISVILLE METRO COUNCIL, TO ALL WHOM THESE LETTERS SHALL COME. GREETINGS, KNOW YEE THE LOUISVILLE METRO GOVERNMENT HEREBY HONORS AND AWARDS JACK AND JILL OF AMERICA, INCORPORATED, LOUISVILLE CHAPTER, AN ORGANIZATION FORMED BY AFRICAN-AMERICAN MOTHERS WITH THE IDEA OF BRINGING TOGETHER CHILDREN OF SOCIAL AND CULTURAL ENVIRONMENT AND TO NURTURE FUTURE LEADERS. WE HEREBY CONFER THIS HONOR WITH

ALL OF THE RIGHTS, PRIVILEGES, AND RESPONSIBILITIES THEREUNTO APPERTAINING AND TESTIMONY WHEREOF WE HAVE CAUSED THESE LETTERS TO BE MADE AND THE SEAL OF THE METRO GOVERNMENT TO BE HEREUNTO AFFIXED, DONE IN THE COMMONWEALTH OF KENTUCKY THIS 24TH DAY OF OCTOBER, 2019, JESSICA GREEN, FIRST DISTRICT COUNCILWOMAN.

WELCOME, GUYS, AND YOU ARE FREE TO STAY FOR AS LONG AS YOU WANT TO DURING THE MEETING. I KNOW YOU HAVE SCHOOL TOMORROW, SO YOU WILL TIP OUT AT SOME POINT, BUT WE JUST WANT TO RECOGNIZE YOU, WELCOME YOU GUYS FOR BEING HERE, AND THE FUTURE IS SO BRIGHT WITH EACH OF YOU ALL AT THE FOREFRONT AS LEADERS OF OUR COMMUNITY AND OF THIS NATION. SO WE LOVE YOU, AND WE'RE EXCITED TO WELCOME YOU. TURN AROUND, CAN WE GET A COUPLE MORE -- COME ON, STEP UP SO WE CAN GET A PICTURE. [APPLAUSE]

>> PRESIDENT JAMES: THANK YOU, COUNCILWOMAN. MR. CLERK, ARE THERE ANY ADDRESSES TO THE COUNCIL?

>> CLERK: YES, SIR.

>> PRESIDENT JAMES: PLEASE REFRAIN FROM MAKING DEROGATORY STATEMENTS TO COUNCIL MEMBERS.

>> CLERK: NANCY TIERNEY. NANCY TIERNEY. ISAAC MACKIN.

>> TIME START WHEN I START? GOOD AFTERNOON, METRO COUNCIL. MY NAME'S ISAAC MACKIN, I'M 20 YEARS OLD, AND I STUDY POLITICAL SCIENCE AT THE UNIVERSITY OF LOUISVILLE. AS A MEMBER OF DISTRICT 27, THIS IS A VERY PERSONAL ISSUE TO ME. I'M HERE TODAY IN OPPOSITION OF THE LOUISVILLE TREE ORDINANCE, NOT BECAUSE I HATE

TREES, BUT BECAUSE OF THE SIMPLE FACT WE CANNOT AFFORD DELAYS IN LEGISLATION WHEN IT COMES TO OUR CURRENT CLIMATE CRISIS.

LOUISVILLE'S THE FASTEST GROWING URBAN HEAT ISLAND IN THE NATION, WHICH IS A REALLY FANCY WAY OF SAYING IT IS 12 DEGREES HOTTER DOWNTOWN DURING THE DAY THAN IT IS ELSEWHERE IN OUR CITY. THAT'S CRAZY. THIS, IN COMBINATION WITH THE OHIO VALLEY FAIR AIR QUALITY IS A DEADLY COMBINATION TO SOME OF OUR RESIDENTS, ESPECIALLY THOSE OF COLOR. TO CLARIFY, THIS IS A VERY CLEAR EXAMPLE OF ENVIRONMENTAL RACISM IN OUR CITY OF LOUISVILLE, AND THAT MUST BE CHANGED IMMEDIATELY. ON THE 20TH OF SEPTEMBER, MAYOR FISCHER DECLARED THE CITY OF LOUISVILLE IS IN A CLIMATE CRISIS, AND I'M THANKFUL FOR THAT MAN. THIS IS A STEP TO ENSURE WE PASS MORE LAWS FOR THE ISSUES IMPORTANT TO OUR CITY. ONE OF THOSE ORDINANCES I'D LIKE TO DISCUSS IS THE LOUISVILLE TREE ORDINANCE. IF WE WERE TO IMPLEMENT THIS ORDINANCE TODAY, WE WOULD BE PUTTING UP A HACK JOB, INADEQUATE ATTEMPT TO SAVE OUR RESIDENTS FROM DRASTIC CLIMATE EFFECTS THAT ARE GOING TO COME IN THE NEAR FUTURE. I'M NOT TALKING OUR GRANDCHILDREN'S LIFETIME. I AM TALKING IN END YEARS. THIS ORDINANCE IS NOT ENOUGH, AND IT WILL BE SELLING MY GENERATION'S FUTURE TO GREEDY DEVELOPERS WHO NEED LOBBYISTS, SUITS, AND TIES TO MAKE SURE THEY CAN KILL AS MANY TREES AS POSSIBLE JUST TO MAKE A QUICK BUCK. WE DON'T HAVE TO DO THAT. ARE YOU GOING TO ALLOW THEM TO DO THAT? PLEASE, COUNCIL PEOPLE, I KNOW WE'RE FROM DIFFERENT GENERATIONS, BUT I

LIKE TO BREATHE JUST AS MUCH AS YOU DO. IF YOU ARE WILLING TO LISTEN TO PEOPLE LIKE ME AND MY FRIENDS THAT CARE ABOUT THE CITY INSTEAD OF THOSE THAT WANT TO POLLUTE IT AT A COST OF HUMAN LIVES, WE'LL BE REWARDED WITH A MORE SAFER, VIBRANT CITY WITHIN YEARS. IF WE PASS THIS TREE ORDINANCE AS-IS, WITH NO OTHER CLIMATE LEGISLATION TO GO ALONG WITH IT OR AFTER IT, WE ARE SAYING SAVING ONLY 20% OF TREES ON NEWLY DEVELOPED PROPERTY IS OKAY ENOUGH TO OFFSET THE 54,000 TREES WE LOSE ANNUALLY, EVERY SINGLE YEAR. YOU ARE SAYING 20% IS ENOUGH TO POSITIVELY IMPACT THE URBAN HEAT ISLAND THAT PLAGUES OUR CITY, WHICH CREATES A DEADLY ENVIRONMENT FOR COMMUNITIES OF COLOR AND EVERYONE ELSE IN THIS CITY. IF WE PASS THIS RIGHT NOW, YOU ARE SAYING WE HAVE ENOUGH TREES AND OUR AIR QUALITY IS GREAT ENOUGH TO PAY A FINE INSTEAD OF KEEPING SAID TREES ON DEVELOPED PROPERTY. IF YOU PASS THIS, YOU'RE SAYING DUPONT, LG & E IS MORE IMPORTANT THAN THE 12 YEARS DISPARITY OF LIFE EXPECTANCY IN OUR CITY THAT EXISTS FROM THE EAST TO THE WEST. IT IS IMPERATIVE TO MOVE FORWARD WITH INTEGRITY. NO COMPANY SHOULD BE ABLE TO DESTROY LIVES OF CITIZENS WITH SMOG AND MAKING A CHECK AT THE END OF THE DAY. NO ONE WANTS TO LOOK AT THEIR GRANDCHILDREN IN THE EYES AND SAY YOU CHOSE TO WORK WITH SHADY BUSINESSMEN. COUNCILMEN AND COUNCILWOMEN, I AM NOT HERE TODAY TO DERATE YOU. I AM HERE TO INSPIRE YOU. I KNOW YOU CAN DO THIS. I BELIEVE IN YOU GUYS. I

KNOW YOU CAME HERE TODAY BECAUSE YOU CARE ABOUT OUR CITY AND YOU WANT TO MAKE A CHANGE.

>> SIR?

>> YES?

>> YOUR TIME'S OVER.

>> OKAY. WE NEED TO COME TOGETHER, LESSEN THE EFFECTS OF THE URBAN HEAT ISLAND AND CLIMATE CRISIS BEFORE ANY MORE DEATHS IMPACT OUR CITY. THANK YOU FOR YOUR TIME. [APPLAUSE]

>> CLERK: JEFFREY SCOTT O'NEIL.

>> GOOD EVENING, EVERYBODY. I AM JEFFREY SCOTT O'NEIL, AND THIS IS MY FIRST TIME HERE. I HAVE BEEN IN POLITICS IN ALBANY, NEW YORK, WASHINGTON, I AM A CITIZEN OF KENTUCKY, AND A PROPERTY OWNER IN THE CITY OF LOUISVILLE. IN MY RETIREMENT YEARS, I HAVE COMMITTED MYSELF TO BENEVOLENT AND CHARITABLE ACTIVITIES. ONE OF THE FIRST THINGS I WAS INTRODUCED TO WAS SHORTAGE OF FOOD. AND I DEVELOPED A CHARITY, WE CALL IT ACTS OF KINDNESS, OUR OFFICIAL TITLE REGISTERED IN FRANKFORT IS OF METRO LOUISVILLE. IF YOU HAVE A DOCUMENT THAT LOOKS LIKE THIS, YOU'LL SEE A PROGRAM IDENTIFIED AS "DARE TO DELIVER," AND THAT WAS INSTITUTED BY ME AND VOLUNTEERS TO TAKE EMERGENCY BASKETS OF FOOD TO NONAMBULATORIES, SHUT-INS, A MOTHER THAT'S OFF THE BUS ROUTE WITH THREE KIDS AND CAN'T GET THE BOX HOME. WE'VE BEEN DOING THAT FOR ABOUT 15 YEARS. WE'RE TRYING TO PROVIDE VANS DRIVEN BY VOLUNTEERS TO ACCOMPLISH THIS END. TODAY, I'M HERE TO TELL YOU

ABOUT SOMETHING THAT'S A TRAGEDY. MONDAY THROUGH FRIDAY, THERE ARE NO FOOD PANTRIES OPEN IN THE DARE TO CARE FOOTPRINT AFTER 4:00 TO 5:00 P.M., MONDAY THROUGH FRIDAY, MOTHER CALLS ME AT 3:00, WE CAN'T GET HER A BASKET. OVER THE 15 YEARS, ABSOLUTELY NONE ON SATURDAY OR SUNDAY. SO I BEGAN TO PUT MY THINKING HAT ON AND I CANVASSED PERSONALLY TEN OR 15 FIRE STATIONS. I SPOKE TO THE FIRST RESPONDERS. THEIR DNA AND WHAT THEY ARE ALL ABOUT IS TO HELP PEOPLE. COULD WE PUT A COUPLE OF SEALED BOXES IN THE CORNER AND AFTER 4:00 OR 5:00, COULD THEY RING THE BELL AND GET A BASKET OF FOOD? MOTHER WORKS 9:00 TO 5:00, CAN'T BE THERE, IT'S CLOSED. GUY WORKS 3:00 TO 11:00, DOESN'T GET A PAYCHECK FOR TWO WEEKS, THERE'S SOUP, STEW, SOMETHING FOR HIM TO EAT. NOW, THE PARAMETERS OF THE PROGRAM, THE PRAGMATICS OF THE OPERATION, THE SAFETY OF THE EMPLOYEES AND THE FACILITY ARE CERTAINLY OF PARAMOUNT IMPORTANCE, BUT I THINK WE CAN DO SOMETHING ABOUT IT. I THINK IT'S PRETTY PLAIN AND SIMPLE. I PUT THE PROPOSAL ON PAGE TWO, YOU'LL SEE A LETTER TO MAYOR FISCHER, AND IT SAYS SIMPLY THIS -- "ACTS OF KINDNESS IS A GRASSROOTS PROGRAM FOR NEARLY 15 YEARS. DEMOGRAPHICS INDICATE INDIVIDUALS WITHOUT PERSONAL TRANSPORTATION ARE HIGHEST IN OUR NATION AND OUR COMMUNITY FACE HUNGER. NONAMBULATORY, WALKERS, WHEELCHAIRS, SHUT-INS ALSO NEED BASKETS DELIVERED. IT'S IMPOSSIBLE TO FIND BASKETS 4:00 TO 5:00 P.M. MONDAY THROUGH FRIDAY AND SATURDAY THROUGH SUNDAY. SO THE FIRE STATIONS FELT IT WAS FEASIBLE. IT'S ON THE DESK OF THE

MAYOR, AND NOW I PLACE IT INTO YOUR LAPS. AND NOW I PLACE IT INTO YOUR HEARTS. INTO YOUR MINDS. YOU GUYS ARE A WONDERFUL GROUP OF CIVIC-MINDED INDIVIDUALS. YOU WORK HARD ALL DAY. YOU COME HERE, LOUISVILLE'S A GREAT CITY. I'VE MOVED HERE. I'M GOING TO RETIRE HERE. I MIGHT BE BURIED HERE. WE HAVE A GREAT CHARITABLE AND BENEVOLENT HEART IN THIS CITY. I REALLY THINK WE CAN DO SOMETHING ABOUT IT. THERE'S ANOTHER PROGRAM THAT WILL TEACH KIDS BASIC HUMAN VALUES OR AMERICAN VALUES CALLED BIKES FOR BOYS AND GIRLS. I'VE SEEN KIDS RIDING ON THE RIMS IN THE WEST END. THIS WILL GIVE KIDS FROM 4 TO 14 TO EARN A BIKE BY DOING COMMUNITY SERVICE. YOU WORK SO MANY HOURS, YOU EARN A BIKE. HOW DO WE GET OUR CAR? HAVE TO EARN IT. PAYCHECK, RENT, UTILITIES, INSURANCE, SO ON AND SO FORTH. WORKING WITH DIFFERENT GENDERS, DIFFERENT RACES, DIFFERENT CULTURES, DIFFERENT LANGUAGES, AND CLEANING UP A PARK TOGETHER, AND WHEN THEY ARE DONE, WE GET OUR JOB DONE, IF WE'RE WORKING FOR GE, WE GOT A REFRIGERATOR, TWO WEEKS LATER, WE GET A PAYCHECK.

>> MR. O'NEIL?

>> I'M NOT GOING TO TALK ABOUT THE SPECIFICS, BUT I'LL LAY IT IN YOUR LAP, THIS PROPOSAL, THANKS FOR YOUR TIME. [APPLAUSE]

>> CLERK: JOSHUA BRUMLEVE.

>> COUNCIL, I AM HERE TO SPEAK AGAINST THE TREE ORDINANCE CURRENTLY BEING DISCUSSED BY THE PLANNING AND ZONING COMMITTEE.

FRANKLY, THIS ORDINANCE IS A FARCE, A TOOTHLESS DOCUMENT WHICH SERVES NO PURPOSE OTHER THAN TO ALLOW YOU ALL TO GO HOME, PAT YOURSELVES ON THE BACK, AND SAY THAT YOU TRIED. SAY THAT YOU TRIED WHILE CONTINUING TO IGNORE THE FACT THAT WE ARE IN THE MIDST OF A CRISIS, A CRISIS THAT IS GROWING WORSE DAY BY DAY, AND IS CONTINUED TO MAKE WORSE BY THESE PAST MEASURES. MY CRITICISMS OF THIS LEGISLATION CONSIST OF THE FOLLOWING.

PRIMARILY, THE 20% TREE CANOPY POLICY IS NOT ENOUGH, NOT NEARLY ENOUGH. CLIMATE EXPERTS AGREE THAT WE MUST BE DOING OUR ABSOLUTE BEST TO PRESERVE OUR EXISTING TREE CANOPY, AND I KNOW THAT 20% IS CERTAINLY NOT OUR BEST. MIND YOU, ONCE AGAIN, WE ARE IN THE MIDST OF A CRISIS, AND THIS PATHETIC, LAZY, 20% FIGURE DOES NOT RESPECT THE GRAVITY OF THIS CRISIS. NEXT, THE 20% CANOPY RETAINMENT FIGURE WAS NOT BAD ENOUGH ALREADY, THIS ORDINANCE ALLOWS DEVELOPERS TO DESTROY EVEN MORE TREES AS LONG AS THEY PLAY A PALTRY FEE AND WRITE A NOTE SAYING THAT THEY ARE SORRY. ULTIMATELY, THIS AMOUNTS TO LITTLE MORE THAN BRIBERY AS IT ALLOWS THE LARGEST AND WEALTHIEST DEVELOPERS TO FLOUT REGULATIONS AND SIMPLY DO AS THEY PLEASE. THIS WILL RESULT IN EVEN FURTHER DESTRUCTION OF OUR TREE CANOPY AND OUR ENVIRONMENT IN THE NAME OF PROFIT AND AT THE EXPENSE OF OUR FELLOW LOUISVILLIANS. FURTHER, THIS ORDINANCE MAKES NO ATTEMPT TO ADDRESS THE ALREADY ABHORRENT INEQUALITY ALREADY EXISTING WITHIN OUR CURRENT TREE CANOPY, AN INEQUALITY THAT MIMICS THE DEEP

SEPARATIONS ALREADY INHERENT TO THIS CITY ALONG ETHNIC, RACIAL, AND ECONOMIC LINES. MANY OF THE NEIGHBORHOODS IN THE MOST DANGER BY OUR RAPIDLY INTENSIFYING URBAN HEAT ISLAND WILL SEE THE SMALLEST AMOUNT OF RELIEF FROM THE POLICIES PROPOSED BY THIS LEGISLATION. THE RISING TEMPERATURES, COMBINED WITH THE ALREADY ABYSMAL AIR QUALITY IN RUBBERTOWN AND SIMILAR NEIGHBORHOODS, WILL HAVE AND ARE ALREADY HAVING DEVASTATING EFFECTS ON THE HEALTH OF MANY COMMUNITY MEMBERS IN THESE NEIGHBORHOODS. BEFORE US WE HAVE AN OPPORTUNITY TO BEGIN A PROCESS OF RESTORATIVE JUSTICE FOR OUR COMMUNITIES OF COLOR HERE IN LOUISVILLE THROUGH COMBATTING ENVIRONMENTAL RACISM, AND THIS LEGISLATION PROVIDES NO LANGUAGE IMPLEMENTING ANYTHING OF THE SORT. FOR THESE REASONS, I'M OPPOSED TO THE LEGISLATION AND MUST URGE YOU ALL TO FIX THESE ISSUES BEFORE MOVING FURTHER ON IT. [APPLAUSE]

>> CLERK: PEDRO SANCHEZ-VILLA.

>> HELLO, I'M PEDRO SANCHEZ-VILLA, 22-YEAR-OLD SENIOR AT THE UNIVERSITY OF LOUISVILLE. FIRST, I WANT TO THANK ALL OF YOU ALL FOR THE OPPORTUNITY TO BE ABLE TO SPEAK. SOME OF THE MORE SENIOR MEMBERS MIGHT REMEMBER ME FROM A COUPLE YEARS AGO FROM WHEN I INTERNEED WITH THEN-DAVID JAMES BEFORE HE WAS PRESIDENT. BUT I AM TODAY SPEAKING TO YOU NOT AS AN INTERN, BUT AS A CONCERNED CITIZEN. THIS TREE ORDINANCE IN FRONT OF YOU AT THE PLANNING AND ZONING COMMISSION IS AN OPPORTUNITY FOR THE CITY OF LOUISVILLE TO GROW. NOT GOING TO LIE TO YOU ALL, THIS IS NOT A

SOLUTION TO THE CLIMATE CRISIS WE FACE, BUT THIS ALLOWS OUR CITY TO MOVE FORWARD IN A NEW AGE OF URBAN PLANNING. MORE AND MORE CITIZENS THROUGHOUT THE NATION ARE SAYING HOW GREEN A CITY IS ARE ONE OF THE MAIN DECIDING FACTORS WHETHER THEY WANT TO LIVE THERE OR NOT. BEING ABLE TO PASS THIS ORDINANCE GIVES US THE OPPORTUNITY TO BE ON THE FOREFRONT OF A COMING CHANGE THAT IS GOING TO HAPPEN THROUGHOUT ALL CITIES ACROSS THE NATION. FACT, IT CURRENTLY TAKES HALF A BILLION DOLLARS TO REPLANT THE TREES THAT HAVE BEEN RAZED AND DESTROYED BY DEVELOPMENT. THAT'S JUST TOUCHING UPON THAT INITIAL DEVELOPMENT COST. THAT DOESN'T ACCOUNT FOR THE POLLUTION COSTS AND THE AIR QUALITY THAT'S DIMINISHED. SECONDLY, EVERY TREE APPRAISED ADDS ABOUT \$1,000 TO \$10,000 WORTH OF PROPERTY VALUE. THIS IS A NO-BRAINER TO THE COUNCIL, TO BE ABLE TO ADD INDEFINITE PROPERTY VALUE AND SAVE HALF A BILLION IMMEDIATELY JUST BY PASSING SOMETHING SO SIMPLE. 20% OF TREE CANOPY TO BE PRESERVED IS NOT GOING TO CHALLENGE URBAN DEVELOPERS WHO COME INTO OUR CITY. IT'S NOT GOING TO STOP THEM FROM BEING ABLE TO DEVELOP, AND AS I'VE SAID BEFORE, THERE'S A NEW WAVE OF URBAN PLANNING COMING. LOUISVILLE NEEDS TO STOP BEING BEHIND THE TIMES, DOES NOT NEED TO PLAY CATCH-UP. WE NEED TO BE ON THE FOREFRONT. VOTING YES FOR THIS ORDINANCE, YOU ARE SAYING NO TO SHORT-TERM PROFITS BUT YES TO WHAT THE CITY CAN AND WILL ACHIEVE. THANK YOU.

>> CLERK: DANIEL COBBLE.

>> THIS IS MY THIRD ARTICLE I PETITION CHARGING TEN
ADDITIONAL TREASON COMMITTED BY PRESIDENT TRUMP, WHICH I HAVE
WARNED ABOUT. I WAS GOING TO SHOW HOW GOVERNMENT IS -- BUT TRUMP
IS A MORE IMMEDIATE CRISIS. REGARDING THE WARNING, NANCY PELOSI
IS SENDING THE NATION DOWN ANOTHER RABBIT HOLE IN THE UKRAINE
SCANDAL. TRUMP AND GIULIANI COULD NOT HAVE COMMITTED A QUID PRO
QUO WITH THE UKRAINE EVIDENCE BECAUSE THE ALLEGATIONS ON THE

CLAUSE FOUR ON CLIMATE CHANGE IS PROBABLY THE MOST GLARING

REASON TO REMOVE TRUMP FROM OFFICE. PLEASE SEE MY FLYER TO BEGIN WEEKLY RALLIES FOR REMOVING TRUMP, STARTING TOMORROW. YOUR DONATIONS ARE NEEDED. FOR THE CLIMATE ACTIVISTS, YOU'RE GOING TO HAVE TO DO MORE THAN PROTEST. YOU HAVE TO RESEARCH AND PRESENT PLANS FOR CHANGING OUR BEHAVIORS THAT'S CAUSING CLIMATE CHANGE, SUCH AS MY BOOK HERE ON HEALTH CARE THAT ADDRESSES THE HEALTH CARE CRISIS. THANK YOU. [APPLAUSE]

>> CLERK: PETER ROLFE.

>> GOOD EVENING. ONE OF MY GROUP MEMBERS HAS PREVIOUSLY SPOKEN ABOUT THE BENEFITS OF INSTALLING ANAEROBIC DIGESTERS TO SERVICE THE METRO AREA. SO I'M HERE TO FILL IN SOME MORE OF THE DETAILS AND JUST TO REITERATE, AN ANAEROBIC DIGESTER CREATES RENEWABLE ENERGY AND LESS HARMFUL CO₂. IF AN ANAEROBIC DIGESTER WERE TO BE INSTALLED IN PROXIMITY TO THE LANDFILL, IT CAN BE FILLED WITH OTHERWISE USEFUL BIOWASTE SUCH AS YARD CLIPPINGS, LEAVES, OR FOOD WASTE. IF MULTIPLE ANAEROBIC DIGESTERS WERE INSTALLED, WE COULD EASILY MEET OUR 90% LANDFILL RATE AND HELP TO REDUCE THE AMOUNT OF THINGS BACKING UP THE LANDFILLS. BUT NOT TO MENTION IT ALSO HAS A POSSIBILITY OF CREATING NEW JOBS, INSERTING THE UPKEEP AND MAINTENANCE OF SUCH A SYSTEM. CONSIDERING THAT GE HAS ALREADY UTILIZED OTHERWISE DISCARDED METHANE FROM THE LANDFILL AND NEARBY APPLIANCE PARK VIA A PIPELINE, THE VIABILITY AND USEFULNESS HAS BEEN PROVEN AND THE POTENTIAL FOR EXPANSION AND USE FOR FUTURE APPLICATIONS IS

PROMISING. I'M AWARE OF THE ISSUES OF THE GREEN NEW DEAL POSING TO LOUISVILLE, ESPECIALLY CONCERNING ARE ABANDONED ASSETS IN THE FORM OF OUR POSSIBLE UNUSED NATURAL GAS INFRASTRUCTURE, BUT IF NECESSARY, THIS INFRASTRUCTURE COULD BE ADAPTED TO ACCEPT AND MAKE USE OF METHANE. IN THE NEAR FUTURE, WE CAN EVEN HAVE A METHANE-BURNING POWER PLANT, WHICH IF FED BY ANAEROBIC DIGESTERS WOULD BE CARBON-NEUTRAL. IN PREVIOUS YEARS, A SIMILAR IDEA WAS SCRAPPED DUE TO THE PROXIMITY TO HOUSES, AND AN ORDINANCE WAS CREATED TO KEEP ANAEROBIC DIGESTERS AWAY FROM HOUSING AREAS. CONSIDERING THAT THERE ARE NO HOUSES NEAR A LANDFILL, IT WOULD MAKE AN IDEAL LOCATION FOR AN ANAEROBIC DIGESTER. NOT TO MENTION ITS PROXIMITY TO ITS REQUIRED BIOWASTE. LOUISVILLE AS A CITY CAN GREATLY BENEFIT FROM THE ASSETS AN ANAEROBIC DIGESTION FACILITY WOULD BRING, ESPECIALLY BECAUSE OF OUR EXISTING INDUSTRY AND POSSIBLE APPLICATIONS OF THIS RESOURCE. THERE'S MUCH POSSIBILITY FOR GROWTH, ALL WHILE PAVING THE WAY TO A SUSTAINABLE FUTURE FOR LOUISVILLE. LASTLY, THE MAYOR DECLARED A CLIMATE EMERGENCY, AND AS A CITY, WE HAVE A RESPONSIBILITY NOT ONLY TO HOLD TRUE TO OUR COMMITMENTS, BUT ALSO A RESPONSIBILITY TO TRY TO CARE FOR OUR ENVIRONMENT. A RESPONSIBILITY THAT I WOULD LIKE LOUISVILLE TO CONSIDER MORE AS WE GROW AS A CITY. AND AN ANAEROBIC DIGESTER WOULD BE A STEP IN THE RIGHT DIRECTION. THANK YOU. [APPLAUSE]

>> CLERK: DR. FRANCE WEINSTOCK.

>> HELLO, MY NAME IS DR. FRANCIS WEINSTOCK. I'VE BEEN A FAMILY PHYSICIAN FOR THE PAST 36 YEARS IN LOUISVILLE. I WISH TO ADDRESS THE ISSUE OF SIDEWALK SAFETY, BOTH AS A PHYSICIAN AND A CITIZEN OF THIS CITY THAT I LOVE. I LIVE IN DISTRICT 9. SAFETY IS, OR SHOULD BE, A GUARANTEE IN ANY CIVIL SOCIETY. IS THIS MEANS PROTECTION OF CIVIL RIGHTS, EVERYONE'S CIVIL RIGHTS. PUBLIC SAFETY RULES ABOUND. SPEED LIMITS FOR VEHICLES, CROSSWALKS, TRAFFIC LIGHTS, TREAT LAMPS, PARKING SPACES DELINEATED, NEW CARS BEING REQUIRED TO HAVE BACK-UP CAMERAS TO PROTECT PEDESTRIANS. NO SIDEWALK SHOULD BE ALLOWED TO BE DANGEROUS. CLEARLY, EVERY ENTRYWAY TO ANY MEDICAL FACILITY SHOULD BE SAFE. CURRENTLY, LOUISVILLE IS ALLOWING THROUGH INACTION DANGER TO EXIST ON THE SIDEWALK IN FRONT OF THE EMW CLINIC THROUGH THE INACTION OF THIS CITY COUNCIL. NATIONALLY AND INTERNATIONALLY, OUR CITY IS KNOWN FOR THIS BREACH OF CIVIL RIGHTS. THERE IS AN INCREDIBLY EMOTIONALLY CHARGED ATMOSPHERE ON THE SIDEWALK IN FRONT OF THE CLINIC. LET ME DESCRIBE TWO VERY DIFFERENT GROUPS. THE FIRST GROUP IS LOUD, SCREAMING IN ANGER, LITERALLY INCHES AWAY FROM THE FACES OF PATIENTS. THEY BLOCK WITH SIGNS THE ENTRANCE TO THE CLINIC, ALBEIT TEMPORARILY, DAMNING THOSE WHO TRY TO ENTER. THEY ARE A TRUE HORDE, SELF-RIGHTEOUS AND FRIGHTENING. THEY ENGENDER ANGER, AS WELL AS FEAR BY THEIR ACTIONS. THE SECOND GROUP CONSISTING OF ONLY ONE OR TWO INDIVIDUALS AT ANY GIVEN MOMENT IS SCARED. WHY ARE THEY SCARED?

THERE ARE TWO REASONS. THE FIRST IS THAT A WOMAN IS ABOUT TO HAVE A MEDICAL PROCEDURE OF GREAT IMPORT. IT'S A MEDICAL PROCEDURE THAT SHE HAS DECIDED IS NECESSARY. AND LET'S FACE IT, WHO IS NOT ANXIOUS ABOUT HAVING A MEDICAL PROCEDURE? THE SECOND ISSUE IS IN ORDER TO GET INTO THE SAFETY OF THE BUILDING, SHE LITERALLY HAS TO WALK THROUGH THIS LINE OF ANGRY PROTESTERS. THERE HAVE BEEN BRUCES, SPRAINED ANKLES, CRACKED RIBS, DISCREET, BUT PURPOSEFULLY AIMED PUNCHES INTO THE SOLAR PLEXUS, AND, YES, A FRACTURED HIP BECAUSE OF THE SITUATION. WE ARE NOT RESPECTING AND PROTECTING THE CIVIL RIGHTS OF THE WOMEN AND MEN WHO NEED TO GET INSIDE, EVEN USING THE PHRASE "GET INSIDE" IS AN INSULT TO CIVIL RIGHTS. PERSONALLY, I WOULD LOVE TO SEE THE PROTESTERS PUSHED BACK 100 FEET, WHERE THEY CAN BE SEEN AND HEARD, BUT ARE LESS THREATENING AND DANGEROUS. GENERALLY, PROTESTERS ARE NOT ALLOWED, BUT HERE WE ONLY ASK FOR TEN FEET. THIS MEANS FIVE FEET ON EITHER SIDE OF THE PATIENT. TO COIN A PHRASE, WHEN PUSH COMES TO SHOVE, WE'RE ONLY ASKING FOR A TINY STRIP OF SAFETY. WE ASK FOR WHAT CIVIL SOCIETY GENERALLY DEMANDS, ENSURING THE RIGHTS OF ALL. VOTING FOR A SAFETY ZONE DOES NOT MEAN THAT YOU PERSONALLY ENDORSE ABORTION. IT MEANS THAT YOU SUPPORT CIVIL RIGHTS. DO THE RIGHT THING, PROTECT THE INDIVIDUAL, AS WELL AS THE FIRST AMENDMENT PROTESTERS. BE A CHAMPION OF CIVIL RIGHTS. PLEASE, STAND IF YOU'RE WEARING AN ORANGE T SHIRT. THANK YOU. [APPLAUSE]

>> PRESIDENT JAMES: THANK YOU. IT'S BEEN MOTIONED BY COUNCILMAN BENSON, SECONDED BY COUNCILMAN TRIPLETT. CONSENT CALENDAR HAS BEEN PROPERLY MOVED AND SECONDED, REQUIRING A ROLL CALL VOTE. WOULD THE CLERK PLEASE OPEN THE VOTING? WITHOUT OBJECTION, THE VOTING IS CLOSING. AND THE VOTING IS CLOSED.

>> CLERK: THERE ARE 22 YES VOTES AND FOUR NOT VOTING.

>> PRESIDENT JAMES: THE CONSENT CALENDAR PASSES. NEXT ITEM OF BUSINESS IS OLD BUSINESS. MR. CLERK, A READING OF ITEM NO.

>> CLERK: AN ORDINANCE AMENDING 72.083, 72.085(A), AND REPEALING 115.350-369 AND REPLACING THEM WITH A REVISED 115.350-362 OF THE LOUISVILLE METRO CODE OF ORDINANCES (LMCO) TO IMPROVE UPON THE REGULATIONS OF ITINERANT VENDORS, PEDDLERS AND SOLICITORS (AS AMENDED). READ IN FULL.

>> PRESIDENT JAMES: THANK YOU. MAY I HAVE A MOTION AND A SECOND? MOTION BY COUNCILMAN BENSON, SECOND BY -- SEXTON SMITH. THE ORDINANCE IS BEFORE US. ANY DISCUSSION? COUNCILMAN BENSON.

>> THANK YOU, MR. PRESIDENT. THIS IS ONE OF THOSE ORDINANCES THAT I DIDN'T THINK WOULD EVER MAKE IT. IT WENT ON FOR ABOUT A YEAR. BUT AS IT TURNS OUT, HAVING A NUMBER OF PEOPLE COMING FORWARD TO REALLY MAKE THIS WORK. I'M REALLY PROUD OF IT. AND SO INSTEAD OF ME TELLING YOU ALL THE GREAT PEOPLE WHO WORKED TO MAKE THIS WORK, I'D LIKE TO LET BARBARA SEXTON SMITH KIND OF EXPLAIN IT.

>> PRESIDENT JAMES: THANK YOU, COUNCILMAN. COUNCILWOMAN SEXTON SMITH.

>> YES, THANK YOU MR. VICE CHAIR AND MR. PRESIDENT. SO AS IT WAS STATED, MANY PEOPLE HAVE WORKED ON THIS FOR A LITTLE MORE THAN ONE YEAR, AND IT WAS DURING THE LAST SEVEN OR EIGHT WEEKS THAT I WANTED TO OFFER A SPECIAL RECOGNITION, APPRECIATION, AND THANKS TO COUNCILMAN WINKLER AND COUNCILMAN HOLLANDER FOR BRINGING TOGETHER A SMALL GROUP OF COUNCIL MEMBERS AND REPRESENTATIVES OF THE LOUISVILLE FOOD TRUCK ASSOCIATION AND TO

HAVE MEETINGS IN THE CONFERENCE ROOM, TO WORK IN A CONSENSUS-BUILDING FORMAT, AND ALL THOSE DISCUSSIONS WENT EXTREMELY WELL. THERE WERE A LOT OF GIVE AND TAKE, A LOT OF IDEAS AND SUGGESTIONS PUT ON THE TABLE FOR CONSIDERATION, AND NOT EVERYBODY GOT EVERYTHING THEY WANT AS WE WENT ALONG. HOWEVER, THERE HAVE BEEN MANY MOMENTS WHEN THERE WAS A LOT OF AGREEMENT AS IT ADDRESSED THE BEING OPEN FOR BUSINESS IN OUR COMMUNITY. WE WANTED TO MAKE SURE THAT THE BUSINESS CLIMATE MAINTAINED VERY POSITIVELY WITH ANY AMENDMENTS WE MIGHT PROPOSE, AS WELL AS THE PUBLIC SAFETY OF ALL OF THOSE IN THE AREA. SO, MR. PRESIDENT, THE FIRST THING I WOULD LIKE TO DO IS OFFER A VERY SIMPLE FLOOR AMENDMENT FOR CONSIDERATION THIS EVENING, AND THEN IF I MAY, FOLLOWING THAT, I WOULD LIKE TO GIVE A VERY BRIEF OVERVIEW OF THE SALIENT POINTS IN THIS AMENDED VERSION. SO THE FLOOR AMENDMENT THAT I WOULD LIKE TO OFFER THIS EVENING IS ON PAGE 16 OF THE AMENDED DOCUMENT, AND SECTION 115.357-D. IT CURRENTLY STATES, "NO VENDOR LOCATED ON PRIVATE PROPERTY SHALL BE OPERATING CLOSER THAN 20 FEET FROM ANY BUILDING OR STRUCTURE ON ADJOINING PROPERTIES UNLESS EXPRESSED WRITTEN APPROVAL HAS BEEN GRANTED FROM THE PROPERTY, THE OWNER OF THE ADJOINING PROPERTY." THE AMENDMENT I'M OFFERING IS I WOULD SIMPLY LIKE TO STRIKE TWO WORDS "OR STRUCTURE." I HAVE SPOKEN WITH COUNTY ATTORNEY'S OFFICE, WHO'S HERE AND COULD SPEAK TO THIS, AS WELL, AND COUNTY ATTORNEY'S OFFICE HAS REVIEWED OUR LAND DEVELOPMENT CODE AND HAS

ASSURED ME THAT THIS KEEPS US IN ACCORDANCE WITH THAT, SO I OFFER THAT AMENDMENT TO STRIKE THE WORDS "OR STRUCTURE."

>> PRESIDENT JAMES: THAT WAS A MOTION. DO I HAVE A SECOND? WE HAVE A SECOND. COUNCILMAN BENSON. ANY DISCUSSION? HEARING NO DISCUSSION, ALL THOSE IN FAVOR OF THE AMENDMENT SAY AYE. ALL OPPOSED? THE AYES HAVE IT. AMENDMENT HAS BEEN PLACED. COUNCILWOMAN SEXTON SMITH.

>> YES, THANK YOU, MR. PRESIDENT. SO GIVEN THE FACT THAT THERE HAS BEEN SO MUCH INTEREST FROM PEOPLE ALL ACROSS THE REGION AND MUCH COMMUNICATION, I THOUGHT IT WOULD BE HELPFUL TO HAVE A BRIEF SUMMARY. SO THE FIRST SALIENT POINT I WANT TO MENTION THAT'S PART OF THIS AMENDED VERSION, IT SAYS IN THE EVENT A PROPERLY PERMITTED HOODED PARKING METER IS BEING AUTHORIZED BY AN UNAUTHORIZED VEHICLE OR OTHERWISE INACCESSIBLE TO THE OTHERWISE PERMITTED BEING A STATIONARY VENDOR COMMONLY SEEN IN OUR COMMUNITY AS A FOOD TRUCK OPERATOR, THAT THIS PERMITTEE MAY THEN PARK AT ANY ALTERNATIVE NON-HOODED METER FOR THE DURATION OF THE PERMIT. SO AS COUNCILMAN BENSON ELUDED TO EARLIER, THIS ALLOWS THE INDIVIDUAL WHO'S TRYING TO CONDUCT BUSINESS APPROPRIATELY WITHIN OUR COMMUNITY AND HAS RESERVED A METER THAT'S OCCUPIED, THEY MAY CONTINUE TO DO SO. SO THE NEXT ITEM THAT WAS UNDER A LOT OF DISCUSSION, THERE WAS MUCH CONFUSION ABOUT THE DEFINITION OF A PEDDLER. WE HAVE DEFINED THAT CLEARLY IN THIS AMENDED VERSION. A PEDDLER IS ANY PERSON

WHO GOES FROM HOUSE TO HOUSE IN LOUISVILLE AND JEFFERSON COUNTY SELLING OR TAKING ORDERS. WE STRUCK THE LANGUAGE "GOING FROM BUSINESS TO BUSINESS." THIRDLY, THERE WAS MUCH DISCUSSION ABOUT THE APPLICANTS FOR LICENSES AND/OR THE EMPLOYEES WHO ARE ACTUALLY ENGAGED IN THE ACT OF VENDING OR PEDDLING, AND AS THEIR FORMER ACTIVITY RELATED TO CRIMINAL CONVICTION. WE HAVE PLACED IN THIS AMENDED VERSION THAT IT STATES "FOR MOBILE VENDORS AND PEDDLERS, A LISTING OF ALL CRIMINAL CONVICTIONS IN THE PAST FIVE YEARS OF THE APPLICANT AND ALL EMPLOYEES ACTUALLY ENGAGED IN THE ACT OF VENDING OR PEDDLING. THAT WAS DONE BECAUSE MANY TIMES THE ACTUAL APPLICANT IS NOT ON LOCATION VENDING, IT WOULD BE EMPLOYEE. NEXT, THERE WAS CONSIDERATION ABOUT DRIVING RECORDS, BECAUSE SOME OF THE VENDING IS TAKEN PLACE IN A MOBILE FORMAT, AND WE HAVE ADDED LANGUAGE THAT STATES AN UNSATISFACTORY 12-MONTH HISTORY OF HAZARDOUS MOVING VIOLATIONS RESULTING IN THE LOSS OF SIX OR MORE CUMULATIVE DRIVER'S LICENSE POINTS. AND THIS STATES THEN THAT THE DIRECTOR OF CODES AND REGULATIONS HAS THE AUTHORITY TO REVOKE A LICENSE IF THAT HAS BEEN COMMITTED. THAT CHANGE FROM SIMPLY A 12-MONTH HISTORY OF TRAFFIC VIOLATIONS, WE PUT SPECIFIC DEFINITIONS AROUND THAT. AND THEN LASTLY, I SIMPLY WANTED TO MENTION ON PAGE 16 WE STRUCK SOME LANGUAGE THAT WE HAD A LOT OF DISCUSSION ABOUT AS A POSSIBLE AMENDMENT AROUND OUR NOISE LEVELS, AND I WAS HOPING THAT MAYBE ANOTHER COUNCIL MEMBER WOULD LIKE TO SPEAK TO THIS, BECAUSE THERE WAS CONSIDERATION IF

WE TRIED TO ADDRESS THE NOISE LEVELS AND REGULATE THEM THROUGH THIS ORDINANCE, THAT WE WOULD POSSIBLY BE SETTING THE METRO COUNCIL UP FOR A POSSIBLE LAWSUIT AND VIOLATION OF A STANDING CONSENT DECREE. WE ABSOLUTELY DID NOT WANT TO DO THAT, AND WE DO HAVE A NOISE ORDINANCE THAT'S ALREADY IN PLACE, AND WE HAVE SOMETHING HERE IN JEFFERSON COUNTY CALLED THE 50-FOOT RULE, AND IF THE NOISE CAN BE HEARD WITHIN 50 FEET OF ITS POINT OF ORIGINATION, THEN IT'S IN VIOLATION OF THE NOISE ORDINANCE. I'M CONFIDENT THAT WE'LL BE ABLE TO ADDRESS THAT ISSUE THROUGH THAT ORDINANCE GOING FORWARD. SO IT IS MY HOPE THAT EVERYONE WILL FIND A WAY TO SUPPORT THIS, AND AS ONE OF THE COSPONSORS, I DEFINITELY CAN SPEAK SIMPLY FOR MYSELF, I WOULD INVITE ANYONE ELSE THAT WOULD LIKE TO JOIN AS A SPONSOR THIS EVENING. MR. PRESIDENT, THAT CONCLUDES MY REPORT.

>> PRESIDENT JAMES: THANK YOU, COUNCILWOMAN. COUNCILMAN WINKLER.

>> THANK YOU, AND THANK YOU TO COUNCILWOMAN SEXTON SMITH FOR GOING THROUGH THE CHANGES AND HER LEADERSHIP AND COUNCILMAN COAN'S LEADERSHIP AND EVERYBODY WHO WORKED ON IT AND SPECIAL THANK YOU TO SHAUN DENNIS FOR HIS WORK AND THE FOOD TRUCK ASSOCIATION. I DO THINK THIS REPRESENTS REALLY GOOD COMPROMISE WITH THE ASSOCIATION. THEY WERE GOOD PARTNERS TO WALK THROUGH THIS. I THINK WE'VE ADEQUATELY ADDRESSED THE CONCERNS, THE CONCERNS THAT WE HAD AND, YOU KNOW, REALLY THINK THIS REPRESENTS

SOMETHING WHERE, YOU KNOW, NOBODY GOT EVERYTHING THAT THEY WANTED, BUT IT IS A GOOD BALANCE BETWEEN THE INTERESTED PARTIES. TO THE POINT ABOUT THE 70-DECIBEL LIMIT ON THE GENERATORS, AS COUNCILMAN SEXTON SMITH ELUDED TO, WE WANTED TO REMOVE THAT BECAUSE OF CONCERNS IT COULD POTENTIALLY VIOLATE THE CONSENT DECREE. WE WILL PURSUE AN ORDINANCE RELATIVE TO UPDATING THE NOISE ORDINANCE AND VERY SHORT ORDER ADDRESS THAT. THERE'S ACTUALLY NO OPPOSITION. I BELIEVE I'M SPEAKING DIRECT LIP FOR THE FOOD TRUCK ASSOCIATION. THEY ARE NOT OPPOSED TO THE 70-DECIBEL LIMIT. IT'S JUST HOW WE DO IT AND THAT IT'S APPLICABLE TO ALL COMMERCIAL VEHICLES AND NOT JUST SINGLING THEM OUT. SO WOULD ENCOURAGE EVERYBODY'S SUPPORT, AND THAT'S IT.

>> THANK YOU, MR. PRESIDENT. THIS WAS AMENDED IN COMMITTEE. THE REQUEST WAS FOR \$72,500. HOWEVER, THAT WOULD HAVE COVERED FOR A FULL YEAR, SINCE THE CONTRACT WAS ONLY FOR SIX MONTHS, IN COMMITTEE WE REDUCED IT TO HALF THAT AMOUNT FOR \$36,250. THAT PASSED AFTER THE AMENDMENT.

>> PRESIDENT JAMES: THANK YOU. ANY FURTHER DISCUSSION? HEARING NONE, THIS IS A RESOLUTION ALLOWING FOR A VOICE VOTE. ALL THOSE IN FAVOR SAY AYE. ALL OPPOSED? THE AYES HAVE IT. THE RESOLUTION IS APPROVED.

>> PRESIDENT JAMES: COUNCILMAN KRAMER.
