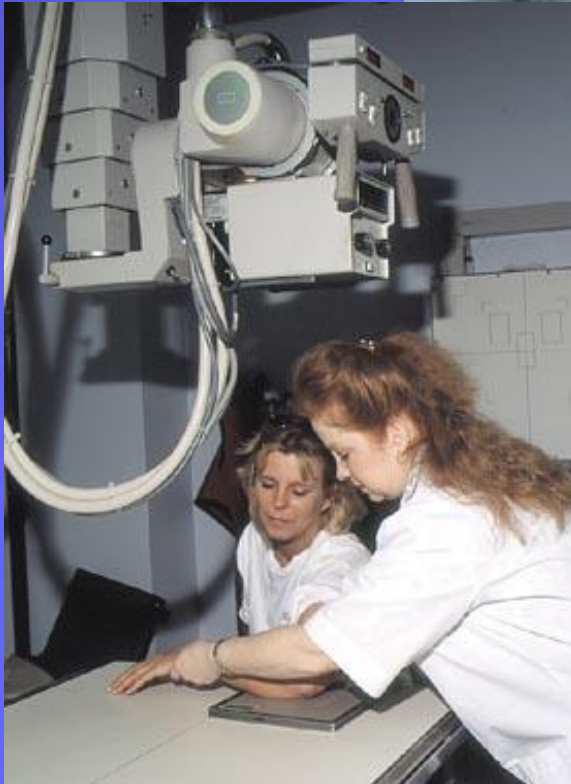

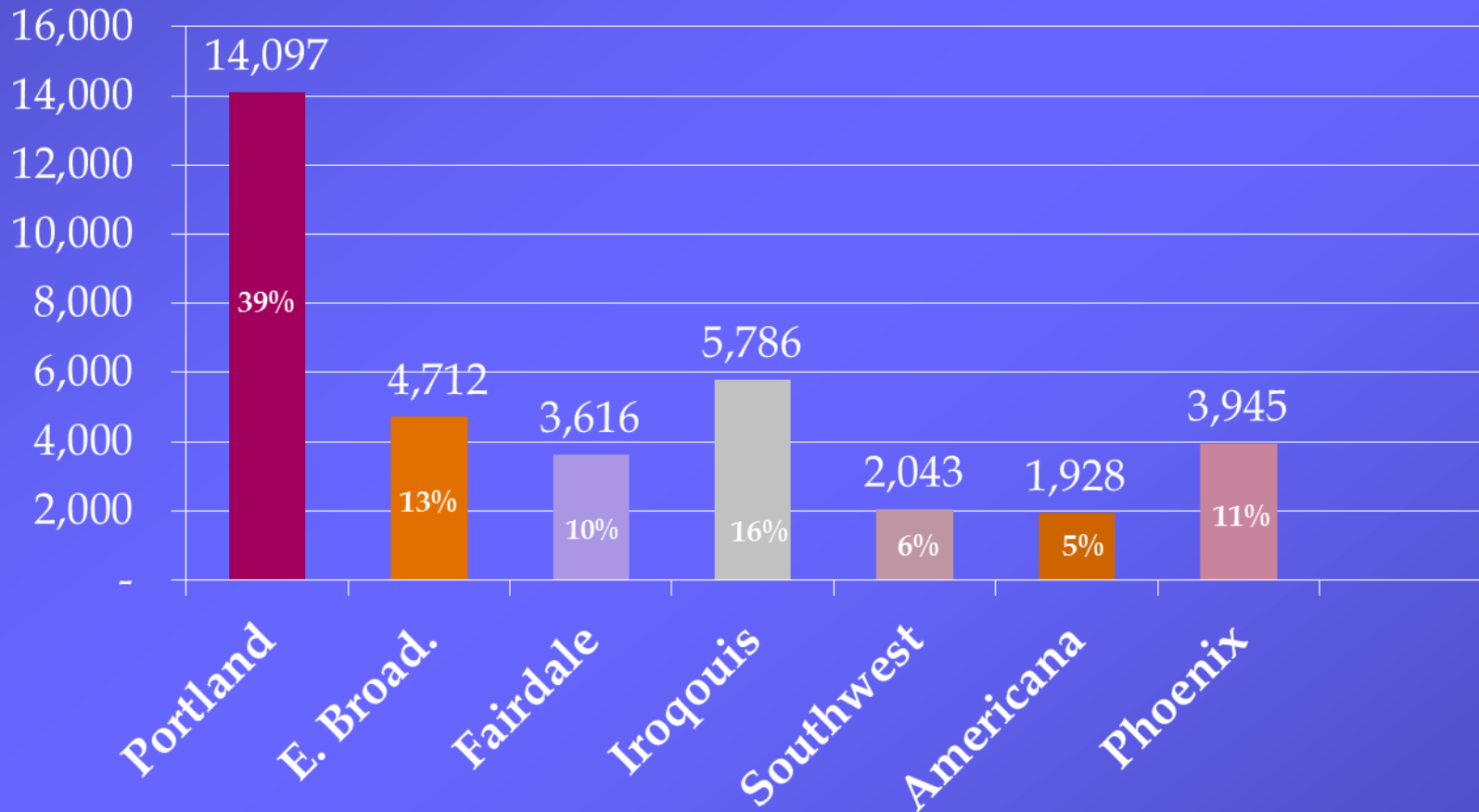

Affordable Care Act (ACA)



- Kynect - Kentucky Health Benefit Exchange
 - Effective January 1, 2014
 - Qualified Health Plans – Incomes up to 400% FPL
 - Open Enrollment 2: November 15, 2014 – April 30, 2015
 - Kentucky Medicaid Expansion
 - Uninsured and below 138% Poverty Level
 - \$16,243 Individual/\$33,465 Family of Four
 - Continuous Enrollment Throughout Year

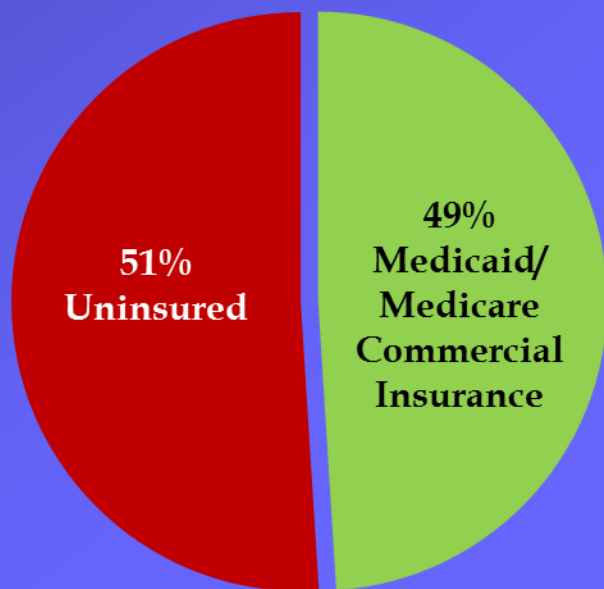

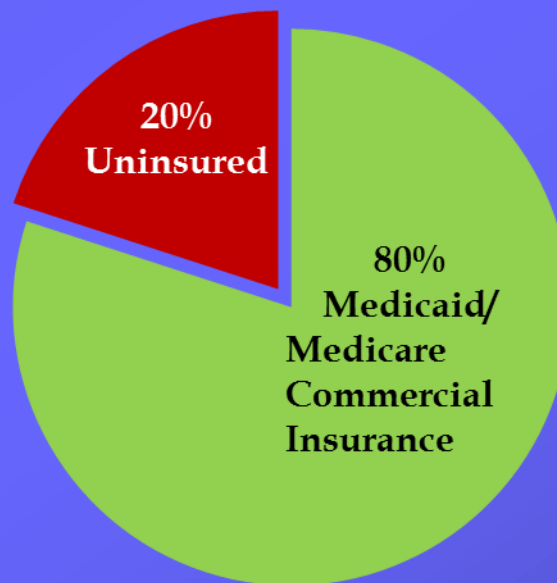
FHC Uninsured Patients

FY 16 FHC Budget Request

- Public Health and Wellness Budget
 - External Agency Contractual Services
 - Direct Appropriation to FHC, Inc.
- Mayor's Recommended Level
 - \$786,900
 - 50% Reduction from Authorized FY 15 Level
 - Metro Appropriation equals 2.3% of FHC revenues

FY 16 Expense Highlights

- Personnel Costs (65.4%)
 - 350+ FTE Employees
 - Louisville Civil Service/non-union
 - CERS Participating Agency
 - 2.5% COLA Proposed for FY 16
 - No COLA in 4 of last 6 years
- Capital Improvements - \$1,000,000
 - Phoenix Health Center Renovation Phase II
 - Funded from FHC Revenues

Serving the Uninsured/Underinsured

- Estimated 15-20% of FHC patients will remain Uninsured in FY16
 - Voluntarily Uninsured - Pay the Penalty
 - Undocumented Immigrants not covered under ACA
 - 90% of Louisville Population growth foreign born (3 years)
- Uninsured and Underinsured likely to continue care at Community Health Centers
 - Sliding Fee Scale Discounts Remain Available

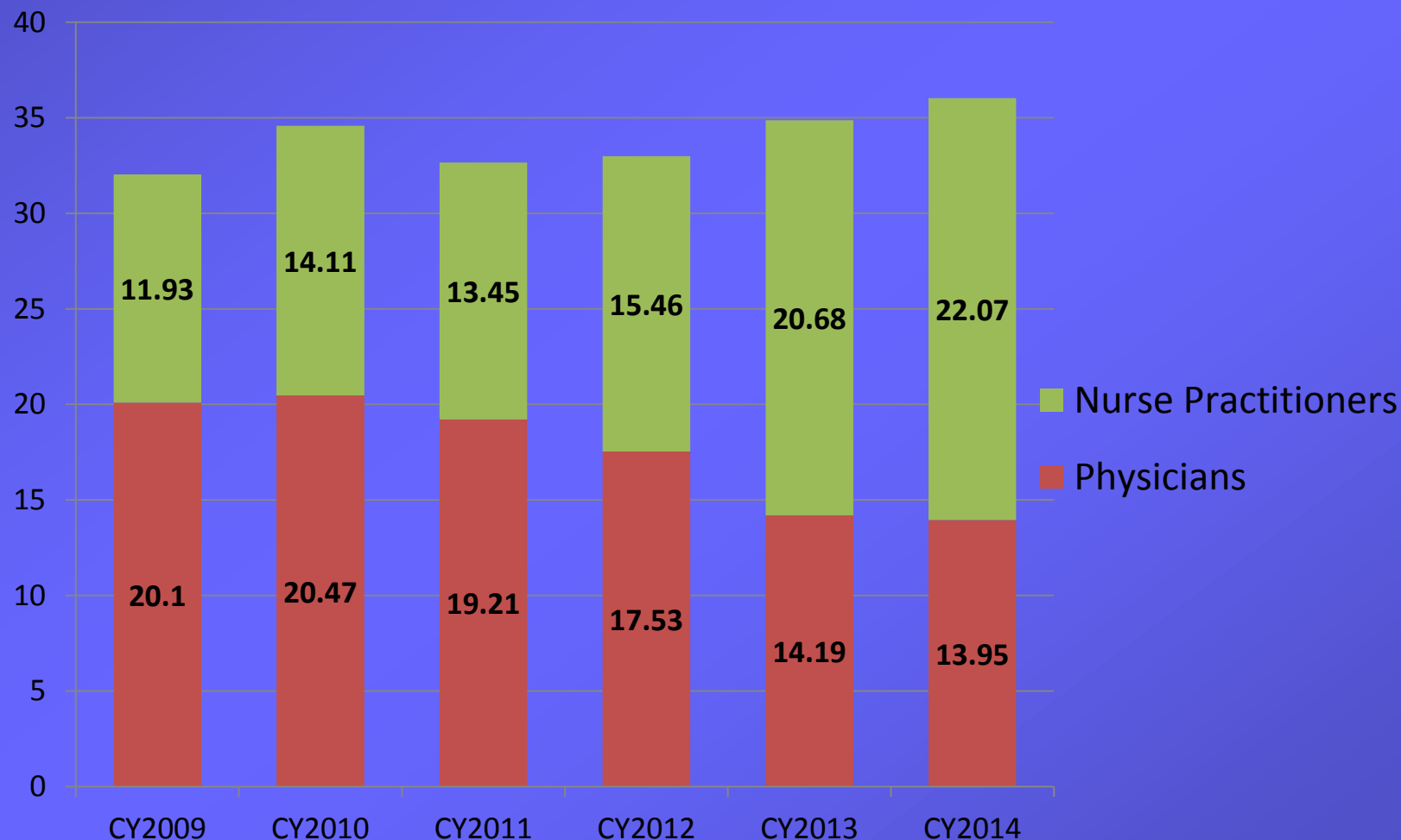
Operational Challenges

- Patient Turnover
- Administrative Complexity/Red Tape
 - Managed Care Contracting
 - Insurance Verification and Payment Delays
 - Changes in Medicaid MCOs – July 1, 2015
- EHR Meaningful Use and Connectivity
- Workforce Shortages

Primary Care Physician Shortage

- Kentucky Health Benefits Exchange Study
 - Shortage of Physicians as a result of ACA
- Louisville and Jefferson County Primary Care and Oral Health Workforce Study - 2011
 - Shortage of Adult Primary Care in Jefferson County
 - 115 more Primary Care Physicians needed by 2020
- Increasing use of Nurse Practitioners
- Patient Centered Medical Home - Team Model

FHC Primary Care Providers (FTEs)



PCP Recruitment and Retention

- Increasing Competition from Hospital/Health Systems
 - Hiring Primary Care Physicians and their Office staff (receptionists, billers, medical assistants)
 - Hospitals willing to absorb losses from acquiring physician Practices
- FHC Salaries Lag behind Market
 - FHC participates in CERS
- Market Salary Surveys Underway
 - FHC Board Action

FY 16 Clinical Priorities

- Increase Health Literacy of Newly Insured
- Reduce ER use for non urgent care
- Continue Emphasis on Prevention
- Improve Management of Chronic Illnesses
- Focus on High Cost/High Utilizers
 - Emergency Rooms, Correctional Facilities
- Expand Behavioral Health Services
 - Case management /Permanent Supportive Housing
