- There was a audit done to see who was currently recycling
- Everyone who is currently recycling will receive a recycle cart
- There are 17 drop-off locations for recycling
- The budget for new recycle carts is \$46.26 per cart
- There is a total of 28,000 new carts
- Question whether there is enough staff to perform all the work needed
