- This legislation is for a Sole Source contract with Tabitha Bandy, who has the flexibility to assist Louisville Metro Police with on-site consulting.
- The consultant will also advise the Louisville Metro Police Department on vital resources for establishing an in-house DNA laboratory rather than seeking services from outside agencies.
- This contract will allow the Louisville Metro Police Department to move cases more expeditiously with evidence testing.
- The consultant will work part-time for Louisville Metro Police Department to establish a DNA laboratory and no longer utilize services through the Kentucky State Police lab.
- There were several questions regarding the turnaround time when receiving laboratory results from the Kentucky State Police lab.
- There was a discussion regarding the testing time frame and return of evidence amassing possibly 24-36 months in total.

- This legislation is for a Sole Source contract for Great Lakes Power Service Company.
- Currently, the malfunction of the Konrad's out drives on the river patrol unit's boat has caused further deterioration of instruments within the housing mechanism.
- The boat is currently in a storage unit where it has been for roughly six months.
- Great Lakes is the only company that manufactures these lower units; the closest local vendor is in Evansville, Indiana.
- This contract will allow two units to be repaired.
- There were several questions regarding whether the boat is covered under a manufacturer warranty.
- There was a discussion regarding maintenance of boats, motors, and equipment going forward.
- There were several questions regarding whether an additional warranty will be executed after repairs are made.
