AN ORDINANCE APPROPRIATING ~~\$7,425~~~~\$9,050~~\$10,050 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$2,000 FROM DISTRICT 9; \$1,200 FROM DISTRICT 8; \$850 FROM DISTRICT 10; \$725 FROM DISTRICT 4; \$575 FROM DISTRICT 7; \$500 EACH FROM DISTRICTS 3 AND 24; \$350 EACH FROM DISTRICTS 2, 5, 6, 12, 13, 14, 15, 17, 25, AND 21; AND \$200 FROM DISTRICT 1; THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO LOUISVILLE INDEPENDENT BUSINESS ALLIANCE, INC. FOR PROGRAMMING EXPENSES ASSOCIATED WITH THE TENTH (10TH) ANNUAL BUY LOCAL FAIR (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of ~~\$7,425~~~~\$9,050~~\$10,050 is hereby appropriated from Neighborhood Development Funds in the following manner: \$2,000 from District 9; \$1,200 from District 8; \$850 from District 10; \$725 from District 4; \$575 from District 7; \$500 each from Districts 3 and 24; \$350 each from Districts 2, 5, 6, 12, 13, 14, 15, 17, 25, and 21; and \$200 from District 1; through the Office of Management and Budget, to Louisville Independent Business Alliance, Inc. for programming expenses associated with the Tenth (10th) Annual Buy Local Fair to be held at the Louisville Water Tower Park.


SECTION II: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

SECTION III: This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.


SECTION IV: This Ordinance shall take effect upon its passage and approval.
