

I have a growing passion for the physical environment of cities. Segments of Louisville's population - low income, young people, senior citizens, persons with disabilities, and refugees/immigrants - are left out of active participation in society when we assume everyone owns a car. We need to re-think our streets so that walkers, bikers, public transit have equal, safe access.

This also means strategically zoning and building neighborhoods to make alternative transportation live-able in reality. A curb-attached sidewalk down Hurstbourne Pkwy will never feel safe, even if it represents progress from an accessibility standpoint. Street trees, street parking, small curb radii, and lower speed limits are vital to pedestrian safety. So are taller buildings set closer to the street in appropriately dense neighborhoods with amenities, housing, shopping, employment, parks, and schools in a strategic walking shed. I want to be part of changing the paradigm and advocating for equity.
