

ORDINANCE NO. 145, SERIES 2021

AN ORDINANCE AMENDING ORDINANCE NO. 088, SERIES 2021 RELATING TO THE FISCAL YEAR 2021-22 CAPITAL BUDGET, FOR THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT BY APPROPRIATING \$4,722,970 TO THE LOUISVILLE ZOO TO FUND A NEW PROJECT TITLED THE ZOO OPERATIONS SURPLUS PROJECTS.

SECTION I: Part I. Revenues and Funding Sources, of Ordinance 088, Series 2021 is hereby amended as follows:



SECTION III: The Council has determined the funds requested in this Ordinance will be expended for a public purpose.


SECTION IV: The Ordinance shall take effect upon its passage and approval.


