He believes there are deed restrictions prohibiting this restaurant. They are in negotiations with the developer; however, the association was okay with a sit-down restaurant but not a fast food, drive thru restaurant. They are concerned with the C-1 zoning allowing any type of restaurant in the area. They have proposed lighting and signage elements they would like to see added to the Binding Elements if the proposal gets approved.
