It was great talking with you at the last Airport Authority event in the old Bowman Field Terminal. That is always an event I look forward to!

I'm contacting you about an issue that you're already aware of, I'm told.

The section of Beaumont Road off of Taylorsville Road, behind our business is in need of a curb. Customers of the very popular Oishii Sushi park along this section of road regularly. As a result, about 8 inches of roadbed has been lost; chewed off into the carparking created "ditch" in front of the residence at 2907 Beaumont. Additionally, the mud sloshed onto the road reduces traction significantly; I've witnessed many close calls by vehicles sliding on this mud in wet weather and narrowly missing one another.

I know it is not an inexpensive fix, but curbing this area now will be far cheaper than restoring the roadbed later, especially after another winter.

I've enclosed two images to illustrate what I've described above.
