The following was discussed:

- Clarification that the Purchased Transportation, 18 percent of the Operating Budget, is the TARC3 contract
- Escalating cost of TARC3 service
- Request for breakdown of union personnel and management personnel, including how many new positions were created in the last five years for both categories
- Concerns about expenses being more than revenue and how that may affect TARC3 services
- TARC actively hiring drivers, with up to 100 needed right away, and whether the budget for TARC3 reflects the additional drivers
- Request for last year's spending for TARC3
- Randy Frantz, Assistant Executive Director, still being employed by TARC
- TARC's income statement and balance sheet, and whether there is an operating loss
- TARC funding not part of the Louisville Metro Government Budget, but is funded by taxpayers' occupational taxes through a mechanism set up in the 1970s
- Amount of state funding provided to TARC from Indiana and Kentucky
- TARC being designated recipient of \$650,000 grant and they allocate funds to

local non-profits to assist with transportation for elderly or persons with disabilities

- TARC pay for coach operators is \$17+/hour to \$25/hour, and includes paid training, health benefits, retirement plan, and paid time off - candidates must be at least 21 years old
- Concerns about tardiness for pick ups when people are waiting for rides home from appointments
- Whether all money is utilized by the end of the fiscal year, and leftover revenue going into the Mass Transit Trust Fund, which maintains a \$14M balance at the end of each year to cover a few months of expenses in case they have no income
- Whether any bonuses were negotiated for essential pay for drivers, and whether drivers laid off during COVID-19 have been brought back to work
- How often employees are vetted during employment, and whether they are vetted for anything other than just their driving records
- Paratransit and Customer Service line item in budget, specifically a line item titled Services for \$13,000, and the reduction from the previous year
- Line item for enhancement of call center and what customers can expect from the enhancement

A motion was made by Committee Member Engel, seconded by Committee Member Winkler, that this Ordinance be recommended for approval.

Chair Hollander explained that the American Rescue Plan ("ARP") funds total \$388M and are split into three types of projects: Response to COVID Health Needs; Stability; and Economic Recovery.

Keith Talley, Strategic Operations, spoke about the guiding principles used when determining how the funds should be used.

Margaret Handmaker, Louisville Accelerator Team, stated that the focus was on short-term emergency needs and then the team would clearly define challenges and priority areas going forward.

Projects 1 through 4 regarding Response to COVID Health Needs totaling \$13.1M were discussed.

The following was discussed:

- Concerns regarding process used for determining how the funds would be

spent

- Contact tracing by Lacuna Health for \$3.2M and whether that amount is needed for the next 100 days
- Funding not only for the first 100 days, but more to get things started for the next five months
- Why the services listed under the \$2.9M for Community Support overlap other areas in the proposed spending and why there is an emergency for these services at this time
- Funds for COVID management needing to be used proportionately in regards to the number of cases
- Another line item for Lacuna Health regarding their call center staffing for \$1.7M, bringing the total funding to Lacuna Health to about \$5M
- Unused funding being available for deployment for other programs
- Concerns regarding the Southwest Government Center being closed and whether funding will be used for reopening
- Projects being funded may not be based in the Southwest Government Center but will serve the area, and will include programs concerning harm reduction, treatment navigation needs, access to recovery housing, and residential services
- Why pop-up site is being utilized in parking lot when there is a building available
- ARP funds have to be obligated by December 31, 2024
- Whether there are more funding streams available other than the \$388M (referenced press release attached hereto)
- Budget for Suicide Fatality Review Board and what the money will be spent on, and requested a copy of the Washington County model discussed
- How outreach for treatment services for substance disorders are to be implemented, and whether it would be the same for Medicaid navigation
- Recovery housing and whether some funds will go to incentivize landlords who provide housing
- Funding for child care financial assistance and the amount being provided to Metro United Way
- Whether Public Health and Wellness was aware that the Center for Disease Control was going to allocate an additional \$4.5M before the ARP funds were proposed for distribution, and whether there are other grants for which they have applied
- Number of people that need to be vaccinated before support services are cut, and whether cutting funding for contract tracing and adding more for vaccinating would help reach that level quicker
- Current funding is to address immediate needs until additional funding is received
- Follow up question later by Vice Chair Kramer regarding the financial assistance for community learning hubs and how much Jefferson County Public Schools should be reimbursing to Evolve502

- Explanation regarding why this funding is needed for eviction prevention
- Moratorium has been lifted for evictions
- Funds currently available for eviction prevention diversion and additional funds coming
- Clause that landlords cannot evict tenants who receive assistance during the time period for which rent is paid
- Unemployment concerns and information about wrap-around services
- Concern about rehousing of 500 families through anticipation of more vacancies due to evictions, and why there is a dependence on evictions to provide housing rather than building more affordable housing (referenced Rules are attached hereto)
- Initially estimated need for eviction prevention as \$75M, and how this additional \$10M puts the total significantly over \$75M
- Getting attestation of income on those receiving assistance
- How rental assistance paid in advanced will be reimbursed if tenant moves out
