RENEWABLE ENERGY ALLIANCE OF
LOUISVILLE. FOR 10,000 YEARS,
FROM THE END OF THE ICE AGE IN
1880, THE EARTH'S ATMOSPHERE
REMAINS STEAD AT 222 PARTS PER
MILLION DIOXIDE. TODAY IT'S 50%
MORE. EVERY CUBIC INCH OF THE
EARTH'S ATMOSPHERE HOLDS 55%
MORE CARBON DIOXIDE. THE LAST
TIME IT WAS THIS CONCENTRATED IN
THE EARTH'S ATMOSPHERE.
SCIENTISTS ARE WORRIED ABOUT 1
AND-A-HALF AND TWO DEGREES
HOTTER. LAST YEAR, WE DUMPED AN
ADDITIONAL 40 BILLION TONS OF
CARBON DIOXIDE INTO THE EARTHEST
ATMOSPHERE AND THIS YEAR WE'LL
DUMP ANOTHER 41 TONS. THE
CARBON LEVELS ARE INCREASES AND
THE RATE OF INCREASE IS
INCREASING. THERE'S A WORLD
WIDE EFFORT TO SAVE THE EARTH
FROM THIS CLIMATE. THE PEOPLE
OF LOUISVILLE ARE A SMALL
PERCENTAGE OF THE EARTH'S

POPULATION AND WE CAN NOT TAKE THIS PROBLEM ON OUR OWN, BUT WE CAN TAKE ON OUR PART OF THIS PROBLEM RIGHT HERE AND NOW. IN FEBRUARY, OF 2020 WE DID TAKE ON OUR PART OF THIS PROBLEM, WHEN THIS BODY PASSED A RESOLUTION FOR 100% RENEWABLE ENERGY COMMUNITY WIDE BY 2040, AND FOR CITY OPERATIONS BY 2030, WE'RE NOW A QUARTER OF THE WAY TO 2030. WE AT HAVE ALWAYS SAID THAT WE WOULD LOVE TO MAKE THE TRANSITION TO RENEWABLE ENERGY IN PARTNERSHIP WITH LG & E. BUT WE ALSO SAID IF THEY WON'T DO IT, WE WILL FIND SOMEONE WHO'LL THERE ARE SOME FORWARD-LOOKING PEOPLE IN THE OFFICE OF ADVANCED PLANNING AND SUSTAINABILITY WHO ARE SERIOUSLY LOOKING INTO THE POSSIBILITY OF WHAT'S CALLED PARTIAL MUNICIPALIZATION. THAT IS THE IDEA OF THE CITY ITSELF OWNING THE MEANS AND TRANSMITTING, DISTRIBUTING, AND I HOPE, GENERATING RENEWABLE ENERGY FOR CITY-OWNED BUILDINGS THAT'S THE PART OF THE RENEWABLE ENERGY, THE PART OF THE ENERGY THAT THIS BODY IS RESPONSIBLE FOR. THIS IS AN ISSUE METRO COUNCIL WILL HAVE TO FACE. OUR ORGANIZATION REELS IS PRESENTING A JUNE. WITH A DIRECTOR OF THE OFFICE OF ADVANCED PLANNING AND OUTSIDE EXPERT. YOU ARE ALL INVITED, BUT YOU MUST REGISTER, I'LL LEAVE FLYERS HERE WITH FURTHER INFORMATION. AND I GAVE THOSE FLYERS TO SOMEONE TO MAKE COPIES AND SHE SAID SHE WAS DISTRIBUTE THEM. I'M NOT SURE THAT MUNICIPALIZATION IS THE ANSWER, BUT I'M SURE THAT EXPLORING THIS POSSIBILITY IS

TO BECOME A NO-KILL COMMUNITY.
LOUISVILLE HAS HUNDREDS OF
UNOFFICIAL, UNRECOGNIZED AND
OFTENVILLEFIED VOLUNTEERS WHO
SUPPORT THEM IN THE COMMUNITY.
IT'S OFTEN SAID IF YOU WANT A.
THIS PERPETUATES THE IDEA OF
ANIMAL SERVICES BEGINS AND ENDS
INSIDE THE SHELTER WALLS WHILE
DEVALUING THESE VITAL SUPPORT
SERVICES. IN 2021, 72% OF THE
STRAY DOGS ARRIVING AT THE
SHELTER CAME IN VIA THE PUBLIC.
AGAIN, MORE DETAILS IN YOUR
PACKET. WE'RE NOT THE ENEMY,
IT'S TIME TO BRING THE TWO SIDES
TOGETHER IN A POSITIVE,
COLLABORATIVE EFFORT OF INPUT
AND ACTION TO IMPROVE THE LIVES
OF PETS IN LOUISVILLE. A GOOD
START IS REMOVING BARRIERS TO
ACCESSING SERVICES. THIS STARTS
WITH COMMUNICATION ABOUT
AVAILABILITY, THEIR PHONES HAVE

SAID THEY'RE CLOSED ON SATURDAYS
FOR AT LEAST TWO YEARS NOW, WHEN
THEIR OPEN. THERE'S NO
PUBLISHED INFORMATION ON
ADJUSTMENTS LIKE HOLIDAY HOURS.
AND IT LEADS TO INTAKE HOURS
THAT WE NEED MORE THAN 22% OF
THE HOURS IN THE WEEK. AGAIN,
ALL THE DETAILS ARE IN THE
PACKET. BUT WE NEED CHANGES TO
SUPPORT THE COMMUNITY.
PROVIDING SUPPORT TO THE
COMMUNITY LEADS TO ANOTHER
ISSUE, HOW TO SOLVE OUR STRAY
DOG PROBLEM. UNFORTUNATELY,
LMAS' LIMITED RESOURCES ARE
DEPLETED BY A CATCH 22 OF NOT
ADDRESSING THE UNDERLYING
PROBLEMS LEAVING NO STAFF TO
ESTABLISH PROBLEMS TO STOP
STRAYS FROM BEING CREATED IN THE
FIRST PLACE. WE NEED THE
RESOURCE TOSS WORK ON THE
SOLUTIONS OF THIS PROBLEM. WE
HAVE TO WORK ON A POSITIVE SIDE
TO SUPPORT PET OWNERS THROUGH
EDUCATION, MEETING SPECIFIC
NEEDS, AND ULTIMATELY, IF
NEEDED, AN OWNER SURRENDER
PROGRAM THAT KEEPS THE DOGS FROM
BECOMING UNCLAIMED STRAYS. I
LOOK TO THE METRO COUNCIL TO
CREATE THE ANIMAL SHELTER TO
LOYAL METRO ANIMAL SERVICES,
BECOMING TRULITA NO-KILL
COMMUNITY. THANK YOU FOR

ON FIFTEENTH. IT 2 ACRES,

CONTINUED UNTIL MAY THE 12, THE
ISSUE OF NOT HAVING TWO DE
DISTINCT INGRESS AND EGRESS WAS
NOT DISCUSSED. AT THIS TIME I
WOULD LIKE FOR YOU TO RECOGNIZE
COUNSELMAN MARKUS THIS WAS IN
HIS DISTRICT.

>> MADAM CHAIR HIGHLIGHTED THE
ISSUES SUCCINCTLY, I MADE
DETAILS COMMENTS IN THE
COMMITTEE MEETING. THIS
PROPERTY IS ESSENTIALLY A
TRIANGLE AND WHEN YOU GET DOWN
TO THE ROAD FRONTAGE IT'S NOT
WIDE ENOUGH TO HAVE TWO DISTINCT
POINTS OF ACCESS. THE CHAIR
WOMAN INDICATED BY THE TIME THEY
GOT TO THE DELIBERATION THAT
DISCUSSION WAS FORGOTTEN AND
THEY DIDN'T GET TO TALK ABOUT
IT. ADDITIONALLY, SO, WHAT THE
APPLICANT HAS ASKED FOR A WAIVER
TO MOVE THE SECOND ACCESS
EASEMENTS THROUGH A NEIGHBORING
PROPERTY. THE PROBLEM IS THE
NEIGHBORING PROPERTY WAS BEFORE
US, AND WE PUT BINDING ELEMENTS

AT THAT TIME ON THE PROPERTY
THAT SAID ANY CHANGE OF THAT
PROPERTY WOULD REQUIRE A PUBLIC
HEARING, GO TO THE PLANNING
COMMISSION, AND COME BACK TO
COUNCIL. NONE OF THOSE THINGS
HAPPENED. SO, A VOTE TO ALLOW
THIS TO MOVE FORWARD AND
BASICALLY SAY OUR OWN RULES
DON'T APPLY. I WOULD ENCOURAGE
EVERYBODY TO SUPPORT WHAT WAS
PASSED UNANIMOUSLY BY THE
COMMITTEE. THE PROCESS CLEARLY
LAID OUT WAS NOT FOLLOWED WITH
THIS REQUEST. AND SO, I
ENCOURAGE EVERYONE'S SUPPORT OF
THE AMENDMENT IN FRONT OF YOU
WHICH IS THE AMENDMENT BY

AND IT WILL CHANGE ON PAGE TWO,
THE REFERENCES TO NEIGHBORHOOD

>> A MOTION AND SECOND IS BEFORE US. IS THERE DISCUSSION COUNCIL MEMBER FLOOD?

>> THIS IS A REVISED PLAN FOR A MINI WAREHOUSE FACILITY ON 2.19 ACRES, THE SITE WAS PREVIOUSLY REZONED UNDER CASE 17 ZONE 222, THE PLANNING COMMISSION APPROVED THE DEVELOPMENT PLAN UNDER DOCKET 18 PLAN 1123, HOWEVER THERE WAS A BINDING ELEMENT ON

THE ORIGINAL CASE THAT REQUIRED ANY CHANGE TO THE PLAN TO BE REVIEWED BY LOUISVILLE CITY COUNCIL AND THAT WAS MISSED BY STAFF AND THAT'S WHY IT'S IN FRONT OF US AT THIS TIME, AND THIS IS IN COUNCIL MEMBER FOWLER'S DISTRICT. SHE MAY WANT TO ADDRESS US.

>> PRESIDENT JAMES: COUNCIL MEMBER FOWLER?

>> THANK YOU, MR. PRESIDENT.

THIS, AS COUNCIL MEMBER FLOOD SAID, A REVISED PLAN FROM THE 2017 DEVELOPMENT PLAN AND REQUIRED THIS TO COME BACK TO THE PLANNING COMMISSION AND THE METRO COUNCIL, IT TOOK FOUR YEARS FOR THIS TO HAPPEN. I'M QUESTIONING ALL ALONG WHY THE BUILDINGS WERE GOING UP AND NOT ACCORDING TO PLAN AND THEY FINALLY HAD TO TELL ME THAT THEY HAD MADE A MISTAKE. AND YOU KNOW, I JUST WONDER IF OTHER COUNCIL MEMBERS HAVE THESE ISSUES OR IF IT'S JUST ME? I GOT A PROJECT TO BUILD A HOME WITH A CONNECTING SIDEWALK FROM THE ROAD TO DIXIE HIGHWAY WAS LEFT OFF OF THE DEVELOPMENT PLAN AND NOW WE'RE TRYING TO FIGURE OUT HOW TO GET THAT NEEDED SIDEWALK TO COMPLETE STREETS TO DIXIE HIGHWAY, ALL BECAUSE, SOMEBODY MISSED -- I DON'T KNOW, IT'S FRUSTRATING, FOLKS, I DON'T KNOW, I WOULD LIKE TO KNOW IF OTHER PEOPLE HAVE THESE ISSUES OR IS IT JUST MY LUCKY STARS? ANYWAY, I GUESS, I REQUEST YOUR APPROVAL. THANK YOU.

>> PRESIDENT JAMES: THANK YOU, COUNCILWOMAN, ANY FURTHER DISCUSSION?

>> COUNCILMAN PEDEN.

>> I WOULD LIKE TO REMIND EVERYBODY THAT WE PASSED A LAW BECAUSE OF THIS MISTAKES, WE PASSED AN ORDINANCE THAT SAID BEFORE APPROVAL OF ANY FINAL PLAN, THEY'RE SUPPOSED TO GET IT BACK TO YOU, TO LOOK AT IT, SOME OTHER EYES, WHAT PROMPTED THAT, THE ENTRANCE TO THE GROCERY STORE, THE ACCESS ROAD WHICH RUNS RIGHT NEXT TO MERCY HIGH SCHOOL WHERE WE PRACTICALLY LET THEM ADD A LANE, WHICH THEY WERE NOT SUPPOSED TO DO, WE APPROVED THAT IN THIS ROOM AND YET WHEN WE SUBMITTED A DEVELOPMENT PLAN WE BLINDLY STAMPED AT AS PUBLIC WORKS. IT IS LAW THAT THEY'RE SUPPOSED TO COME TO YOU, OR IN THIS CASE, COUNCIL MEMBER FOWLER AND SAY "HERE, HERE'S ONE LAST LOOK AT THIS, EVERY SIDEWALK AND ENTRYWAY AND ALL THAT". AND GUESS WHAT, THEY'RE NOT DOING IT AND THEY WILL OPENLY ADMIT NOT DOING IT, BECAUSE IN THEIR WORDS, THEY CAN'T FIGURE OUT HOW TO DO IT, AND THEY'RE IGNORING IT AND IT'S A LAW AND THEY'RE FLAT OUT NOT DOING IT AT PLANNING AND ZONING OR PUBLIC WORKS, I'M JUST SAYING, HE'S YET ANOTHER ONE IN FRONT OF US. I'M FINISHED, THANK YOU.

>> THANK YOU, PRESIDENT JAMES, I'M SORRY TO INTERRUPT LIKE THAT. BUT, THE DEVELOPMENT PLANS AND THE PLANNED CERTAINS

ARE NOT BEING FOLLOWED UP ON. I MEAN, THERE ARE STACKS, AND STACKS, AND STACKS OF THEM JUST NOT BEING DONE. EVEN THOUGH WE VOTED AND PUT IN MONEY FOR NEW EMPLOYEES, AND, PLANNING AND THE DESIGN SERVICES, NEW ZONING INSPECTORS. I MEAN, I HAVE STILL GOT A ROAD IN BON LAKES SUBDIVISION WHICH IS GRAVEL NOW BECAUSE IT'S DEGRADED TO BADLY BECAUSE THE FINAL TOP COAT OF AS ASPHALT ON THE ROADS. THE DEVELOPMENT COMPANIES ARE HAVING STAMPS ON DEVELOPMENT PLANS THAT THEY NEVER FINISH UP THINGS THEY FAILED TO DO 20 WELL, 18 YEARS AGO.
